Megan Becker – MFT – Approved for licensure.

Chapman, Joanne – approved for licensure.

Daltry, Melissa – The SNHU course 675 Co-Occurring Issues for Children and Families does meet the requirement for course 4 of group 2, Addictive Disorders.

Ghalamzan, Momtaz – Category A has been met with the expected completion of GPS 505 per Boards letter in 2003 to applicant. In regard to category B, course 504 “Clinical Assessment by Graphic Means” would not meet the requirements. However, the Board has contacted her school to inquire of course AT 527 Psychopathology for 3 credits to see if this will satisfy this requirement. The information provided by the school does not indicate that this course would fulfill this category. If the applicant can provide additional information showing this course included DSM, the Board will review it further. Unfortunately applicant withdrew from GPS 504 Advanced Abnormal which would have been acceptable. The Board has accepted GPS 500 Professional Ethics and this requirement has

been met. The applicant must take note of the Vermont Rules. No applicant for licensure may practice in Vermont without being on the Roster. The applicant's rostered status has expired. The Board tried to reach the applicant by phone to report the above but was unable to reach her.

Herrington, Margaret – Approved for licensure.

Lowenthal, Eleanor – MFT – approved for licensure.

Mason, Sara – Approved for licensure.

Montminy, Linda – Internship/field experience requirement has been met. Group I course for Human Growth and Development has been met. The Board is unable to locate a measurement course and there is still no course description for Notre Dame course CPY 66300 "Clinical Assessment". Otherwise the 3 credit course for measurement can be supplemented. She will need to supplement 2.5 credits in Group 3 courses for Career Development and Lifestyle Appraisal. The NCE still need to be successfully completed.

Schug, Casey:

- 1) School check needed to see if program was accredited under "center for Humanistic Studies".
- 2) No documentation for 310 hours needed to supplement internship program to reach 1000 hours.
- 3) DSM credits verified.
- 4) Group 1 courses: needs another 3 credit course.
