Analysis of Bill

This bill proposed to change the name of the Vermont Criminal Information Center to the Vermont Crime Information Center

Resolving this inconsistency will provide both uniformity and clearer indication of what function the Center serves (i.e. information on multiple aspects of Crime is retained instead of information relating only to individual Criminals).
