Hi Cary,

I'd like to make some revisions to Sec. 12 of the senate version to reflect the administration's latest thinking regarding increasing the Agency's role in rulemaking and oversight. I have the chart from earlier; however, what would be most helpful is if someone in the agency could review subchapter 1-3 of chapter 87 in Sec. 12 of the bill and suggest substantive changes to the policy set forth. My goal is to reflect the policy with small language tweaks rather than rewriting the section, so that if the Senate

wants to amend S.241 if it passes the House or wants to add S.241 to another bill, I can have essentially the same bill that passed the senate with a few technical changes that give the Agency what it needs to work collaboratively with DPS on the program. Let me know if you want to discuss further. I am happy to sit down with someone and go through it with them.
