Hi Sue! Glad things are going well and you're enjoying it. Seems like such a perfect gig for you. I'll get some details on the VYCC project, but my understanding was that VTrans was a potential obstacle in the past. Here is a summary of what I've gotten from them:

VTrans has a scenic easement on 40 acres of property, which is in view of I-89. VYCC wants to install 210,000kw of (solar) trackers on 1.5 acres as part of their education/land mission and has negotiated a swap of land with Vermont Land Trust and Richmond Land Trust to do this. The swap would allow the trackers to be on conserved land, but much better hidden from the road. The alternative is to put trackers on non-conserved land, however, that land and the trackers would be very visible and block the scenic value.

That's the sum of it. But if they haven't come to you, they no doubt will.

Morgan and I are living in Burlington. We just bought a house and boy oh boy is it a handful. Lots and lots of painting and projects, but fun to see the place slowly made our own. And by slowly, one room is done and that's it.

The Vermont Agency of Transportation today announced the hiring of a new Director of Policy, Planning and Intermodal Development.

Chris Cole of South Burlington, the General Manager for the Chittenden County Transportation Authority (CCTA), will direct a newly-formed division within the Agency that addresses all modes

of transportation -- integrating the needs of automobiles, trucks, passenger and freight railroads, and public transit. Cole, who has lead CCTA since 2001, and the Green Mountain Transit Agency since 2003, has been instrumental in growing Vermont's largest public transit agency into a dynamic organization that serves a five county region in Northwestern and central Vermont. Under his leadership, CCTA has been hailed for increasing ridership by 63% since 2001, creating Vermont's first inter-regional commuter buses connecting Burlington with Middlebury, Montpelier and St. Albans, and reducing the number of small transit agencies throughout the region into a single unified agency.


The purpose of this letter is to follow-up on initial comments made in our November 17, 2010 email by Larry Dwyer. The VYCC is proposing to install solar collection infrastructure on their property in Richmond Flats and have been working with the Richmond Land Trust to locate the solar panels in a way that would minimize visual impacts from I-89 and US Route 2. The latest proposal would include placement of solar panels on property conserved as part of a 1996 VTrans Transportation Enhancement (TE) Project. Similar to VTrans' own analysis, Mr. Dwyer noted that the solar array would be inconsistent with the purpose and need of the 1996 project to provide a scenic easement as part of the Monitor Barn preservation and appears to consist of development that would specifically be prohibited by the restrictions placed on the land.

In addition to the above issue with the scenic easement, in our review of the categorical exclusion and supporting documentation for the TE project, we noted that the purchase of the scenic easement was also made a stipulation of the Section 106 Memorandum of Agreement for the Barn Restoration portion of the project, in order to mitigate the potential Adverse Effect of the barn relocation. As a result of this commitment under the National Historic Preservation Act (36 CFR 800) and National Environmental Policy Act (23 CFR 771), development of a solar farm on the property conserved under this FHWA TE project would not be permissible even under a scenario that included replacement conservation land and/or payback of Federal-aid funds.
