1. General Business

- a. The Board called the meeting to order at 9:02 a.m.
- b. Mr. Irwin moved, seconded by Ms. Smith, to approve the minutes of the December 17, 2020 meeting as written. Approved.

2. Hearings

2020-24 – Seth Gogo – A Stipulation and Consent Order was heard. Mr. Irwin moved to accept the Stipulation and Consent Order as presented. Approved.
