Dear Dave:

I have enclosed the records from the Governor's office that are responsive to your request. Some of the text messages are a bit choppy, and I have manually noted the identity of the person with whom the Governor was texting, as that information doesn't otherwise appear in the hard copies of the texts.

I have withheld one record as exempt in its entirety pursuant to 1 VSA 317(c)(4) (executive privilege. It is an email from Alex MacLean to Governor Shumlin dated 8/29 3:40 p.m., copied to Bill Lofy, Jeb Spaulding, and Susan Allen, and reply from Governor Shumlin. The email contains a press briefing from senior staff to the Governor.

In addition, you will see that I redacted various items throughout the disclosure. Ordinarily, we do not publicly disclose communications between senior staff and the Governor, pursuant to the executive privilege. In this case, we have elected to disclose those communications that reflect transmission of purely factual information (as opposed to advice, opinions, deliberations, planning, decisionmaking, etc.) I have, however, redacted items reflecting advice, opinions, deliberations, planning or decisionmaking communications between senior staff and the Governor in the following records:

- Texts with Sue Allen – discussion of advice or opinions or process regarding planning decisions redacted
- Archived emails with Sue Allen – discussion of advice or opinions or process regarding planning decisions redacted
- Emails among Governor Shumlin, Jeb Spaulding, Shana Trombley, Alex MacLean, Bill Lofy, Brian Searles and Beth Robinson—discussion among senior staff of planning relating to helicopter trip to damaged areas immediately following storm (these communications also contained communications exempt from disclosure insofar as they relate to the Governor's security arrangements – see below)
- Email from Bill Lofy to Governor Shumlin, cc to Alex MacLean and Susan Allen – discussion reflecting advice, opinions, deliberations, planning or decisionmaking communications between senior staff and/or agency secretaries and the Governor reacted

Finally, pursuant to 1 VSA 317(c)(25), we do not disclose information reflecting the Governor's security arrangements. Accordingly, I have redacted the following information:

- Texts with Sue Allen – name of assigned security
- Emails among Governor Shumlin, Jeb Spaulding, Shana Trombley, Alex MacLean, Bill Lofy, Brian Searles and Beth Robinson—discussion among senior staff of planning relating to helicopter trip to damaged areas immediately following storm – discussion of security arrangements interwoven in conversation

- August 30 preliminary schedule—names of assigned security

In addition, I have redacted phone numbers.

You have the right to appeal.
