Analysis of Bill

§ 354. ENFORCEMENT; POSSESSION OF ABUSED ANIMAL; SEARCHES AND SEIZURES; FORFEITURE (a) The Secretary of Agriculture, Food and Markets shall be consulted prior to any enforcement action brought pursuant to this chapter which involves livestock and poultry. Law enforcement may consult with the Secretary in person or by electronic means, and the Secretary shall assist law enforcement in determining whether the practice, or animal condition, or both represent acceptable livestock or poultry husbandry practices.

2. Is there a need for this bill? Please explain why or why not.

The Agency of Agriculture took part in stakeholder meetings this summer and provided input. Improved clarity of the involvement of the Agency of Agriculture in Animal wellbeing cases is needed.

This will require time for our State Veterinarian to take part – salary and possibly travel – limited impact.


The agency is neutral – can live with our without this bill.
