

## SELECTMEN'S REPORT FOR THE YEAR 2003



The following are the many accomplishments that have occurred during 2003:

We made some changes and renovations in the Town Clerks Office. We put new carpet in the meeting room.

We paved Depot Street in West Burke Village and repaved Sugarhouse Road from Burke Hollow up towards Newark Street. We also paved a portion of the schoolyard.

We received a grant for an engineering study on the bridge in West Burke by the fire station. That bridge will need either a lot of repair or replacement soon.

We put up gates that can be locked at Hillside Cemetery and the town garage yard. We have had vehicles up in the cemetery after dark that have caused some damage. We have had gravestones tipped over, the grass has been torn up by vehicles spinning around. The flag has been taken off the pole and thrown on the ground. A bonfire was set on a plastic tarp and killed some of the grass. In the town garage yard we have had quite a few different pieces of old furniture, garbage, tires and other things left when no one is there. A vehicle was spinning circles in the garage yard and broke a window on the garbage truck. It's too bad we have to put up and lock gates but it seems that is how it is. We will try to keep the cemetery open all daylight hours. We plan on leaving the gate at the town garage open in bad weather for the residents who need sand or salt for their driveway. If anyone has any problem with access please let the Town Clerk, Road Foreman, Cemetery Sextons or the Selectmen know and we will help however we can.

Carlos Bean is looking after the park in East Burke and as anyone can tell he is doing a good job. The park is always well kept. One reason we make mention of this is that Carlos planted nine maple trees along the north side of the park. He dug these trees up on his own land, dug the holes and moved them by himself. He didn't want any pay for the trees or the time it took. The board felt that we should at least pay something towards the trees but Carlos told us he and Betty wouldn't take anything. We would like to take this opportunity to thank them for their donation and Carlos for the time and care he puts into the park.

We had eight "Bulky Days" this year. Every one of them was quite busy. We shipped 39.85 tons of bulky day waste. Of this total, one load was mostly used and broken skis from the Burke ski swap program. This year we shipped 356.14 tons of household waste to the landfill.

We had access to a hazardous waste day in Coventry at the landfill and we had one just for Burke residents in West Burke. We have received a grant for \$485.00 toward our hazardous waste program. In 2004 we are planning on having our own hazardous waste building. This should save us money plus give Burke residents more access to hazardous programs and recycling.

We purchased a 12-foot cargo trailer to park at the school and make it easier for the school to recycle. When it is loaded we pull it over to the recycling building and unload it.

We sponsored classes by the Vermont Association of Recyclers in the graded school. These classes with actors and props were to help the students learn more about burn barrels and protecting the air we breathe. The children learned more about how to recycle and reduce waste. We had a poster contest about burn barrels. The winning posters are in the recycling building for everyone to see. The town donated four composters to give as prizes to the winners of the poster contest.

Our recycling building is staying busy. We put the addition on this fall. We have an information rack with all kinds of pamphlets about recycling, composting, reuse and reducing waste. We received a grant from the Vermont Solid Waste Program for \$7,662.21 to help with the building and equipment.

In 2003 we collected a total of 96.24 tons of recyclables. We have shipped three trailer loads of baled recycled product totaling 66.24 tons. We are grinding all the glass that we get in. This year we ground up 15.97 tons of glass. This can be used for fill in certain cases and it saves a lot of weight from the landfill.

We accept used motor oil and used cooking oil for both the town garage and the recycling building. We use the oil to run our waste oil furnaces. We accept automobile batteries and used oil at all bulky days and at the recycling building. We have shipped 32.85 tons of scrap metal plus 7.08 tons of tin cans. We have contributed an estimated 2,600 lbs. of returnable for deposit bottles and cans to various organizations in town. We don't keep track of the dollar amount of the returnable containers; we just weigh the bags before they are picked up. We collect labels and box tops for education. We collect greeting cards and send them to St Jude's for children. We have started to collect good usable children's clothes. These are given out by the clothing and boot fund to needy families. We have composters for sale at the recycling building. We collect rechargeable batteries and fluorescent bulbs for recycling. We collect packing peanuts and bubble wrap for re-use. We are using one section of our recycling building to store reusable items. Anyone can drop off something that they think is too good to just throw away and could be of some use to someone else. We feel there is a need for a place people can drop off items that that could be useful to someone else. This would save useful items from being scrapped and sent to the landfill.


The body on the garbage truck was sandblasted and painted. We added decals of the little skunk "Pepe Le Pew" to make it run better.

Our selectboard meetings are the first Monday of each month. There is usually something interesting going on. We invite people to attend if you have any questions; suggestions or maybe you are just interested in what is going on. Our meetings are where we decide what bridges to repair, roads to work on and all the other decisions that are needed in town business. Public participation is always welcome and is really needed if your elected officials are to keep town affairs going as town residents would like.

## **MESSAGE FROM THE TOWN CLERK'S OFFICE**

### **For the year which ended December 31, 2003**

**Highlights from the Town Office for the year 2003 are as follows:**

**We seem to get busier and busier each year as you will see by some of the stats that we have shown below. Most are increases over the previous year.**

**This year we recorded 3,458 pages in the land records. This is an increase of 26% or 685 pages over last year. There still seems to be a lot of refinancing going on as people are taking advantage of the low interest rates. The mortgage deeds that we are required to record in our land records are at least 8 to 16 pages, some even more. This takes up a lot of room in our land records. Our land records are in pretty good shape. We continue to have a couple of volumes restored each year. The vital records are also being restored.**

**Twenty five marriage licenses were issued this year. There were 17 births and 9 deaths also recorded in our vital records.**

**We get a tremendous number of phone calls everyday covering just about everything you could imagine. Just for the fun of it we decided to log them everyday. As it turns out we logged 6,659 phone calls in 2003. This is an increase of 117 calls from 2002.**

**We registered 405 dogs in 2003. There were several dogs still unregistered at the end of the year. These dogs will still have to be registered for 2003 along with 2004. There will be a rabies clinic Saturday, March 6, 2004 at the Burke Town Hall, 3293 Burke Hollow Road from 11:30 a.m. until 1:00 p.m. This is a perfect opportunity to get your dogs vaccinated and registered at the same time. There will be staff from our office there to register your dogs for you. The deadline for registering your dogs is April 1. After that there will be a penalty applied. We must have a valid rabies certificate and spayed or neutered papers on file at the Town Clerk's Office prior to registration. The fee for spayed or neutered dogs prior to April 1 is \$5.00, non-spayed or neutered is \$9.00, and after April 1 the fees are \$7.50 and \$13.50 respectively. After May 1, the fees double to \$10.00 and \$18.00 respectively. Please remember that there is a dog ordinance which we do enforce. Please stop by the office to pickup a current copy. All owners must keep their dogs under control at all times.**

**If you are planning on bringing your dogs or cats to the Rabies Clinic, please have your dogs on a leash and your cats in a carrier as requested by the Vet.**

**We are still continuing to offer vehicle renewals. This is a service that is greatly appreciated by those of us who lead busy lives and just forget to send in our registrations on time.**



## Message From the Town Clerk's Office - Continued

We can renew a vehicle registration that has expired up to sixty days. We can only renew from a State generated renewal form. We do not accept cash for this service, checks or money orders only, made out to the Department of Motor Vehicles (DMV) for the amount of the registration. There is a three-dollar processing fee, which the Town gets to keep. This year we renewed 308 vehicles. This is an income of \$924. Fees like these, for the little extra work that we perform, help to pay for approximately 65% of our office expenses, reducing the amount required from property taxes.

We have had two new additions to the Town Clerk's office this year. The Board of listers have had two resignations and we gained two very competent new listers. Many of you already know Irene Sawyer who had been chairman of the Planning Commission for many years. Irene is extremely knowledgeable of the Town. The other new lister is Susan Rowe. Susan has been in the area for awhile. Susan was Business Manager at Burke Mt. Academy. She has an extensive background in accounting and is also familiar with the Marshall Swift program which is a program listers use in assessing property. Both Susan and Irene bring a wealth of knowledge to the Board of Listers and we would like to welcome them to the Burke Town Office.

The Lister's files are available Monday thru Thursday from 10:00 a.m. until 3:00 p.m. or by appointment.

Continuing Education in the Clerk's office is a big concern of mine. I am still on the Continuing Education Committee for the Vermont Clerk's and Treasurers Association. I learn so much from this committee and also from the workshops that we put on. I feel that I can run my office more efficiently. This year I had the honor of being appointed to the Executive Board of the Vermont Clerk's and Treasurer's Association.

The Town Clerk's office moved from the north side of the building to the south side which has a nice southern exposure. It also has more space. The meeting room is where the Town Clerk's Office used to be. This has worked out well for all. ## VERMONT LEAGUE OF CITIES AND TOWNS

The Vermont League of Cities and Towns' mission is to serve and strengthen Vermont local government. Most government services used by Vermonters on a daily basis are those provided by its cities and towns. These include highways, police, fire, recreation, sewer and water. Vermont municipal officials are responsible for raising and expending nearly one-half of the non-federal taxes raised in the state.

In large part, volunteer, elected and appointed municipal officials lead these governments. VLCT provides the following services to its member cities and towns to serve and strengthen the ability of the these officials to provide quality services at affordable levels of taxation:

- Advocacy representation before the State legislature, administration and judiciary, ensuring that municipalities have the resources and authority to serve their citizens. VLCT is a leader in the education and in securing revenues for town highway and bridge maintenance programs.
- Training, technical assistance and publications to strengthen the ability of municipal officials to serve their communities. In the past year, we have responded to almost 50,000 telephone calls, 21,200 of them from local officials on the toll-free telephone line available to them. Our Municipal Assistance Center and Group Services staffs provided over 750 workshops and small group training sessions attended by over 4,000 municipal officials and answered over 2,300 legal questions posed by municipal officials. VLCT distributed over 575 copies of local government publications and distributed over 3,200 hard copies or electronic mail versions of VLCT's *Weekly Legislative Report* to municipal officials each week during the legislative session.
- Purchasing opportunities to provide needed services at the lowest cost. These include an array of municipal insurance programs, among many others. Examples of how this saves local taxpayers dollars are the securing of municipal employee health insurance and liability coverage for town operations. The VLCT, Health Trust represents the most affordable option available to provide health insurance to your employees. The value of VLCT PACIF to all our members was made painfully clear last year when the major re-insurer for the largest private sector option available for municipal property and casualty insurance was declared insolvent by the State of Pennsylvania, threatening the payment of claims made under those policies.

All 246 Vermont cities and towns are members of VLCT, along with 140 other municipal entities including villages and fire districts. Membership dues are \$.72 per capita plus a \$250 service fee per year. VLCT maintains its offices in Montpelier and employs 42 staff members. It has an annual operating budget of approximately \$3.0 million.

# Who's Who in Local Government

A Publication of the Office of the Secretary of State

President Teddy Roosevelt said, almost a century ago that *"Far and away the best prize that life offers is the chance to work hard at work worth doing."* When he included these words in his speech at the State Fair in Syracuse, New York in 1903 he could have been speaking of Vermont's many hardworking local officials. Nearly 5000 municipal officials in our 237 towns, nine cities and 45 villages, devote their free time to everything from hearing zoning disputes and writing land use plans to assessing the value of property in the town and collecting delinquent taxes. They serve for the chance to "work hard at work worth doing." Without them, our communities would not function and our system of self government would come to a standstill.

Serving in local office is a great way to give something back to your community. So why don't you take a turn? Here are the offices you can choose from:

The Following Officials Are Elected At Town Meeting:

**MODERATOR** - Runs the Annual and Special Town/School Meeting. Should have a good sense of humor, be good at group process, and have experience following Roberts Rules of Order.

**TOWN CLERK** - Records, preserves and certifies the public records of the town, issues dog, marriage, civil union and hunting and fishing licenses and motor vehicle renewals. Runs the local elections, serves as clerk of the Board of Civil Authority, and hears tax abatement requests and tax appeals. Should have the patience of a saint and be a good ambassador for the town.

**TOWN TREASURER** - Keeps the town and school's accounts (unless a separate school treasurer is elected), invests money (with the approval of the legislative body,) keeps a record of the taxes voted and pays orders drawn on him or her. Should be very precise, detail oriented and good at math.

**TOWN ADMINISTRATOR** - Hired by the selectboard, the town administrator, sometimes called the administrative assistant to the selectboard, assists the selectboard in managing the business of the town. The town administrator has no independent statutory authority. The scope of his or her duties is determined by the selectboard.

**SELECTBOARD MEMBERS** - General supervision and control over town, enacts ordinances, regulations and policies for town, oversees town property and personnel, prepares, presents and manages budget, oversees roads, including laying out, discontinuing and reclassifying roads, sits as local board of health, liquor control commission and sewer commission. Should know the town well, be able to understand all sides of complex issues, and have very thick skin.

## Who's Who in Local Government (Continued)

**LISTERS** - Appraise property within the town for the purpose of property tax assessment. Should be able to be polite, yet firm, and not oversensitive to criticism.

**AUDITOR** - Review and audit all town accounts and prepare the annual town report. Should be very detail oriented. Good, clear writers are a plus.

**CONSTABLE** - In some towns the constable is the town's local law enforcement officer, with all powers of search, seizure and arrest within the town. In other towns the constable only has the power to serve civil process, assist the health officer in the discharge of his or her duties, destroy unlicensed dogs, kill injured deer, remove disorderly people from town meeting, and, if the First Constable, to collect taxes, if no tax collector is elected. Should be good at de-escalating and resolving conflicts.

**COLLECTOR OF CURRENT TAXES** - Collects the taxes for the town. In many towns this function is performed by the Treasurer or Town Manager. Should be detail oriented and good with numbers.

**COLLECTOR OF DELINQUENT TAXES** - Collects delinquent taxes for the town. Should be good with numbers and also able to work with people who are in difficult circumstances. Should also have thick skin.

**GRAND JUROR** - Helps to prosecute criminal offenses that occur in the town by giving information to state and local law enforcement. (Generally not a very active position.)

**TOWN AGENT** - The town agent used to prosecute and defend suits. The selectboard now have that authority. Thus, the Town Agent's duty consists merely of assisting when litigation is in progress at the request of the selectboard. (Generally not a very active position.)

**TRUSTEE OF PUBLIC FUNDS** - Manages, invests and reports on real and personal property held in trust by the town. This includes cemetery trust funds. Should like investing money.

**TRUSTEE OF PUBLIC MONEY** - Oversees "United States Public Money" received under the Act of 1836 held by the town. (It is unlikely any Vermont town still has these funds.)

**CEMETERY COMMISSIONER** - Responsible for the care and management of the town's cemeteries. If no cemetery commissioners are elected the Selectboard fulfills this role.

**PATROLMEN** - Patrols town highways under the direction of the selectboard - if the town so orders. (Generally not an active position.)

## Who's Who in Local Government (Continued)

**ROAD COMMISSIONERS** - Can be elected or appointed. Has no independent authority, but can assist the selectboard in overseeing town highways at the request of the board. Should have experience with town highways and be a good communicator.

**WATER COMMISSIONERS** - Water commissioners supervise the town's water department by establishing water rates and all the rules and regulations for the control and operation of the department. Should be a good manager and detail oriented.

**PLANNING COMMISSIONERS** - Appointed unless town votes to elect. Duties include preparing a municipal plan, making recommendations on matters of land development, conservation, and preservation, and to participate in a regional planning program. Makes site plan and subdivision permit decisions unless there is a Development Review Board in town. Should have a good working knowledge of all aspects of the town and be able to listen to many sides of an issue.

The Following Local Officials are Appointed by the Legislative Body:

**MUNICIPAL MANAGER** - If the manager system has been adopted by the electorate, the town manager is the official administrator of the local government and general supervisor of the affairs of the town.

**ZONING ADMINISTRATOR** Appointed by the planning commission with the approval of the selectboard. Approves or denies applications for zoning permits. Administers the municipal bylaws literally. Enforces regulations pertaining to the zoning ordinance.

**ZONING BOARD OF ADJUSTMENT** or development review board members – Holds hearings and makes decisions on land use permit applications and appeals from decisions of the zoning administrator.

**REGIONAL PLANNING COMMISSION REPRESENTATIVE** - Helps develop the regional plan and assess municipal land use plans.

**CONSERVATION COMMISSION MEMBERS** - Inventory, natural resources of a community and purchases and administers municipal lands for the purpose of conservation.

**HEALTH OFFICER** - Appointed by the Commissioner of Health to a 3-year term after recommendation by the town selectboard. Enforces the rules and regulations for the prevention and abatement of public health hazards.

**Who's Who in Local Government (Continued)**

**TOWN SERVICES OFFICER** - Appointed on or before April 15th of each year. Assists individuals within the town who require emergency food, fuel or shelter assistance when the Vermont Department of Social Welfare is not available.

**PATROLMEN** - Patrols town highways under the direction of the selectboard - if the town so orders. (Generally not an active position.)

**AGENT TO CONVEY REAL ESTATE** - Executes the deeds on behalf of the town.

**POUNDKEEPER** - Cares for the animals that are impounded within the town.

**TOWN ENERGY COORDINATOR** - Responsible for developing the town energy plan and conducting the town energy audit.

**TOWN FOREST FIRE WARDEN** - Appointed by the fire commissioner with the approval of the selectboard. Prevents forest fires in the town by enforcing the laws designed to prevent forest fires. Chairperson for Civil Defense - responsible for the organization, administration and operation of the local committee that is formed for emergency management in the town or city. The emergency management chairperson is under the direct control of the selectboard but may coordinate his or her emergency management efforts with neighboring towns and cities and with the state emergency management division, and with the federal government.

**BUILDING INSPECTOR AND DEPUTY INSPECTOR** - Appointed only in towns that have adopted a building code. Performs inspections and enforces the local building code.

**FENCE VIEWERS** - Three viewers are appointed by the selectboard each year. When called up they examine fences and other boundaries within the town.

**INSPECTORS OF LUMBER** - Appointed upon request to examine, measure, and classify the quality of lumber, shingles and wood sold within the town.

**WEIGHERS OF COAL** - Serves as a referee over weights of contested loads of coal.

**INSPECTOR OF WIRING** - Inspects electrical wiring in buildings on request of the selectboard.

**SERVICES OFFERED BY THE TOWN OF BURKE**

The following is a list of services provided to the taxpayers and residents of the Town of Burke. If there is something that is not listed and you want to know about it please contact the Town Clerk's Office.

**Rubbish Removal** Curbside pickup each Tuesday morning beginning at 7:00 a.m. You are required to have an orange "B" sticker on your rubbish bags or to use a yellow 33 gallon "B" rubbish bag. These are sold in the area stores (East Burke Market, Bailey's and Burke in East Burke, Mike's Redemption, West Burke Quick Stop, Aldrich's General Store and The Town Clerk's Office in West Burke). The bags and the stickers are \$1.50 each.



**Recycling Center** The Recycling Center is located at 212 School Street behind the Town Clerk's Office. The hours are Wednesday from 3:00 p.m. to 6:00 p.m. and Saturday from 8:00 a.m. until 12 noon. The following materials are accepted:

#1 and #2 plastics, mixed paper, boxboard, corrugated cardboard, newspaper, magazines, catalogs, telephone books, Aluminum cans, Tin Cans, tinfoil pie plates, glass of all colors, bubble wrap, packing peanuts and air packs.



Computers and microwave ovens are accepted for a fee of \$.18/lb.



**Fund Raisers**

Box tops and Campbell's labels are collected for education. Returnable bottles and cans are collected and given to various groups as fund raisers. We also collect all Occasion Cards, used eyeglasses and costume jewelry



You may bring good reusable items to put in our "FREE SHOP" corner



If someone needs something specific collected and saved, we try to accommodate them.

**Composters** — available for sale for \$30 each

**Bulky Waste Day** – Held every third Saturday of each month, from April to October, to give everyone the opportunity to get rid of big items such as beds, furniture, TV's, yard stuff, metal and used oil. You must get an authorization slip from the Town Clerk's office. You are allowed to bring up to one pickup load of bulky items. In addition to used oil, the town also accepts car batteries, rechargeable batteries, batteries from battery-operated tools, and florescent light bulbs. There is a \$25 charge for refrigerators and freezers and a \$3 charge for each tire.



**Haz-Mat Day** - Household hazardous waste is accepted twice a year. In the Spring we join with other area towns in taking our HHW to Coventry. In the Fall we have a Haz-Mat Day at the Town Garage off, School Street. We are in hopes of having our own Haz-Mat Facility in Burke this coming year—2004



**DMV- Motor vehicle renewals** The Town Clerk's Office renews vehicle registrations for a processing fee of \$3.00. You must have your current renewal form generated from the State of VT.



**Notary Public**—There are three Notary Publics in the Town Office who can notarize your very important documents. This service is free to the public.





## A MESSAGE FROM YOUR FRIENDLY RUBBISH ATTENDANTS

### SUGGESTIONS TO MAKE YOUR CURBSIDE RUBBISH PICKUP SERVICE RUN MORE SMOOTHLY

WE WOULD LIKE TO SUGGEST THAT EVERYONE GET A 30 GALLON CONTAINER WHO DOES NOT ALREADY HAVE ONE AND PUT ONE STICKER ON THE TOP BAG—THIS WILL PREVENT SOME PEOPLE FROM USING TOO MANY STICKERS AND HELP WITH THE ONES WHO DO NOT USE ENOUGH.

\*\* Please make your rubbish containers visible to the Rubbish Truck driver from both directions

Use containers no larger than 30 gallons. Please do not use 55-gallon drums to put your trash bags in. It makes it very hard to get the bags out.

\*\* Try to be considerate about the weight of each bag. You may put more than one bag in a thirty-gallon container and place a "B" sticker on the top bag. If bags are not placed in a 30-gallon container each bag must display a "B" sticker visible to the driver. Any bags without the stickers will not be picked up. Bags that are too heavy for the workers will be left to be rebagged for next week. You can buy your "B" stickers and "B" bags at any of the stores in both East Burke and West Burke and also at the Town Clerk's Office.

\*\*\* Do not put out tires, fluorescent bulbs or metal at curbside. We will take these items at the bulky days during the summer.

### MESSAGE FROM THE RECYCLING CENTER

The recycling center in Burke has had a good year. The tonnage of recyclables is up from last year. We received a twelve hundred dollar (\$1,200) grant for educating our community on the hazards of barrel burning. A new addition has been built onto our existing building for extra storage.

The swap shop or reuse shop is up & running with much success. We are taking in more items, such as, packing peanuts, bubble pack, cell phones, eye glasses and costume jewelry. Some of the cardboard and newspaper has even been used by a local business to use for shipping of their products.

Just to let you know a few facts on what your recyclables are made into once they leave our building:

- Paper goes into the making of boxboard, notebook coverings, and more paper;
- Cereal boxes go into the middle of board games;
- Cardboard goes into more cardboard;
- Plastics make fill for sleeping bags, it also goes into making carpet and making new paint containers.

Remember before you throw something into the trash, it costs you \$1.50 per bag and it costs the town \$72 per ton to deposit it in the landfill. If you recycle your mixed paper, cardboard, plastics, aluminum, it brings money into the town. Did you know that recycling one ton of paper can save seventeen trees for the future generations.

We have several composters available for sale for \$30.00 each.

I would like to thank the people of Burke for their financial support and dedication to the recycling program. Any suggestions to make it better are welcome. The recycle center is always willing to help the community collect items for art, gardening, business projects, etc. Anything to help prevent items from going into the landfill is our goal.



## BREAKDOWN OF RECYCLING CATEGORIES

CATEGORY	DESCRIPTION
1	<b>MAINE PACK</b> – Newspapers, with inserts, telephone books, magazines, catalogues.
2	<b>NORTH SHORE MIX</b> – Junk mail, mixed office paper, classroom paper, box board, fax paper, single layer cardboard, gift wrap, egg cartons, shredded paper, Any color is fine. No containers that have direct contact with food will be taken such as donut boxes and most pizza boxes and waxed containers such as Chinese take-out.  Please open junk mail to take out any contaminates. Also, please rip off anything that has been contaminated with food and throw away.
3	<b>OLD CORRUGATED CONTAINERS</b> – brown corrugated cardboard. Staples are OK, tape is OK, please remove the plastic shipping list. Kraft paper bags are OK. No Duct Tape.  <u>UNACCEPTABLE MATERIAL</u> – Foil containing juice boxes, blueprint paper, carbon paper, waxed or polycoated boxes, gable-top dairy container, food contaminated paper, tissue and paper towels, rubber bands, string, metal or plastic bindings, no books, no ribbon.
4	<b>GLASS</b> – All colors together
5	<b>#1 PETE PLASTIC</b> – Clear and green  Brown, blue, or tinted pete containers are not accepted. Also no automotive, animal care, lawn and garden or medical product containers.
6	<b>#2 HDPE PLASTIC NATURAL</b> – Natural milk containers and water bottles only. Oil containers and hazardous product containers not acceptable.
7	<b>#2 HDPE PLASTIC COLOR</b> – Household detergent and personal care bottles. Hood light block milk jugs also go in this group. Also acceptable are Welch's frozen concentrate plastic bottles labeled #2.  Oil containers and hazardous product containers not acceptable.  The rule of thumb when dealing with HDPE, bottles will have side seams and necks that are narrower than the base.  All containers must be empty, clean, and without lids.
8	<b>ALUMINUM</b> – Cans that can be crushed easily such as V-8, soda, etc.
9	<b>TIN CANS</b> – Pie Plates, Aluminum foil, wire coat hangers.



## HOUSEHOLD HAZARDOUS WASTE COLLECTION DAY

The Town of Burke with Special Assistance from Heritage Environmental Services of Williston, Vermont sponsors two Household Hazardous Waste Collections Days per year to comply with our "State Plan". One is offered in the spring and another in the fall. Please look for dates and times to be announced at a later time.

### WHAT IS HOUSEHOLD HAZARDOUS WASTE COLLECTION DAY?

Household Hazardous Waste is any discarded household material that can be classified as toxic, corrosive, flammable, or reactive/explosive. \*Paint, \*Acids/bases, \*Hobby Chemicals, \*Pesticides, \*Cleaning Products, \*Batteries, \*Thinners/strippers.

There may be both short-term and long-term harmful effects to humans and the environment from improper use and disposal of household hazardous waste.

To protect human health and the environment, the Town of Burke is sponsoring this one-day collection event two times per year.

Residents can bring unwanted household hazardous wastes to the Town Garage off 212 School Street in West Burke at times to be announced. Staff from a licensed hazardous waste disposal firm will package and transport the waste to an approved disposal facility. There will be no charge to Town residents wishing to participate in this event. Please refer to the list of acceptable and unacceptable materials when preparing for this event.

### WHO MAY PARTICIPATE?

Residents of the Town of Burke only. These special days are designed for collection of household generated materials only. Business waste will not be accepted during the hours of collection without prior arrangement. There will be a charge for accepting business waste. Please call the Town Clerk's Office at 467-3717 for more information.

We are sorry, but due to the cost of offering this event, we must limit participation to Town of Burke only. Please follow these instructions:

**\*\* Keep all products in their original containers with labels intact.**

**\*\* Place individual containers in sturdy cardboard boxes for transportation to the collection event. You may want to use newspaper or cardboard to keep items from tipping or hitting each other during transportation. Make sure all lids are on tight.**

**\*\* Wrap leaking containers in newspapers and place in clear plastic bags. Make sure lids are tight.**

**\*\* Do not mix any chemicals or pesticides together. Place any chemicals that might react with each other in separate areas of the vehicle.**

**\*\* Do not leave products in hot, unventilated vehicles for an extended period of time.**

**\*\*Do not smoke near any chemical products. Smoking and eating are prohibited on site.**

**\*\* Participants are discouraged from bringing small children or pets to the collection event. Neither may leave the vehicle once on site.**

Our office has gone through many changes this past year. Listers Rick Libera, who had served for four years, and Byron Calkins, who had served for three years, both resigned during the year. We thank them for their service and wish them well. Irene Sawyer and Susan Rowe were appointed by the Board of Selectmen to fill the vacancies until elections are held at Town Meeting. Irene and Susan come from diverse backgrounds, but share the goal of treating all properties fairly and equally.

We are currently checking all Listers' files to be certain that they are complete and accurate. In February and March, we will be sending out letters to the property owners that need a site visit or other updates. We appreciate your cooperation with this matter.

There were 156 property transfers this year compared to 129 the previous year. Property in Burke is selling at up to 160% above the listed value, which is indicative of the need for the upcoming Town wide reappraisal. We mailed out RFP (Requests for Proposals) to all state approved appraisal firms. The Board of Selectmen will review any bids that the town office receives and award the contract. We assessed 13 new homes, 10 new garages, 3 mobile homes, 4 additions, 1 new barn, 14 new sheds and 1 new camp.

The State has mandated many changes to implement the ACT 68 for the year 2004. The State must receive your Homestead Declaration by April 15, 2004. All town residents must file a "Declaration of Vermont Homestead" (HS-131) by April 15, 2004. Please read the form carefully as it explains many of the changes. We would like to emphasize that you must live in that dwelling as of April 1. More changes are being proposed as implementation of Act 68 nears.

## BURKE PLANNING COMMISSION 2003 Accomplishments

It was a busy, exciting year for the Planning Commission. We dealt with subdivisions, alternative energy issues and started the process of revising the Burke Town Plan. We had significant citizen support and participation, which we hope will continue!

**The Burke Town Plan:** The Planning Commission initiated a project to revise the Town Plan. All the expenses associated with this project are covered by a grant that the Planning Commission applied for and received. The project started with a review and critique of the current town plan and a compiled a list of recommended changes, issues, and topics to address. In order to learn what planning issues were important to Burke citizens and property owners we created a "Burke Citizen Public Survey" questionnaire that was mailed in September. We mailed over 1,600 questionnaires and received 500 responses. This was an excellent response rate for this type of survey and the citizens of Burke are to be commended for taking the time to record their opinions. Survey respondents also provided many additional and valuable comments, which will help the Planning Commission understand the most important issues in the town. The survey responses have been tabulated and a report will be prepared. The goal of the Planning Commission for 2004 is to create a draft of a revised town plan based on the information collected from the public survey and from other sources.

**Subdivisions:** The board approved 11 subdivisions in 2003. No subdivisions were denied.

**Alternative Energy/Viewshed Protection:** Due to several proposals to place wind turbines on ridgelines surrounding Burke, the Planning Commission was requested by a group of citizens to create a policy to protect the scenic areas of Burke. A public hearing was held in September to solicit citizen input. The Planning Commission worked with the Selectboard to create a scenic protection policy. In January 2004, there was public meeting to authorize the Planning Commission and the Selectboard to incorporate the Ridgeline Protection Policy and Interim Ordinance into the Town Plan and its attendant Zoning Regulations. This Ordinance will now come back to the Planning Commission to go through the proper steps to be incorporated into the Town Plan.

**Planning Commission:** The membership of the Planning Commission changed in 2003. Irene Sawyer resigned as Chairperson after many years of dedicated service. The present members, all volunteers, consists of Al Duey, chairperson, Carlos Bean, vice-chairperson, Darryel Corrow, Merton Leonard, Dean Shatney, Mike Sylce, and Diane French, secretary and board member.

The Planning Commission meets on the second Thursday of each month at 7 PM in the Burke Town Clerk's meeting room. Citizens are encouraged to attend these meetings and participate in Burke's planning initiatives.

## 2004 APPROPRIATIONS REQUEST

Because the reports from organizations asking for appropriations cover many pages they have been condensed. There is a short description of what the organization does for the people of Burke and if the information is present the number of people that have received help. There will be a representative from some of the organizations at the informational meeting and the name of the representative has been given. Summaries are in the order of articles asking for money. Every taxpayer who is interested in how their money is spent should take the time to look at the financial statements of those asking for tax dollars. The complete reports are available and certainly would give the taxpayer an indication of the amount of money spent on different aspects of health care, recreation, education, and development in the area. These full reports are at the Town Clerk's Office and are available for your inspection Monday - Friday - 8:00 a.m. - 4:00 p.m.

**ARTICLE 7 - East Burke Fire Department – Request - \$10,000.**

**ARTICLE 8 - West Burke Fire Department – Request - \$12,000.**

**ARTICLES 9 - Lyndon Rescue Squad - Request - \$23,919.00.**

Because the fire departments and Lyndon Rescue depend heavily on the Town for funds the full reports are printed as submitted.

**ARTICLE 10 - Catamount Arts - Request - \$500.**

This request is the same as last year. Funding will be used to enhance arts education programs and programs that benefit young people. They offer art classes and workshops for adults and children.

**ARTICLE 11 - Cobleigh Public Library – Request - \$600.**

This request is the same as last year. It will help continue the library's many programs and services for all area towns. The Cobleigh Public Library in Lyndon is committed to serving individuals and families with free library services. The Library has long served the residents of all towns in the area and does not charge for library cards, use of the library services or attendance at programs.

**ARTICLE 12 - East Burke Community Library – Request - \$300.**

This request is \$100.00 lower than last year. Each month the Library has a different "theme" with appropriate materials displayed in support of that theme. This year 145 library cards were issued, 1,400 people visited the library. Over 200 new books were purchased or donated. Thirteen new chairs were also purchase for the library.

**APPROPRIATION REQUEST (Continued)**

**ARTICLE 13 – Fairbanks Museum and Planetarium – Request - \$840.**

The request is the same as last year. The amount is based on \$0.60 per resident with all residents receiving unlimited general admission to the museum. The money is used for the care of the historic building, for maintenance and exhibition of the most extraordinary educational collections of northern New England, and for meeting in part the costs of their services and programs for the region and its visitors. The Museum has extended its public hours by 12 hours per week.

According to Museum records, nearly 10,000 area residents take advantage of the free admission that accompanies municipal support each year.

**ARTICLE 14 - Lyndon Area Senior Action Center, Inc. - Request - \$200.**

The request is the same as last year. This goes toward keeping the center functional for all senior citizens. This facility is available to all.

**ARTICLE 15 - Northeast Kingdom Human Services, Inc. – Request - \$1,650.**

The request is the same as last year. The Northeast Kingdom Human Services, Inc. is a private not-for-profit Organization serving Essex, Caledonia and Orleans Counties. It is organized and directed by local citizens who believe the human services should be cost effective and responsive to the needs of our local communities. NKHS served 88 Burke residents in 2003

**ARTICLE 16 - Northeast Kingdom Learning Services – Northeast Kingdom Adult Education and Literacy Program - Request - \$200.**

The request is the same as last year. They provide on-demand home and learning center services to residents of Burke as well as to almost anyone in Caledonia, Essex, or the tri-county area. They provide instruction for students who wish to obtain their G.E.D. or an Adult diploma, or study for a Commercial Drivers License and in general to study to improve job skills. Town appropriations go toward the purchase of books and other educational materials.

**ARTICLE 17 - Northeast Kingdom Youth Services - Request - \$750.**

The request is the same as last year. Northeast Kingdom Youth Services (NEKYS) is available to teens and their families twenty-four hours a day every day. NEKYS has provided crisis intervention and outreach programs to families for 24 years. Programs include shelter, Court Diversion of Caledonia and Essex Counties, a Parent Support group, Transitional Living, and Independent Living, as well as Outreach to Schools and communities. NEKYS Staff is committed to helping teens become productive members of the community. NEKYS served 110 Burke residents in 2003. In 2002 – 113 and in 2001 155 were served from the Town of Burke.

**ARTICLE 18 - Northeastern Vermont Development Association - Request - \$659.82.**

The request is up \$63.82 over last year. This year's request is based on the 2003 appropriations or \$.42 cents per capita, whichever is greater. NVDA has been around a long time. They have been instrumental in getting grants for a large variety of projects in the tri counties. They help with studies, relicensing of dams, and mapping areas that need information. They work with small businesses that wish to expand and in general work toward development in the area. They have helped with Enhanced 911 and local Towns with transportation projects.

**ARTICLE 19 – Pilgrim Manor Meal Site and Senior Center - Request - \$500.**

The request is the same as last year. Money will be used to provide extra activities for the seniors in the area. The appropriation was also used to help purchase groceries for the senior meals.

**ARTICLE 20 - Vermont Leadership Center (The Kingdom Corps.) - Request - \$800.**

This is an increase of \$500.00 over last year. The Kingdom Corps hires young men and women from the region to explore the world around them and work together to complete high-priority community service projects. In 2003, 4 Burke residents logged in more than 900 total work hours restoring eroding riverbanks, improving wildlife habitats, and maintaining trails throughout the Northeast Kingdom, including sections of the Kingdom Trails network and the Burke School Fitness Trail.

\*\*\*\*There are 14 requests for appropriations for 2004 for a total of \$52,918.82.

Again this year we have requests for the following, which will be paid out of the Darling Trusts with funds available to the Town to be used for this purpose.

The WEST BURKE VOLUNTEER FIRE DEPARTMENT is requesting an appropriation of \$12,000.00 for 2004. This is the same as last year. We were fortunate to receive a FEMA grant this year for money to buy a replacement portable pump, fire turnout gear, and portable radios. This coming year we will be applying for any grant money available but cannot count on the availability, therefore we are asking for the same appropriation as last year to maintain our volunteer fire protection service.

2003 has been difficult with the untimely loss of Chief John Villeneuve. His son Tom has accepted the role of Chief and is adapting quickly to the position.

Equipment replacement still remains our largest continuing expense, mostly due to extreme exposure, damage, and loss while fire fighting.

The Fire Station facility is in need of repairs including re-staining the exterior and painting the interior on both floors. The upstairs meeting room needs carpet cleaning.

We are always pleased and very thankful for all donations received throughout the year. This helps cover unexpected expenses we seem to incur each year.

The WEST BURKE VOLUNTEER FIRE DEPARTMENT has 11 active volunteer members on call 24 hours, 7 days a week, serving the greater West Burke, Burke Hollow, and surrounding area. Our Department is also available at any time for mutual aid request service from surrounding towns. We are working with a closer mutual aid association with the East Burke Fire Brigade. Due to the lack of active volunteers with each unit, it is becoming a better responsive practice to have both departments responding together to major fires in town.

During 2003 our unit responded 36 times to a variety of situations. Also, we participated in fire drills, fire prevention seminars, and education courses.

To the Residents of Burke,

The Crewmembers of Lyndon Rescue wish to thank our member towns for their continued support and the opportunity to serve. We responded to over 920 calls, including over 150 transfers (hospital to hospital, hospital to home, etc), completed our first year as a fully paid service and stayed within budget despite the challenges of dealing with slow-paying insurance companies and compliance with new government regulations. Our roster includes one Director, five Advanced Life Support (ALS) EMTs and four Basic Life Support EMTs and a handful of Lyndon State College student and other local volunteers.

The transfer ambulance we purchased last year has been on the road to Dartmouth and other area hospitals regularly, providing a comfortable and safe ride for our patients. We also received a grant from the USDA to help pay down the loan for this vehicle. Through the generosity of a federal grant, we now have several new Automatic External Defibrillators in the community. All the evidence on cardiac arrest points to early defibrillation as the number one factor in saving a life. Additional grant money from the Department of Homeland Security will give us the ability to better respond to a large-scale disaster.

The biggest challenge we face is the shortage of care providers. We can report that the EMT-Basic course returned to the Lyndon State College curriculum and will be offered again in the Spring semester. This course is open to both LSC students, who will earn three credits, and community members who may take the course at a significantly reduced cost. We continue to work with the college on a new two-year degree, Associate of Science in Emergency Medical Services – Paramedic. The addition of this degree would bring experienced EMTs to our area for training, and while here, they would join our crew. The more responders we have in the community, the faster help gets to those who need it.

A continuing problem remains the lack of 9-1-1 numbers on buildings. In an emergency, it is critical that your property be correctly identified for emergency services. We can produce your 9-1-1 sign for only \$10.00 – very cheap insurance! Remember – *if we can't find you, we can't help you!*

We are also working with the College on plans to expand our building. Our sleeping quarters and garage spaces need to be brought up to code - one ambulance has lived outside for over a year. We are looking for funding for this project both from the State and other sources. Finally, you should know that it costs about \$600 per ambulance run. With government regulations forcing us to accept reimbursements as little as 40%, higher costs for fuel, maintenance, insurance, medical supplies, as well as compliance with state and federal regulations, we must depend on the citizens we serve to bridge the gap between revenue and expenses. Some of this comes from direct or "In Memory Of" donations for which we are grateful. The remainder must come from you. Consequently, Lyndon Rescue requests the sum of \$23,919.00 so we may continue to meet your ambulance needs.

AND AUSTRALIAN BALLOT RESULTS**

The legal voters of the Town of Burke met Tuesday, March 4, 2003 at 9:00 A.M. in the Town Hall, 3277 Burke Hollow Road to transact the following business.

Moderator John Hall opened the meeting at 9:00 a.m. Moderator Hall asked for a moment of silence for the town residents who had passed on during the year.

**Article 1.** Shall the voters of Burke accept the Town Report? Nancy Berge commented on how nice the Town reports were and also made a motion to accept the Town report as amended. The amendment was on page 36, the East Burke Volunteer Brigade report where the words donations and fundraisers were omitted. Motion seconded by Joe Anastasia. Approved by voice vote.

**Article 2.** Shall the voters of Burke authorize the Selectmen to have all taxes paid into the Treasury as provided by law and if so to establish Wednesday, October 15, 2003 as the due date? Motion made by Dwight Davis, Seconded by Nancy Berge. Approved by voice vote.

**Article 3.** Shall the voters of Burke vote to authorize the Selectboard to borrow money in anticipation of revenues? Motion made by Ford Hubbard, seconded by George Wagner. Approved by voice vote.

**Article 4.** Shall the voters of Burke support the retention of the East Burke dam by opposing the proposed removal of the dam by the Passumpsic Land Trust? There was extensive discussion on this subject. Dwight Davis, Ford Hubbard and Herman Hoyt gave a detailed presentation and urged everyone to support this article. Virginia Elliott made a motion to table the article for lack of information. Mrs. Berge seconded. The audience voted against the motion to table. Ford Hubbard moved to vote on the article, Karl Wieland seconded. A vote was taken to support the article, which passed by voice vote.

**Article 5.** Be it resolved that the citizens of the Town of Burke urgently call upon our municipal leaders, state legislators, governor, and Congressional delegation to put Vermont in the forefront of a sustainable energy future. Specifically, we request immediate and ongoing action on legislative initiatives designed to promote energy efficiency in Vermont's homes, businesses, public buildings, and transportation systems, and to encourage expansion of the renewable energy industry in the state of Vermont.

Mr. Vernon Gray gave a detailed overview on Wind Towers and Wind Farms. He urged the taxpayers to vote against any proposals to allow wind farms in the area. A motion by Donna Otto was made to table the article until further information is available. Gerald Welden seconded the motion. The article was tabled by a voice vote.



Dear Burke Residents,

I find it amazing that I have become one of the most veteran educators having an historical perspective on education in this Northeast Kingdom district. Much has changed not only in education but in the world during the last three decades. I know for a fact that the knowledge base of your teachers in content areas and pedagogy of learning strategies, mixed with modern scientific research of how the brain operates is at an all time high in your school. Also at an all time high are the challenges and needs that our students bring with them through the schoolhouse doors. We can no longer ignore the impact that society and 21<sup>st</sup> century issues are having on our children and our families and our community.

The last five years has brought the most significant changes in education that I can ever remember. Your school went from a single dial up account to our current high speed wired and wireless connections. The explosion of information and digital technology is everywhere in our lives. More than half the people in our nation – and 65% of our children - are now online. As a country, we now use the internet for business transactions, shopping, entertainment, information searches, communication, and of course learning. (Economics and Statistics Administration, 2002). Although we are “connected” and after several years of Technology grants have acquired substantial equipment, software and professional services, we are only at the very tip of providing to our students the skills they will need to succeed in the 21<sup>st</sup> century.

I was fortunate to recently attend the Technology, Reading and Learning Difficulties Conference. One of the many presenters was Donald Leu, Endowed Chair of Literacy and Technology at the University of Connecticut. He addressed these skills not as “technology,” but as Literacy for the 21<sup>st</sup> century. According to Leu, “We would put ourselves at risk to depend only on the traditional literacies of print.” Especially since other countries of the world including Ireland, Finland, New Zealand and Australia are investing in these new literacies to promote, with success, their economic growth and development.

Another huge impact on education is the recent legislation known as *No Child Left Behind*. It mandates that ALL children (THAT MEANS EVERY SINGLE ONE) will MEET OR EXCEED rigorous standards. Testing has now become a very high stakes, political endeavor. Schools and or districts that don't meet these standards will be financially penalized or taken over by authorized or private agencies. (Interestingly, NCLB, better known as “nickel-B,” only uses the traditional literacies of print to assess children! There is no state in the union that allows students to use any of the technological accommodations they use on a daily basis with which to take their tests.) Other mandates and legal obligations span from confidentiality, civil rights and harassment not to mention drug and alcohol protocols and criminal screenings of providers. We live in a different time and yet struggle to hold on to the community commitment that has made Burke able to provide a place of hope and a simpler life.

Let me share one example of the “New Literacy” skills. As in the past higher order thinking processes need to be developed and taught. Skills such as identifying important questions (learning how to question), searching for relevant information, analyzing information critically, synthesizing and summarizing information to address the questions and then communicating answers to others through a variety of media are still important. Now add on top of these high level skills, the ability to read and evaluate the informational text on the Internet as compared to traditional informational text in books.

The challenge we face as educators, parents and community members is to help students develop 21<sup>st</sup> century skills that enable them to fully realize technology's most positive effects and balance it with our rural heritage.

Some days I feel overwhelmed by the changes and mandates put before us as educators and then as a community member trying to fund it. At the same time I am so excited by new knowledge and developments in helping all kids be successful (even if they don't meet the standards.) Every child's growth, no matter how great or small is an accomplishment. Some days I am very tired when I think about the roadblocks that stop us from doing what we know best. Other days I feel like I am just starting out as a traveler to a new land and listening to our children to guide me to where I have to go to help them.

I hope I have encouraged you to think about what our school might need to be in the future, the challenges we face as a community in educating our youth and the role we want to take in the global and digital technology education of our children. Perhaps I have allowed some of you to play in those higher order thinking arenas and kindled some great ideas for the future for Burke students.

Thanks to all those folks that do make our school a great place – all staff members, school board members, town officers and town office personnel, the road crew, parents, BSCA workers, community members and students– you know who you are! I look forward to sharing another year of challenging, but rewarding work.

## REPORT OF THE SUPERINTENDENT OF SCHOOLS

Two important initiatives are occurring in the district that focus on the traditional and central 3 R's of Reading, Writing, and 'Rithmetic albeit through the lens of modern and rigorous state and national standards. Federal funds have enabled skilled math teachers within CNSU to provide guidance and training to their colleagues. Federal funds have permitted the purchase of consulting services in English Language Arts from experts throughout Vermont. District teachers are devoting hours to honing their teaching knowledge and skills with the help of these professionals. In addition, initiatives are underway to offer alternative programming through Lyndon Institute for high school students and to create a regional collaborative to serve Caledonia County students on the autistic spectrum.

Although the media has reported on turnover among principals and superintendents in Vermont, relatively little attention has focused on the turnover of school directors. The school board plays the critical role of setting the overall direction of the school, reviewing the performance of staff and students, and monitoring the budget. Without sustained leadership, including that of the school board, schools flounder. Please support the efforts of your school directors and consider serving in the post yourself.

The budget recommended by the School Board is for Fiscal Year 2004-2005 (FY05). It reflects the transition from the Act 60 education funding formula to the formula established by the Legislature in Act 68. Under Act 68 the grand list will be split between homestead property and all other property. The education tax rate for homestead property will depend on the level of per pupil spending in your school district; the rate for all other property is set uniformly throughout Vermont by the Legislature.

In recent years the student population in Vermont has been declining. Accordingly, taxpayers rightfully ask if school costs can be reduced. I would make two observations: 1) In many settings, the per pupil cost cannot be held at previous levels because, although enrollment has dropped, a) the basic physical plant maintenance needs remain the same, b) regulations imposed at the state and federal level require the school to provide specific programs and services, and c) the public demands and authorizes programming beyond traditional academic instruction. 2) Vermonters cherish the benefits of community schools with small classes. Large savings in school budgets cannot be achieved without larger class sizes. Against this backdrop school boards struggle to control their expenditure budgets.

I value the contribution that each of you make to the budget discussion as well as the time and talent that you volunteer to your local school. No work, no legacy is more important than the preparation of children and youth to assume the responsibilities of adulthood.



## MATHEMATICS SUPPORT

The schools of Burke, East Haven, Miller's Run, Newark, and Sutton have benefited during the 2003-2004 school year from support offered in the area of mathematics. This support has been provided by Amy Patoine-Gale, through a position created and funded by federal Title HA grants. As Mathematics Teacher Leader, Amy has worked in the classrooms of many teachers in these schools. Support has taken a variety of forms, including coaching teachers in best practices in mathematics instruction, teaching model lessons for teachers to observe, planning instruction with teachers, facilitating meetings, and providing coursework related to mathematics.

One of the priorities identified for the Math Teacher Leader was to assist in the formation of mathematics teams within each of the five schools. The math team meetings bring teachers within the school together on a regular basis to confer on issues pertinent to mathematics instruction. Topics such as the new grade level expectations for state testing in mathematics are discussed. Plans are made to provide teachers and students with the instruction necessary to help improve understanding and results on assessments. The Mathematics Teacher Leader assists in implementing those plans, either within a classroom, across the school, or supervisory union wide, whatever is most appropriate.

## SPECIAL EDUCATION SERVICES

### UPDATE

The Caledonia North Supervisory Union has a commitment to, and engages in, practices designed to support the free, appropriate, public education of students with a wide range of disabilities in the general education setting as appropriate for each student. This commitment is based on and aligned with the federal law, Individuals with Disabilities Education Act (IDEA) of 1975. The regular education classroom is the first placement option for all students with disabilities in our district with proper consideration for their individual need for appropriate supports. Not all students with disabilities will necessarily be placed in the regular education classroom full time; the individual's program and placement will be determined in accordance with the student's rights as provided by IDEA. Each school in this district is committed to the least restrictive environment based on an individual's disability and learning style.

Support for general education access and the use of a variety of service delivery models for serving the needs of students with disabilities drives the need for paraprofessionals. The fact is, the number of special education referrals is rising as more and more students are coming to school with severe emotional and behavioral concerns along with learning impairments that impact on the regular education environment. Students who are not making appropriate progress in general education in meeting the Vermont standards/curriculum are then referred to special education for supplemental services. Ever-increasing standards and high-stakes accountability demanded by the state and federal government continue to add to the increase in special education identification and costs.

Vermont Act 230, adopted in 1990, requires a prescribed educational support system in each school to catch and remediate learning problems early on and to reduce referrals to the special education system. School districts are required to develop a Comprehensive System of Education Services that include an Education Support Team and system to provide supports to help all students be successful in school. In 2000 the Vermont Legislature passed Act 117. This Act mandated that schools develop a support system to increase participation of students in the regular education environment and to provide them with support regardless of their eligibility for categorical programs. The EST team, composed of several education staff members, assists teachers in developing accommodations and supports for their struggling students. It also requires school districts to provide training opportunities for ALL teachers and administrators on meeting the needs of all students. The intent of the act was to increase the ability of the school to meet the needs of students in the regular education environment without relying on alternative programs. The Education Support System may include services that are operated under different federal programs such as Title I, Section 504, and Special Education. Examples of programs are: Reading Recovery, guidance, nutrition services, teacher advisors, mentoring programs, Early Essential Education, Success by Six and Head Start. Funding for these programs is supported with a variety of local, state and federal funds. The fact that special education costs are rising faster than any other area of education is of great concern all over Vermont.

Questions and concerns continue to come up over the high cost of educating disabled students and the impact on the regular education environment. At the time IDEA was made law, many students with disabilities were not getting proper educational services, and at times no services at all. We continue to face many challenges in educating all students. Increases in costs are driven by the higher special education services count and related increases in the need for paraprofessionals to assist in educating ALL students appropriately.

Each school in the CNSU district shares in the commitment to meet the individual educational needs of all students. Although Vermont has a policy of inclusion, a pull-out model continues to be the most appropriate placement for students with more severe issues and educational needs. The demand for special education services and supports remain high in our district. IDEA protects and provides for all handicapped students, whatever the cost, to provide a "free and appropriate public education." Special education costs cannot easily be reduced unless there are alternative support services for kids. Act 230 was adopted to provide early, less costly, alternatives for students. CNSU schools continue to provide support to students through their Educational Support Systems.

**BURKE TOWN SCHOOL DISTRICT ANNUAL MEETING MINUTES**  
**March 3, 2003**

The Burke Town School District informational meeting and annual meeting were held Monday, March 3, 2003 at the Burke Town Hall at 6:30 P.M.

Moderator John Hall brought the meeting to order. He welcomed everyone and reviewed the order of business. He then read and explained each of the articles on the 2003 School District Warning.

After all of the articles were reviewed, Moderator Hall introduced Representatives Cola Hudson and Howard Crawford to the gathering.

Representative Hudson told the group that a lot of changes had taken place due to the new republican governor and his administration. Cola's committee worked on getting the age limit on judges removed. They are also working on an overhaul of the human services department.

Howard Crawford gave everyone a handout about Act 60. Student enrollment has been dropping statewide since 1997 and yet we have more teachers. The legislature is trying to devise a plan to pay for education, which does not rely so heavily on property taxes and also encourages cost containment. There may be an increase in the consumption tax and the sales tax. There is also a proposal to have separate tax rates for residents and non-residents.

Otto Kremer wanted to know if the tax increase on beer and wine would be used to support rehabilitation programs. Howard said that the increase would be used for education only.

School Director Tony Amodeo was the next to speak. He thanked CNSU, the School Directors, Sonny and all of the school staff who work so hard to provide a good education for all of our children.

Tony explained that this year's budget is up about 7%. The increase is due to salaries, increased secondary and special education costs and an increase in health insurance premiums.

Frank D'Ascencio wanted to know what the difference was between the "equalized tax rate" and the actual tax rate? Mark Belanger explained that the equalized rate is what taxpayers would be charged if all properties in Burke were taxed at 100% of fair market value as determined by the tax department. Right now, the tax department says that Burke properties are only assessed at 95.10% of fair market value. This means that the actual tax rate has to be set higher in order to raise the amount of monies we need for education.

Donna Otto asked why we need to designate Lyndon Institute as our designated high school? Sonny explained that this means that LI must accept all of our students without restrictions and it also puts a cap on the tuition that we pay.

**Moderator Hall returned to the podium to ask if there were any other questions. As there were none, he closed the informational meeting and opened the Annual School District Meeting.**

**Article 3. Shall the voters of the Burke Town School District authorize the transfer of \$36,000 from the Capital Reserve Fund to the general Fund for the fiscal year ending June 30, 2004 in order to reduce the tax burden in FY 2004?**

**A motion was made by Mike Harris and seconded by Ford Hubbard to adopt Article 3. The motion passed by voice vote.**

**Article 4. Shall the voters of the Burke Town School District authorize the transfer of \$25,000 from the Accrual Accounting Reserve Fund to the General Fund for the fiscal year ending June 30, 2004 in order to reduce the tax burden in FY 2004?**

**A motion was made by Tracie Surrige and seconded by Sonny Davis to adopt Article 4. The motion passed by voice vote.**

**Article 5. Shall the voters of the Burke Town School District authorize the School District to transfer any surplus on the district's General Fund from the school year ending June 30, 2003 to the Capital Reserve Fund?**

**A motion was made by Tracie Surrige and seconded by Howard Crawford to adopt Article 5. The motion passed by voice vote.**

**Article 6. Shall the voters of the Burke Town School District authorize and empower the School Directors to borrow money in anticipation of receipts and to give a note or notes in the name of the District to secure payment of thereof?**

**A motion was made by Sam Sanderson and seconded by Howard Crawford to adopt Article 6. The motion passed by voice vote.**

**Article 7. Shall the voters of the Burke Town School District authorize the School Directors to accept and expend such grant monies as may from time to time become available to the school district?**

**A motion was made by Dwight Davis and seconded by Linda Kane to adopt Article 7. The motion passed by voice vote.**

**Article 8. Shall the voters of the Burke Town School District authorize the School Directors to allow public use of school facilities and equipment pursuant to Title 16 V.S.A. 562/11?**

**A motion was made by Otto Kremer and seconded by Sam Sanderson to adopt Article 8. the motion passed by voice vote.**

**Article 9. Shall the voters of the Burke Town School District designate Lyndon Institute as the public high school for the Burke Town School District?**

**A motion was made by Weeza Sanderson and seconded by Roland Martin to adopt Article 9. The motion was passed by voice vote.**

Article 10. To transact any other business that may legally come before said meeting.

Barry Hertz wants the Board to look into establishing a preschool program in Burke. The following motion was made: Shall the voters of the Burke Town School District request the School Board to look into the possibility of re-instituting the preschool program in Burke? The motion was made by Barry Hertz and seconded by Russell Henderson.

George Willy wanted to know how much more people could afford to pay for school. This year's budget is 2.5 million dollars. He would be willing to support the program as long as it doesn't increase taxes. Barry Hertz said the benefits out weight the costs. We can pay now or we can pay later. The motion passed by voice vote.


