VERMONT BOARD OF ALLIED MENTAL HEALTH PRACTITIONERS
JULY 15, 2021 – REMOTE MEETING

1. The meeting was called to order at 9:13 a.m.
2. **Minutes** Mr. Irwin moved, seconded by Ms. Smith, to approve the minutes of the June 17, 2021 meeting as written. Approved.
3. Ms. Smith moved, seconded by Mr. Irwin, that the Board enter Executive Session for the purpose of receiving professional legal services, the premature general public knowledge of which would clearly place the Board and involved parties at a substantial disadvantage. Motion approved.

Mitchell, Caitlin – Mr. Waldron moved, seconded by Mr. Irwin, to request syllabi for all coursework on the transcript and verification from the school of internship. Motion approved.
