Supervised Practices spreadsheet—Dr. Wallis discussed with the Board and with OPR Director Chris Winters about the budgetary possibilities of consulting with an individual with sufficient expertise with Microsoft Excel to be able to format the spreadsheet in an efficient and effective manner. She will pursue and speak with Director Winters.

- a. Policy on Prorating Continuing Education Requirements: After discussion with Dr. Lewis, Mr. Novins drafted a policy to be reviewed by the Board. Item tabled until June, 2009 meeting when Attorney Novins will be present.

 - c. Dr. Root brought up the topic of requesting letters from conditioned licensees to the Board regarding their offenses and "rehabilitation" during the conditions placed on their license. Mr. Leahy joined the discussion to consult with the Board on this matter. No action taken. The discussion to continue at future Board meetings.
