Good Morning Pat,

Hope you're doing well today.

First, I haven't had the opportunity to congratulate you on your recent appointment. From my professional perspective, I can't tell you how encouraging and hopeful it feels to have you in this role.

The reason I'm emailing today: we are applying for federal resources on behalf of a statewide partnership to do job creation through business expansion/start-ups, serving primarily low-income Vermonters (see attached abstract). It's a really exciting proposal that focuses on the opportunities in composting, food rescue, organics diversion and recycling related to Act 148, the Universal Recycling Law.

We're hoping you'll be amenable to providing a letter of support by this coming Friday 7/11. I've taken the liberty of attaching a draft letter for your consideration. Feel free to get back to me with any questions and feel free to make revisions – we just minimally need to demonstrate that you're behind the application and that you're willing to make appropriate referrals.
