Analysis of Bill

1. Summary of bill and issue it addresses. *Describe what the bill is intended to accomplish and why.*

This bill raises the minimum wage every year in following phases:

\$9.15 on January 1, 2015

\$9.60 on January 1, 2016

\$10.00 on January 1, 2017

\$10.50 on January 1, 2018

On January 1, 2019 and each subsequent year the minimum wage will increase 5% or the percent increase of the CPI-U, whichever is smaller.

2. Is there a need for this bill? *Please explain why or why not.*

The minimum wage earners of Vermont are not able to make ends meet even if they are working more than a 40 hour work week. Studies have shown minimum wage workers live pay check to pay check and they spend the extra money they receive on consumer goods. This not only helps the worker but also puts more money into the State's economy.

3. What are likely to be the fiscal and programmatic implications of this bill for this Department?

With the incremental steps of the bill, we will not have to release a minimum wage increase every year until 2019 since it is defined in statute. After 2019, we will use of the CPI-U city average as calculated by the U.S. Department of Labor to determine the minimum wage, as we previously have done.
