Dear Gov. Shumlin:

Under the Vermont Public Records Law, §315 et seq., I am requesting an opportunity to obtain copies of public records created by written exchanges between and among your office, the office of Gov. Peter Shumlin, and anyone utilizing a "whitehouse.gov" email address containing the search terms "DHS," "immigration reform," and "executive actions."

The time frame for which I am seeking the records is November 1, 2014 to March 31, 2015.

If there are any fees for searching or copying these records, please inform me if the cost will exceed \$25.00. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public's understanding of the Amicus Curiae brief signed by 14 state attorneys general and the District of Columbia urging the U.S. District Court for the Southern District of Texas to lift its temporary injunction on Obama's declared executive actions on November 20, 2014 entailing "immigration reform."
