Meeting of September 4, 2014**

1. The meeting was called to order at 8:30 a.m.

2. The Chair called for the approval of the minutes of the August 7th meeting. Mr. Aldrich made a motion, seconded by Mr. Bartenstein, to approve the August 7, 2014 minutes as submitted. Motion passed.

Ms. Hanaway-Corrente indicated that the current board of the ASCE Vermont Section continues to support this position.

Ms. Norris, attending on behalf of the Vermont Society of Professional Engineers, voiced her support for increased educational requirements for licensure of civil engineers in Vermont.
