MINUTES**

1. The meeting was called to order at 9:12 a.m.

Members present: Daniel A. Coane, Chairperson; Robert E. Edwards, Secretary; Leo P. Blais, Vice-Chair; and Emma Pudvah and Nancy Stevens, Ad Hoc Members.

OPR Staff present: Christopher D. Winters, Board Counsel; Robert H. Backus, Prosecuting Attorney; Carla Preston, Unit Administrator and Patty Skinner, Administrative Assistant.

2. The Chair called for approval of the Minutes of the May 21<sup>st</sup> meeting. Mr. Edwards made a motion, seconded by Ms. Pudvah, to approve the Minutes of the May 21<sup>st</sup>, 2004 meeting as presented. Mr. Blais recused himself since he was not present at that meeting. Motion passed.

3. **Hearings /Stipulations**

- a. At 9:30 a.m. a hearing was scheduled in the matter of Jeffery Stewart who was preliminarily denied on February 20, 2004. This matter was tabled from the April 16<sup>th</sup> and May 21<sup>st</sup> meetings. Mr. Stewart did not attend the scheduled hearing nor did he provide the requested documentation. The Board believes that the applicant has had ample opportunity to provide the necessary documentation. Mr. Edwards made a motion, seconded by Ms. Pudvah, to affirm the Board's preliminary decision to deny Mr. Stewart for registration. Mr. Dwyer and his Attorney, Jon D. Valsangiacomo were present. Robert Edwards recused himself from this proceeding due to a business connection with the Respondent. The Board went into deliberative session at 1:58 p.m. and out at 2:54 p.m. A written decision will be issued.

The Board went into deliberative session at 3:32 p.m. and out at 3:41 p.m. Mr. Edwards made a motion, seconded by Mr. Blais, to accept the Stipulation and Consent Orders as presented. Motion passed. Chairman Coane, Investigating Member, did not participate in the vote.
