**TOWN OF BELVIDERE, VERMONT**  
**Town Meeting Minutes**  
**MARCH 6, 2018**

The Annual Town Meeting for the Town of Belvidere was held on March 6, 2018 at the Belvidere Central School. Mary Hysick, Moderator, called the meeting to order at 10:01 A.M. The body was invited to recite the Pledge of Allegiance.

**Article 1:** To elect a Moderator for Town Meeting. Mary Hysick was nominated by Thad Tallman and seconded by Deb Baker. A motion to cease nominations was made, seconded and approved. Mary was elected by voice vote. Mary introduced herself and the Rules for Meeting Order were given.

**Article 2:** To elect all other Town Officers required by law:

Town Clerk: Cathy Mander-Adams was nominated by Lyle Miller and seconded Josie McLean. There were no other nominations. Cathy was elected by voice vote. She was sworn in by Arlene Tallman.

Town Treasurer: Cathy Mander-Adams was nominated by Stacey Chase and seconded by Lyle Miller. There were no other nominations. Cathy was elected by voice vote.

By ballot, A Selectboard member for a term of 3 years: Ken Adams is the incumbent in this position and wishes to remain in the position if so moved by the body. Ken was nominated by Earl Domina, Jr. and seconded by Brent Jones. There were no further nominations and the clerk was asked to cast 1 ballot for the election of Ken Adams as Selectboard for a term of three years.

By ballot, a Lister for a term of 3 years: Stephanie Draper was nominated by Lyle Miller and seconded by William McLean. There were no further nominations and the clerk was asked to cast 1 ballot for the election of Stephanie Draper for the position of Lister for a term of three years.

By ballot, an Auditor for a term of 3 years: William McLean is the incumbent in this position and wishes to remain in the position if so moved by the body. William was nominated by Debora Baker and seconded by Lyle Miller. There were no further nominations and the clerk was asked to cast 1 ballot for the election of William McLean for the position of Auditor for a term of three years.

Road Commissioner: Frank Machia was nominated by Pam McKenna and seconded by Jon Hysick. No other nominations were heard. Frank Machia was elected by voice vote.

First Constable and, if needed, a Second Constable: William (Bill) McLean was nominated by Josie McLean and seconded by Brent Jones. There were no other nominations and Bill was elected by voice vote. The body decided a Second Constable was not necessary.

Collector of Delinquent Taxes: May Hysick was nominated by Brent Jones and seconded by . There were no nominations. Mary Hysick was elected by voice vote.

Grand Juror: Josie McLean was nominated by Pam McKenna and seconded by Josie McLean. There were no other nominations. Josie McLean was elected by voice vote.

Town Agent: Kevin Leavitt was nominated by Kathy Marchant and seconded by Carol Caldwell-Edmonds. There were no other nominations. Kevin was elected by voice vote.

Lamoille Regional Solid Waste District Director for a term of 2 years: Cathy Mander-Adams was nominated Lyle Miller and seconded by Jon Hysick. There were no other nominations. Cathy was elected by voice vote.

**Article 3:** To receive and act on the reports of the Town Officers and those presented. Pam McKenna moved the motion to accept the reports and Lyle Miller seconded the motion. Debora Baker, Auditor

noted corrections: Important correction on page 18 in the Town Report: Beginning balance, Warrants and Total Due are correct. The change is in the amount collected. The amount collected should read \$42,138.06. The Ending balance should now be \$22,469.05.

There was a typographical error on page 16 listed as Ed Taxes MUSD. The correct number should be \$381,482.70.

Page 3: Kathy Hobart's name appeared as Energy Coordinator in error. That position was vacant for 2017.

The reports were accepted by voice vote.

**Article 4:** To see what action the town will take in regard to the collection of taxes. Will the town vote to pay education taxes to the Treasurer on or before September 27, 2018, and pay town taxes to the Treasurer on or before November 15, 2018, and a rate of interest of 1% per month be charged on all overdue taxes beginning December 1, 2018?

Moved by Susan Schill and seconded by Lyle Miller. The date for the collection of Education Taxes was set by the Selectboard along with the date set for the collection of Town Taxes. This came to be due to the elimination of a School District Meeting. There is no School District Meeting now that Belvidere Central School budgets are set by the creation of the new Lamoille North Modified Unified Union School District.

**Article 5:** To fix the rate of compensation for Town Officers, if any.

Town Clerk & Town Treasurer: A motion was made by Pam McKenna, and seconded by Carol Caldwell-Edmonds, for the rates to remain the same as last year. There was an amendment made, and seconded, to raise the rate of pay for Town Clerk to be \$15.00 per hour. This would result in an increase of \$0.60 per hour. Discussion ensued. Ken Adams helped to explain the Selectboard's budget for the position of Town Clerk and Treasurer to be for 21 hours per week for 50 weeks at a rate of \$14.40. To increase the rate of pay for the Town Clerk would result in an increase to the budget. The amendment to the Town Clerk and Treasurer's raise in pay of \$.60 per hour for 21 hours a week for 50 weeks was approved. The increase amounts to \$630.00

Another question concerning the amount of money in the budget for the Town Clerk was explained by Ken Adams. The added money paid to the Town Clerk involves payment for elections. The Town Clerk is the Election Official for all elections held in town and there will be at least two elections this year; Primary and General.

The motion to maintain the 2017 rates of compensation for the Town Officers, with the amendment for the increase in the hourly rate for the Town Clerk & Treasurer, was approved by voice vote.

**Article 6:** Will the Town vote to expend the current revenues as proposed in the Selectboard's Budget to pay the debts and current expenses of the Town? A motion was made by Ken Adams and seconded by Pam McKenna, for the town to vote to expend the current revenues as proposed in the Selectboard's budget in the amount of \$176,377.00 to pay the debts and current expenses of the town with \$170,958.00 to be raised by 2018 Property Taxes and the 2017 Budget surplus amount of \$5419.00 to be applied to the total proposed amount for 2018.

Discussion pointed out that the increase in the rate of pay for the Town Clerk & Treasurer was not reflected in this budget total. The budget amount was amended to include the \$630.00 increase in the total budget. The new proposed 2018 total then became \$177,007.00 with \$171,588.00 to be raised by 2018 Property Taxes and the 2017 Budget surplus amount of \$5419.00 to be applied to the total proposed amount for 2018. The motion was approved by voice vote.



## MESSAGE FROM THE SELECT BOARD AND ROAD COMMISSIONER

On behalf of the residents of Belvidere, the Selectboard would like to thank Shirley Cox for her years of dedicated service as a town lister. Shirley decided to retire as a lister at the end of her term in 2018.

Last summer, the State of Vermont reconsidered the annual fee required by implementation of the "Municipal Roads General Permit", which is an element of Act 64, commonly known as the "clean water act". Originally the new law required every Vermont town to pay an annual fee of \$2000.00, as well as additional permit fees for each road project related to Act 64 compliance. The annual fee is now based on the size of each town, and in Belvidere's case this annual fee was reduced to approximately \$900, in addition to any specific project permit fees, which are about \$240 for each project. The Road Commissioner extends a thank you to Chris Slayton and Ken Adams Jr. for donating small amounts of labor as "in-kind" matching on the Better Roads projects, and to our Tree Warden, Kevin Leavitt, for removing downed trees on the town roads.

At the 2018 Town Meeting, the Selectboard received voter approval to use existing general funds to install electricity at the town gravel pit. Winter road maintenance sand is now hauled and spread directly from the town gravel pit. Also, the Road Commissioner stockpiled a supply of processed gravel for use on last summer's, and future, road projects. Using processed gravel instead of bank run gravel is a requirement of most grant funding. The Road Commissioner plans to process gravel and sand at the town pit as needed from year to year.

Last summer, the Road Commissioner installed caution signs on the Class 3 roads indicating neighborhoods that have families with young children, urging drivers to slow down and be extra cautious. Also, with much help from Rob Moore, transportation planner from LCPC, the Select Board has reached the final stage of posting speed limit signs on the Class 3 town roads. Rob and LCPC performed traffic studies and vehicle counts on areas of excessive speeding by travelers using the town roads with all kinds of vehicles, including ATV's. The Select Board has included \$1000 in the proposed budget for purchasing these signs.

The Selectboard is still investigating grant opportunities to fund an engineering study on the Basin Bridge to determine its structural integrity. The Selectboard is researching the availability of grants to fund preservation of the records at the town clerk's office. The oldest volumes of our record books are very fragile and are easily damaged when removed from the vault for research, and the integrity of these town records should be maintained.

The Belvidere Planning Commission continued efforts to prepare a Town Plan revision for the 2020 deadline. After receiving public comment, and after much debate among its members, the Planning Commission recommended the wetlands in the Belvidere Bog area remain a Class II wetland. This recommendation was in response to the desire of the Vermont Agency of Natural Resources to upgrade the wetlands to a Class I. The Select Board would also like to thank Jack Schill, who decided to leave the Belvidere Planning Commission early in 2018, for his many years of service.

## The New Vital Records Law (Act 46) and What It Means for You

The Vermont Legislature passed Act 46 in May 2017, which significantly changes the state laws that govern vital records –namely, birth and death certificates. The new law and rules will enhance the safety and security of birth and death certificates, provide better protection against misuse of these legal documents, and reduce the potential for identity theft. Additionally, the changes streamline the entire statewide system for creation, storage and tracking of birth and death certificates. Act 46 will impact anyone who seeks a copy of a Vermont birth or death certificate. **The changes go into effect on July 1, 2019.**

The most notable changes are:

- Only family members (as defined in Act 46), legal guardians, certain court-appointed parties or legal representatives of any of these parties can apply to obtain a certified copy of a birth or death certificate. In the case of a death certificate only, the funeral home or crematorium handling disposition may apply for a certified copy.
- An individual must complete an application and show valid identification when applying for a certified copy of a birth or death certificate.
- An individual who refuses to complete the application or cannot provide valid identification will be ineligible and referred to the Vital Records Office.
- Certified copies of birth and death certificates can be ordered from any town, not just where the birth or death occurred or where the person was a resident.
- Certified copies will be issued on anti-fraud paper.
- Access to noncertified copies (previously called “informational” copies) is not significantly changed by the new law or rules.
- Marriage, civil union, divorce or dissolution certificate copies and processes are not affected by the new law or rules.
