Joan:

Thanks for taking time to catch up last week. As I mentioned on the phone it looks like we have a resolution on the river buffer matter at Long Trail. In summary, we are going to plant 75 – 6', 2" caliper maples and an additional 60 plus trees along the river buffer area that has been coordinated and reviewed between the State and our civil engineer. There will be a split rail fence as well to protect the area.

We need to now memorialize this and make it part of the official AOD which we will have counsel submit for formal sign off.

While Pat Moulton and Trey Martin have left their positions, the resolution would not have been possible without the tremendous support by you and your colleagues at the Agency of Commerce and

Economic Development. You were really tremendous at standing by our desire to get to a solution while respecting the environmental integrity that is so important to our state and the Vermont brand.

There is a lot of cynicism about how broken government is these days. But please know we are very grateful to you and the Agency of Commerce, the Agency of Agriculture and Governor's office for making this a win-win.
