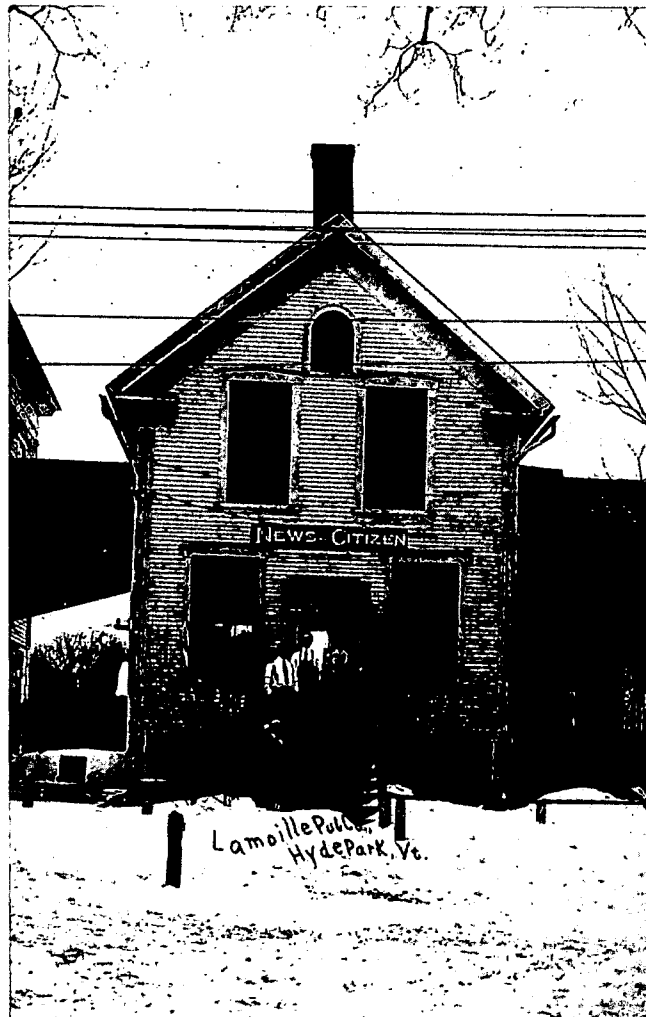

## DEDICATION

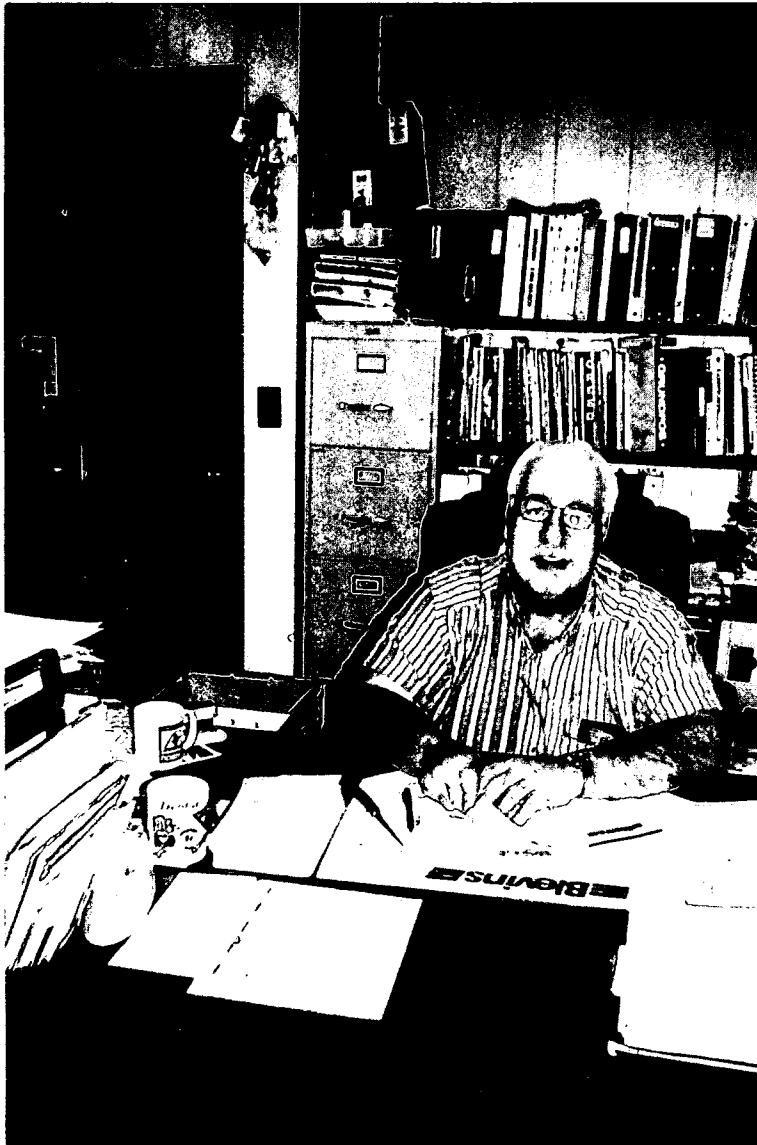


This year the Town Report of Hyde Park is dedicated to the employees of the Highway Department in recognition of their dedication to their jobs and to the residents of Hyde Park.

## SELECTBOARD REPORT

Last year's report commented about the lack of significant snow and above average temperatures. Through the end of January this year those previous comments have no relevance. The Highway Department's sand pile has certainly taken a beating thus far as well as the demand for salt. Again, this year we would like to mention the great effort by our highway crew. They work long hours in adverse conditions keeping our roads clear and safe for the rest of us.

A new bridge is planned over the Centerville Brook on the Silver Ridge Road for this summer. We received a grant from FEMA (Federal Emergency Management) and one from AOT (Agency of Transportation) with 10% of the cost being paid for by the Town. After getting price quotes for construction we found ourselves with a funding shortfall of over \$25,000.00. With the help of Senator Bartlett contacting AOT, we were able to secure the additional money needed to move this project to construction. Thank you Susan!

Over the past two years we have been using Sta-mat on the hills and more difficult areas of town roads. We have found this application to work very well. With the cost of paving a mile of road being nearly \$50,000.00 it has become prohibitive to transform any more graveled roads to pavement. By using Sta-mat it appears we can improve our graveled road surfaces for about one-third the cost of pavement.

The Town Clerk's Office received a fresh coat of paint this past summer, in addition to insulation, and a new-shingled roof. The shingles were over thirty years old and in need of replacement. Also, because of the Town's growth, we will need to evaluate our need for space at the Town and Village offices. We will keep you posted.

The library addition has been progressing slowly due to lack of donated funds. The inside design has been altered without sacrificing functionality to help lower the overall cost of construction. Thus far all money spent has been received through fund raising, grants and donations. By early spring we will have a better idea of what it will take to finish the project. At that time depending on what funding we have will determine if the voters will be asked to approve some financing to complete the project.

A few years ago we reconstructed 80% of the Town Garage by tearing down a large part of the existing building and adding some additional work areas. The remaining part of the original garage needs a new roof and rafters. We have budgeted \$8,000.00 to have this work done in the coming summer months.

Over the past few years we have included under "anticipated income" the amount of money the town would receive from delinquent taxes in the coming budget year. This amount of money is deducted from the proposed town budget each year at Town Meeting and then the voters are given the amount to be raised from taxes. Well, we shouldn't have done this. The money received from delinquent taxes should have been used to pay down our working line of credit. Delinquent tax money has already been spent, but when not collected, we borrow to cover those amounts. You cannot spend it in this year's budget; then lower next year's tax rate when the money is collected. As a result our line of credit has been slowly increasing, not zeroing out

each year. We have budgeted this account back in balance over the next couple of years as well as adjusted our anticipated revenue estimate, not to include delinquent taxes.

The listers are working to have the town reappraisal within the next few years. Appraisers are booked way ahead due to the demand statewide. Many properties in town are selling for much more than we have them listed for. A new appraisal is required when lister values drop below 80%. The new appraisal brings equity among property owners and keeps us in compliance with the State.

At last year's meeting we discussed our change in ambulance service to Northern Emergency Medical Service, which is a division of Newport Ambulance. The cost of this service to the five towns has been reduced by approximately \$13,000 in this proposed budget. Hyde Park's share of this reduction is slightly over \$4,000. Although not a major decrease we still are confident with our five-year plan of reducing the cost to the five Towns to approximately \$75,000. This budget was put together in November so it by contract could be finalized by the end of December in time for the town report. This only gave us four months of history with the new service yet in that short time we still were able to reduce the cost to the Towns.

Also last year we approved a motion to amend our Act 250 permit for the town property in Garfield to allow recreational use. Due to that, in July of this past year we established a new recreational committee. (Please see their report).

One of the major issues we faced this past year was the loss of our insurance carrier, Legion Insurance, who went out of business. We obtained coverage through the Vermont League of Cities and Towns. Although, like most, we are still experiencing increases in our premiums, we feel that these increases have been kept to a minimum by this change.

Also this past year through the very hard work of our planning commission the first public meetings introducing changes to our zoning bylaws were held. We have warned a public hearing on those changes for March 24th. Your comments on the purposed changes will be very much appreciated. Copies of the new proposed bylaws may be obtained through the Town Clerk's office.

In conclusion, we would like to thank the many volunteers who donate their time to our town in many capacities. Please note their names throughout this report. These are the people who allow Hyde Park to be such a wonderful community! We would like to thank two who are not mentioned, Anne Worth and Janet Gibbons. We all enjoy the beauty of their toils when viewing the flower gardens at the intersection of Routes 15 and 100. We ask that you assist them by refraining from placing signs in the gardens as well as slowing down when they are working in the gardens. Additionally, we thank our town employees for all their efforts and the residents of Hyde Park for their support this past year.

The legal voters of the Town of Hyde Park are hereby warned and notified to meet at the Hyde Park Elementary School Gymnasium in the Town of Hyde Park on Tuesday, March 2, 2004 at 9:00 o'clock in the forenoon, to act on the following articles of business.

Article 1. To elect Town and School District Officers as required by 17 V.S.A. – 2646, to wit:

Selectboard Member for a term of two years

Auditor for a term of three years  
School Director for a term of two years  
School Director for a term of three years

## WARNING FOR THE ANNUAL SCHOOL DISTRICT MEETING OF THE TOWN SCHOOL DISTRICT OF HYDE PARK

The inhabitants of the Town of Hyde Park who are legal voters in the Town School District of Hyde Park are hereby notified and warned to meet in the Town School District meeting in the Hyde Park Elementary School Gymnasium in said Hyde Park on Tuesday, March 2, 2004, said meeting to be held immediately following the annual meeting of the Town of Hyde Park at 9:00 AM to act on the following articles of business:

- Article 1. To elect a moderator by ballot for the ensuing year.
- Article 2. To adopt rules of order for the transaction of business in Town School District meeting.
- Article 3. To receive and act upon reports of the School Directors as presented.
- Article 4. Will the Town School District vote to pay its School Directors for the ensuing year; and if so, determine the amount.
- Article 5. Will the Town School District authorize the School Directors to borrow money to pay current expenses and the debts of the District in anticipation of collection of taxes?
- Article 6. To receive from the School Directors their estimate of expenses for the Hyde Park Elementary School for the ensuing year, and to appropriate such sum, \$2,466,347 together with the amount required to pay the assessment for the Lamoille Union High School and Green Mountain Technology Center Students as passed by the District by Australian Ballot.
- Article 7. Shall the voters of the Hyde Park School District authorize renovations and repairs to the Hyde Park Elementary School estimated to cost Three Hundred Ninety-Eight Thousand Nine Hundred Eighteen Dollars (\$398,918)? Said repairs may include replacement of the roof of the 51 wing, playground drainage improvements, window replacement, sprinkler installation, elevator installation, interior improvements to gym soundproofing/insulation, space utilization in the LCA building and fire safety and security improvements. The payment by the Hyde Park School District for said renovations and repairs is subject to reduction from available state construction grants in-aid; and by use of the district's construction reserve fund if directed by the voters.

## **LAMOILLE COUNTY SHERIFF'S DEPARTMENT 2003 ANNUAL REPORT**

The Lamoille County Sheriff's Department provides twenty-four hour patrol service on a contract basis to the Towns of Hyde Park, Johnson and Wolcott. Our agency also provides assistance to other local, state and federal law enforcement and emergency response agencies.

The Department's Communications Center dispatches the appropriate agency to all emergency calls throughout the ten towns in Lamoille County. Dispatchers handled a total of 11076 calls for police service, 2065 calls for EMS service, and 742 calls for fire service, a 19% increase in total call volume over 2002. The Center is also the Public Safety Answering Point for all the Enhanced 911 calls throughout Lamoille County. Personnel are trained in answering 911 calls and providing pre-arrival instruction for police, fire and medical emergencies. Personnel receive emphasized training in assisting callers in medical emergencies.

Grant funding applied for and received in 2003 included Special DUI Patrol funding, START (Stop Teenage Alcohol Risk Team) funding, Snowmobile Law Enforcement, Seat Belt Enforcement, Homeland Security Equipment funding, U.S. Department of Justice Universal Hiring Grant, School Resource Officer, Community Heroin Interdiction Program, and Local Law Enforcement Block Grant receipts. This funding allowed the department to participate in a variety of activities that would not have been possible with the current level of contract funding.

The Seat Belt Grant enabled the department to dedicate one part-time deputy to enforcing the Vermont Traffic Laws. Training goals for the position include child car seat occupant safety and the inspection of child safety seats to assure proper installation for the child's safety. Town's people are encouraged to make an appointment to have their child's safety seat inspected. The Lamoille County Sheriff's Department also provides child safety seats to those people who are in need at a minimal cost.

A grant secured in 2002 from the U.S. Department of Justice allowed the department to place a School Resource Officer within the Lamoille North Supervisory Union. The goal of the program is to create a safe and secure environment in area schools. The School Resource Officer is currently working in partnership with students, parents, teachers, town, county and state officials to establish a rapport with students as well as to act as a resource to the school, the SRO provides presentations related to substance abuse, violence prevention, conflict management and safety. To date the program has been very successful in achieving it's goals.

The department continues to work with other county, state and federal law enforcement agencies in narcotics investigations. This has resulted in several federal and state level arrests this year. The Lamoille County Sheriff's Department is committed to an on going effort that will result in the reduction of the demand for drugs in our area. The Department has secured a grant from the state to specifically interdict heroin and the diversion of prescription medicine.

The department further received authorization to spend \$120,000.00 from federal grant money to enhance radio coverage for Emergency Services in the following areas: Stowe-Mt Mansfield, Jeffersonville, Waterville, Morrisville, Wolcott and Elmore. The department is currently awaiting the radio licensing for these locations.

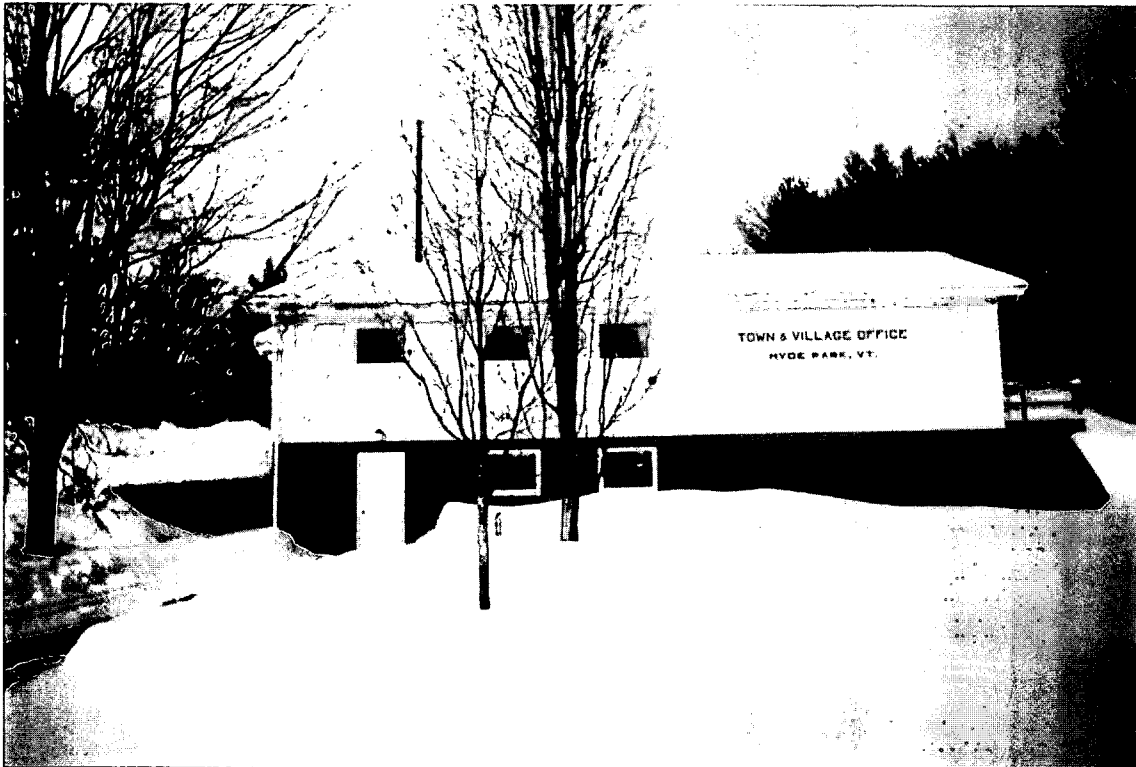

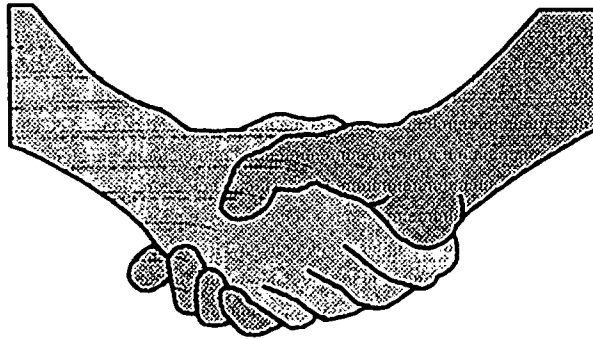

For the period of July 1, 2002 through June 30, 2003 the Hyde Park Town Fire Department responded to 74 calls, and the Fire Department Fast Squad responded to 92 calls, for a total of 166 calls for assistance answered by the Department. The calls were as follows:

During this time period, members of the Department completed the Vermont Fire Service Fire Fighter Level 1 training. To date 14 members have completed all the training and testing requirements, a total of 133 hours, and have been certified by Vermont Fire Service Training as Fire Fighters Level 1. This is the same certification as required by law for career fire fighters.

When you review our year's expenses you will see that we went over our budget projection in Truck Maintenance. This was due to the fact that we had a pump bearing go bad in our Engine 1. Total cost for this one repair was \$3,545.79.

As always, the Department is looking for people who would be interested in serving the Town by joining either the Fire Department, Fast Squad or both. The Department needs dedicated people so that it can properly service all calls it receives.

### **FIRE PERMITS**

Fire Permits in the Town of Hyde Park may be obtained at the Town Clerk's Office, Monday through Friday, between the hours of 8:00AM and 4:00PM. Fire Permits will not be issued on weekends. If you want to burn on Saturday or Sunday, you need to obtain your permit prior to the weekend. Also, permits will not be issued for more than three consecutive days.

REMEMBER, the person setting a fire must have a written permit in their possession! If they do not, they may receive a "Vermont Fire Prevention Ticket," which results in court action and a fine. They are also subject to any costs involved in putting a fire out by the Fire Department. ALL fires must be attended until they are out. Fire Permits are not required if there is snow on the site.

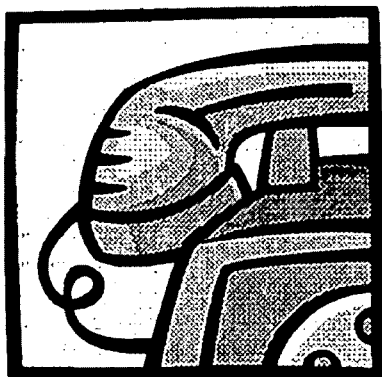

Dear Boards and Citizens,

We would first like to thank you for allowing us to serve you. We are both excited and proud of the work we are performing in your communities. We have a lot remaining to do in establishing the service and making it sound. We envision, with your support, that we will be where we initially proposed in our five-year plan.

The NEMS staff has worked hard and has met every challenge put forth to them. We are very pleased and proud of the staff that has come together at our Johnson facility. They are presently offering both First Aid and CPR classes to the public for a nominal charge. Our community work such as the Healthy Homes Program is free of charge to all. Our staff will come to your home or group and provide you with material about radon and lead paint in your homes.

As of December 31<sup>st</sup> we had responded to a total of 563 calls with 258 of these being emergency calls. Our average response time was 4.95 minutes with an average on-scene time of 6.68 minutes.

In looking toward the future our most pressing need is that of a facility. The present location is for sale and if purchased would require much work and expense. Because we are looking at this as an indefinite contract, we need to consider our own facility.

The Board of Directors and the Oversight Board have worked to keep the budget on target and our crews are working to stay within the budget. As with any start up company we have experienced growing pains and we continue to make the changes necessary to relieve those pains. In the last few months many of the local EMT's have signed on with us, which aids our efforts in becoming a community-based service.

## BOARD OF LISTERS REPORT

The real estate market continues to be very strong and property values are continuing to rise at a very fast pace. This has created a large disparity in our assessed values of properties compared to the selling price of these properties. Our common level of appraisal (CLA) was 83% last year and it is now at 77%. This means that currently 77% of property owners are paying their fair share of tax. Vermont law requires that once a CLA falls below 80%, the town is forced to reappraise all of the properties. We were expecting to conduct a partial reappraisal this coming July but after careful consideration and review, the Selectboard and the Listers came to the conclusion that the Town of Hyde Park will need a complete reappraisal in order to be fair and equitable to all property owners. This reappraisal will hopefully begin in 2005.

There have also been changes to ACT 60 (now referred to as ACT 68). One of the major changes has been the requirement that ALL resident Vermont homeowners complete the new DECLARATION OF VERMONT HOMESTEAD FORM HS-131. This declaration determines which school property tax rate is applied to your property. You must file the declaration in order to receive the correct rate. Please file no later than April 15, 2004.

## **DEVELOPMENT REVIEW BOARD 2003 ANNUAL REPORT**

The Town of Hyde Park saw an increase in steady growth in 2003 with many projects requiring Development Review Board approval. The Board conducted fifteen public hearings/site reviews; thirteen of which were in town and two in the village. The Board also conducted seasonal periodic permit reviews and assisted the Administrative Officer with permit enforcement.

Commercial development of note included the continued expansion of the Casella Waste Management facilities, Mathieu Enterprises Bus Depot and an access bridge over the Green River.

The Board recognized the resignation of long-time member Eric Aither, and thanked him for his many years of service. Mr. Aither resigned in order to begin training for the position of Chief for the North Hyde Park/Eden Fire Department. The Board wishes him well in his new position.

Development Review Board hearings are held at 7:00 PM, the first Tuesday of each month, and are open to the public.

## **PLANNING COMMISSION 2003 ANNUAL REPORT**

The Planning Commission had an active and productive year in 2003. The Commission completed a comprehensive revision to the Town Zoning Bylaws originally enacted in 1988. The Commission contracted with Lamoille County Planning Commission for the drafting of bylaw amendments. Funding for this process was obtained through a \$5,000 grant from the Vermont Department of Housing and Community Affairs.

The Planning Commission also received a \$5,000 grant from VDHCA for the development of subdivision regulations. The Commission began drafting language in late fall. Preliminary draft subdivision regulations are anticipated for public review in the spring of 2004. A third VDHCA planning grant was applied for and awarded in the amount of \$4,000 for an update to the Town Plan. Work will commence on this project upon completion of the subdivision regulations.

The newly created Industrial/Commercial District in North Hyde Park was chosen by Leslie Elisabeth, Inc. as a site for their specialty foods processing business. Construction of their facility, as the first tenants in the district, was completed in 2003. Leslie Elisabeth, Inc. anticipates employing twenty people.

The Commission wishes to recognize the resignation of Russell Lanphear and Frank Kneeland, and to thank them for their dedication to the board.

Planning Commission meetings are held at 7:00 PM, the first and third Wednesday of each month. The public is encouraged to attend.

## **Hyde Park Recreation Fields Committee 2003 Annual Report**

The Hyde Park Recreation Fields Committee is a group of citizens interested in fostering recreational activities and opportunities in Hyde Park. The group meets at 7:00 PM, the third Thursday of each month at the Municipal Office. The group focuses on project development, fundraising and grant writing.

The Committee's first project is the development of recreational fields for baseball, softball and soccer. The fields will include a walking trail and playground. Seasonal use will include cross-country skiing and snowshoeing. A restroom/concession stand/storage facility is also planned. After careful consideration, the Town has determined that dogs will not be allowed on the recreation fields.

The fields will be located on six acres of land adjoining the Town of Hyde Park Emerson Gravel Pit off McFarlane Road. Preliminary site work has been conducted including brush hogging, topsoil stripping and some leveling.

An engineered site plan has been developed for the project and Act 250 approval obtained. The Committee participated in the Hyde Park Home Days Community Auction in September and raised \$731. Some of the auction proceeds were used to purchase used playground equipment from the Town of Morristown. In October, committee members relocated this equipment from its existing site to the Hyde Park fields.

The Committee also drafted Policy and Procedures, which the Selectboard adopted at their December meeting.

Committee meetings are open to the public, and all are welcome to attend.

## DOG LICENSE INFORMATION

During the 2003 license year the Town of Hyde Park issued 593 dog licenses. In 2002 there were 564 licensed dogs.

All dogs or wolf-hybrids six months of age and older must be licensed annually on or before the first day of April. Before obtaining a dog license, a copy of a current rabies vaccination certificate must be presented to the Town.

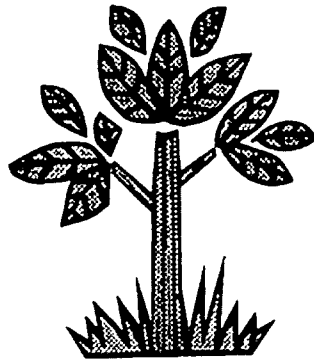

## HYDE PARK SCHOOL DIRECTORS REPORT

2003 has proven to be another terrific year at Hyde Park Elementary School. All of the initiatives planned for the year are in place and yielding positive results. We receive continuing good news in assessment results, our children are doing well in academic and sport activities, our programs and curriculum continue to grow to meet the needs of our children. Volunteers and community members are increasingly present in our school. Development opportunities for parents, visitors, staff and board members help us continue to improve the school for the children of Hyde Park. The board is committed to continuing with our strong, community based action planning that is working to fulfill our mission.

All-day kindergarten is proving to be extremely popular with children, parents and teachers. The expanded day allows our youngest children to get a real head start on social and academic skills. The kids are eager and parents have commented positively on the program.

Our guided reading initiative is fully implemented and the reports are positive in this area. Teachers and children continue to learn and grow with this program. Assessment results indicate that the consistency of Mathland is helping our students achieve the Vermont Standards. Consistent discipline response and training for staff is in place. Our technology initiative is increasing children's learning activities and opportunities throughout the school.

In addition, we have worked with the LNSU board to strengthen elementary to high school ties. New programs, educational opportunities in the high school and safe schools initiatives reach all grade levels in the district. Drop out rates in the high school are improving and programming continues to expand for all children in Lamoille County.

Volunteers and parents support active sports and after school programs, our teams in sports and academic competitions are successful. Our mentoring program is expanding and after school study programs enhance the learning opportunities for our children.

The board communicates regularly with Activity coordinators and supports the volunteer programs that run Sports for Life and have made the wonderful upgrades to our small playground.

Our newsletter brings the board in contact with many community members and helps keep you up to date on many of the current programs, activities, successes and concerns.

At the same time many external pressures continue to impact how we as a community provide education. These pressures range from mandated curriculum and spending requirements to school choice and expanding safety regulatory oversight. The board is constantly monitoring the environment to be certain that Hyde Park is well established and prepared to face changes in a thoughtful and positive manner. We are implementing new requirements from both Federal and State Laws passed within the last several years. We are studying current political, social and economic data and incorporating our findings into planning, budgeting and even facilities management. We as a board look forward to the challenges that some changes may bring knowing that the ongoing support of the community means that Hyde Park Elementary School really is "A good place to be."

## Hyde Park Elementary School Principal's Report

I am pleased to report that Hyde Park Elementary School continues to make positive strides toward becoming a school where all children learn well and meet rigorous academic standards. By focusing on its community developed action plan, many enhancements and changes have taken place in the past year.

The main school goals were:

- To improve student performance in reading and writing.
- To improve mathematics learning in the areas of computation, concepts, and problem solving.
- To ensure the appropriate integration of technology in the school.

Regarding the first two goals, we have implemented a comprehensive literacy program and enhanced our current mathematics program with the help of a \$250,000 Federal grant. In this implementation, teacher instruction was made more consistent across the grades, teachers and staff were thoroughly trained, books and equipment were purchased, and ongoing teacher collaboration time was built in the schedule. Through the use of locally delivered reading assessments, we now can track student progress more reliably and are more responsive to student needs. We are very hopeful that our state assessments will continue to indicate positive growth.

In last year's report, I described how our computer system ensures filtered Internet access and a productivity software access for all students and staff. This system continues to be a success as increased numbers of students and staff are taking advantage of the technology. Just to give you a perspective, four years ago the school had virtually no Internet access and very unreliable computers. Today, there are 110 computers in the school that can access the Internet through a high speed connection and all of the machines have the latest Microsoft productivity software. It remains our goal to have all students move to the middle school able to word process, use spread sheets, create multimedia presentations, and appropriately use the Internet to expand their learning.

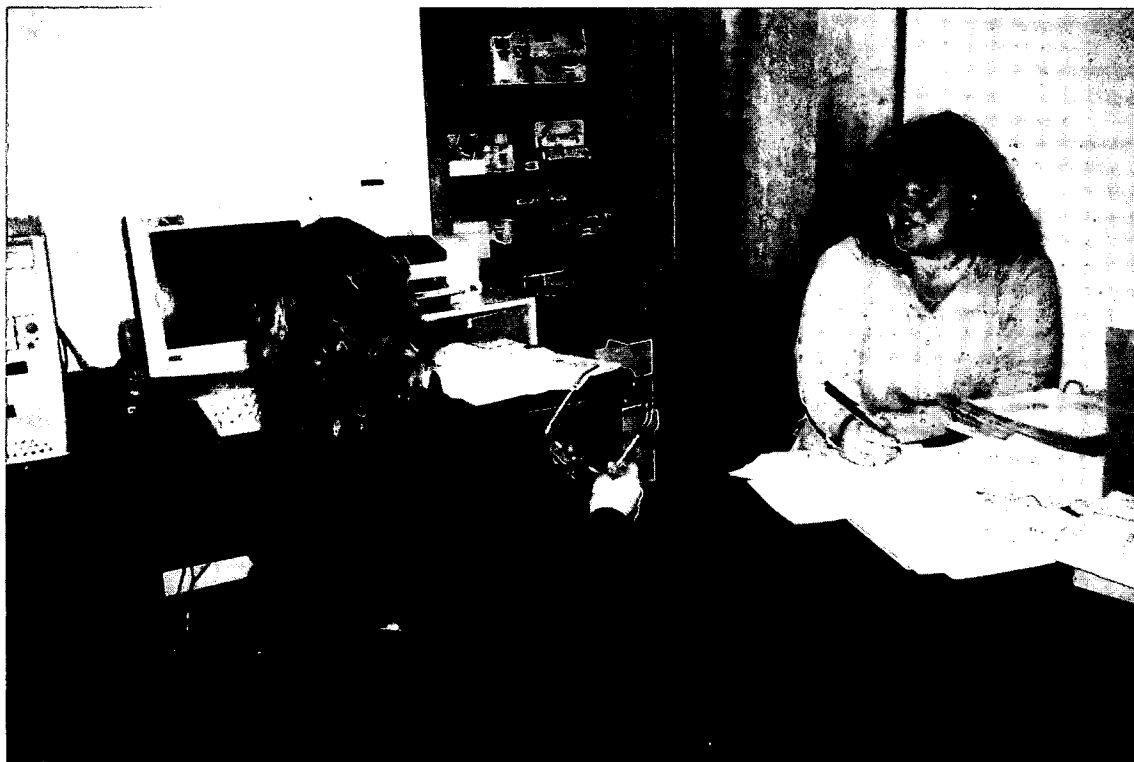
For the years to come, we have more ambition. We want to foster parent/community communication, implement an ongoing equipment replacement and routine maintenance plan, improve academic achievement in the areas of mathematics and literacy, and ensure that each student has the benefit of a comprehensive educational support system. We will do this by implementing our action plan that was created through the input of parents, community members, teachers, and board members. In terms of the overall atmosphere, we continue to look for new ways to improve the number of high quality experiences for all kids. Some of the activities include the First Day celebration, the Ghost Walk, the Sports for Life program, music concerts, sports teams, the spelling team, the after-school reading and math program, field trips, and our homework club. Parents and volunteers are keys to making all of these things happen as they volunteer their time and skills. We have over 50 volunteers working with the school throughout the year.

Clearly, we are proud and excited about what we are doing. As a group we are thankful for your support and look forward to creating an enriching experience for all kids. Hyde Park Elementary School is committed to you and your children. I feel blessed to be your principal and look forward to helping the teachers and staff make the school a better place to be.

## Hyde Park School District Act 68 - FY'04 Budget Restatement

Last spring, the Vermont Legislature adopted Act 68 as a replacement to Act 60. This Act provides state funding for education. It also includes new budget comparison requirements and also changes the way school districts are required to report the value of the vocational services its students receive.

There are no longer the General State Support Grant or Local Share Funding revenue line items. Act 68 replaces these line items with a new line item called *State Education Aid*.

Under Act 144, the State sent funds on behalf of school districts directly to Technical Education Centers. However, school districts were instructed by the State not to include the value of the Tech Center payments in district budgets. Act 68 now requires that the Tech Center payments be included in school district budgets.

Since these payments were not included in the FY'04 budget but now appear in the FY'05 budget, voter confusion may occur when comparing one budget year to the next. In an attempt to minimize that confusion, the Board has chosen to restate the FY'04 budget in the Town Report to include the Tech Center payments made by the State on behalf of the Town. The following charts summarize the restatement.

## REPORTS FROM ORGANIZATIONS

Clarina Howard Nichols Center is a shelter for battered women and their children. Their mission is to end violence against women and their children by providing shelter and services to survivors of domestic and/or sexual assault, and through preventive, outreach education programs. It also provides a 24 hour Hotline, rape crisis intervention, childcare, advocacy in legal, welfare, medical and housing issues, support groups, a children's program, cooperation with the local police, and a community outreach and education program. 888-2584 (Business) 888-5256 (Hotline)

Central Vermont Adult Basic Education, Inc. offers free, one-to-one tutoring and small group instruction for adults over 16 years old with less than 12 years of education. Volunteers teach basic reading, math, ESL (English as a second language), GED (High School Equivalency), ADP (Adult Diploma Program), and CDL (Commercial Driver License) preparation to adults. Last year eighteen Hyde Park residents were served by CVABE. 888-5531

Lamoille County Planning Commission provides technical assistance to municipalities in Lamoille County for land use planning and community development programs. Appointed representatives from each town and village in Lamoille County govern LCPC. 888-4548

Lamoille Family Center is a community based, private, non-profit resource center providing services and resources with support parents in raising children who are healthy and happy. Workshops, home based services, playgroups and preschool programs, support and study groups, emergency help, employment and educational planning, child care resources and referral and specialized resources for teens and their families are among the services the Family Center staff provide. 888-5229

Rural Community Transportation provides transportation to area meal sites, medical appointments and various other places for the elderly, handicapped and disabled through a volunteer service. There were 113 Hyde Park residents served by RCT this past year. Call to see if you may be eligible for transportation. 748-8170

Lamoille County Court Diversion & Restorative Justice Programs, Inc. is a community based, non-profit organization which offers a number of programs that focus on the needs of youth and families involved in delinquent or criminal activities at the pre-adjudication and post-adjudication levels. 888-5871

Central Vermont Community Action Council serves low-income residents of Lamoille County. Its programs and services are designed to help families work toward better lives and to improve the overall quality of life in their communities. CVCAC worked with households through Head Start/Early Head Start, Child Care Food Program, Community Economic Development programs, Family/Community Support Services, Welfare to Work programming, Weatherization assistance, Crisis Fuel resources, and Community Action Motors. CVCAC helped 225 individuals in 87 Hyde Park families with

emergency assistance and comprehensive program services designed to teach important skills and help people access the resources they need to build better futures. 479-1053

Lamoille Economic Development Corporation's primary mission is to assist business growth in Lamoille County. LEDC offers businesses and individuals a wide range of services from developing business plans to security financing. LEDC supported financing and construction for the Lesley Elizabeth Company in North Hyde Park. 888-5640.

Retired and Senior Volunteer Program - In the past 12 months 1,219 RSVP volunteers have donated over 107,689 hours of their time to 159 organizations. Costs for this program include travel expenses, insurance, training, recognition and coordination time. 888-2190.

Central Vermont Council on Aging works to support Central Vermont elders to remain independent as long as possible in their own homes and communities. Services provided include Case Management/Advocacy, Information and Referral, Community and Home Delivered Meals, Senior Center services, Transportation and volunteer opportunities for people of all ages. A total of 56 Hyde Park residents received services from CVCOA in the past fiscal year. 888-2504

Out & About, Lamoille Area Adult Day Care Center is a program supporting elders who are socially isolated and/or functionally impaired and adults with disabilities through activities and services that promote independence. Services may include the following: supervision, transportation, meals, personal care, nursing services, socialization, exercise, recreation, discussion groups, art workshops (writing, music/singing, drawing, painting sculpture), information and referrals, medical and social evaluation, counseling, reality orientation, and care giver respite and support. 888-7045.

Lamoille Home Health & Hospice provides home health care services including nursing, aide, physical therapy, occupational therapy, speech therapy, social work, companion, and homemaking. 888-4651.

North Country Animal League provides services to find homes for animals surrendered for adoption or turned over as strays. Another major service is education on animal care and responsible pet ownership. This is done through education for school children on animal care. Cruelty cases are also investigated. 888-5065

Lamoille Housing Partnership helps ensure that families with incomes below the Lamoille County average have safe, decent, affordable housing. - Art 10 Voted \$2,000 to help with the restoration / construction of sidewalks within Hyde Park Village.
