**House Bills Introduced & Read First Time:**

COMMITTEE INTEL:

House Healthcare committee took testimony regarding H.524, an act relating to seeking a waiver to permit businesses to continue to purchase Exchange plans directly from insurers. The legislation would

authorize DVHA to request a State Innovation (ACA Section 1332) Waiver from the ACA's requirement to establish a website-based small business exchange (also known as Small Business Health Options Program or SHOP). The waiver would permit qualified employers to continue to purchase VHC qualified health benefit plans directly from QHP issuers - as they do now under the temporary transitional flexibility granted to DVHA by CMS. Both committee and witnesses were supportive of waiver approach. Some discussion of changing the bill language to more explicitly limit waiver scope.
