Hi Michael,

In general we're ready, willing and able to help our neighbors. There is much to be determined yet, like what help will be needed, what will we be dealing with here at home, and what resources do we have available to share at the time help is requested.

In the past we have sent help to other states, and the best and easiest vehicle to use for that is the EMAC process which we used to receive help during Irene. I'm not sure if you're familiar with EMAC or not, but if you have questions please let me know. The key is that the help has to be requested before we know what is needed.

I have reached out to some of my NE counterparts in the Maintenance world, and we are in touch. I have not talked to my counterpart in CT yet, as I know how busy he is and sometimes too many calls can be overwhelming. That's part of the reason it's best for all those types of requests and communications regarding aid to go through VEM.

In addition, I can really only speak to transportation related aid. I know there are other types of aid that VEM could provide if requested (national guard, chainsaw crews from ANR, etc)

I'm copying Joe Flynn in case he wants to add anything, but bottom line is VEM is the clearing house for getting aid (through EMAC) to other states. And VTrans is standing by to help if we're called on.
