3. Approval of previous minutes:

Mr. Carpenter made a motion to approve the minutes for the **August 25th, 2021 meeting** as provided. Mr. Carroll seconded the motion, motion approved.

5. Topics for discussion:

- **Quarterly Inspection Report:**

- Mr. Everett presented OPR's quarterly inspection findings to the Board.
 - Of note, there have been several sudden, temporary closures of pharmacies due to inability to staff them with a pharmacist. Some have been operating without a designated pharmacy manager, with only "floating" pharmacists
 - The Board asked Ms. Phillips to send out another email to pharmacies reminding the license holders of required notifications to the Board and to patients when such an event occurs

- **Executive Officer Report:**

- Ms. Phillips presented to the board her Executive Officer report and the recent pharmacy license approvals.

- **State Protocols for Clinical Pharmacy Prescribing:**
 - Initial drafts of the protocols for Emergency Prescribing of Albuterol or Glucagon While Contemporaneously Contacting Emergency Services and Epinephrine Auto-injectors were reviewed
 - A typo was noted by Mr. Carroll, no other comments were made on content; representatives from the Vermont Pharmacist Association and Vermont Medical Society appreciate an opportunity to share with membership. Final review of these protocols will occur at the 11/3/21 meeting.
- **MPJE Discussion:**
 - Mr. Gilman suggested to the Board that they review the Dental Board's jurisprudence exam as a possible replacement for the current MPJE. The Board will review it, and other information, at next scheduled meeting
 - Mr. Chatoff is seeking public comment upon the topic of possibly eliminating the requirement of the MPJE for pharmacist licensure during the next meeting

 - Ms. Philips reviewed the recently posted USP <797> revision.
