As discussed this morning, we are hearing consistent feedback from child care providers when they call their local ID centers that no appointments are available until a much later date. Providers are very anxious about impending deadlines and we are hearing they are being met with less than helpful responses as well.

The specific counties that have been mentioned are as follows:

Washington County Sheriff's Dept. (no appointments until end of September); 223-3001

Lamoille Sheriff's Dept. (no appointments until end of August); 888-2561

Chittenden County Sheriff's Dept. (not answering phone and the voicemail states not to leave a message for fingerprinting); 863-7507

Addison County Sheriff's Dept. (full until Aug 30<sup>th</sup>); 388-2981

and Hartford Police Dept. for Windsor County (very limited hours per week and not flexible) 295-9425

Any assistance in persuading these folks to expand their hours would be greatly appreciated. Thanks again.
