Sen. Snelling,

Darren asked me to send you the amount of funds the CEDF has received and how much of that \$ has been awarded in support of photovoltaics (PV) over the last 5 years ('09 to '14). I've compiled the table below to provide the that information.

Of the \$50.6 million that the CEDF has received over the last 5 years just \$3.3 million has come from the General Fund (*the CEDF also received ~\$1 Million from a settlement with American Electric Power that the AG had secured*). \$3M was conditionally appropriated in FY '13. The CEDF was only to receive that \$3M if economic conditions were met, which I believe were related to whether or not Entergy was going to pay the increased property tax imposed on the plant that year. The economic conditions were met and the CEDF did receive that \$3M in the 4<sup>th</sup> quarter of FY '13. In FY '14 there was an appropriation of ~\$250K. The balance of the funds received came from ARRA (\$21.9M) and Entergy Vermont Yankee (\$24.3M).

You'll notice that ~44% of the funds have been award to PV projects through the SSREIP. That is the Small Scale Renewable Energy Incentive Program. As PV costs came down and interest in PV systems grew the CEDF lowered the incentive over the years and eliminated it entirely at the end of 2014. I've included a chart from the SSREIP that shows the decline of the incentive as PV installations increased.
