


Bio: Secretary John Bryson, Department of Commerce

John Bryson was appointed by President Obama as the 37th Secretary of Commerce and sworn into office on October 21, 2011. Bryson has nearly three decades of business experience, including 18 years as Chairman and Chief Executive Officer of Edison International.

Secretary Bryson will be a key member of President Obama's economic team and will work to implement the administration's top economic priority: accelerating job creation. He will work to strengthen the economic

recovery and U.S. competitiveness, and serve as a voice for the business community in the president's Cabinet.

As Commerce Secretary, Bryson will oversee an agency charged with helping make American businesses more innovative and successful at home and more competitive abroad. He will focus on achieving the President's National Export Initiative goals of doubling U.S. exports by the end of 2014; implementing historic reform of the U.S. patent system; overseeing the president's SelectUSA initiative to encourage more companies—American and foreign—to establish or expand U.S. operations to create more jobs for the American people; and, strengthening America's manufacturing sector including the small- and medium-sized manufacturers.



Bryson will also lead the effort to foster new economic development clusters that take advantage of regional strengths; expand the country's broadband infrastructure and effectively manage its spectrum as America gears up to build a national, interoperable wireless network for first responders; strengthen U.S. coastal communities and our weather and oceans science, promote sustainable fisheries and our fishing industry and support critical satellite programs; and, continue the effort to reform a Cold War-era export control system.

Bryson served as Chairman and Chief Executive Officer of Edison International, the parent company of Southern California Edison and Edison Mission Group, from 1990 to 2008. At Edison, he led the utility through the California energy crisis. As CEO, he created a competitive power subsidiary, the Mission Group, which expanded across the U.S and was a global leader in the privatization of power plants and electric systems in Australia, New Zealand, Thailand, the Philippines and several European countries. Bryson has served as a director on several public, educational and non-profit boards, including The Boeing Company, The Walt Disney Company and has served as an adviser and a director of entrepreneurial and start-up companies including Coda Automotive, Inc. and BrightSource Energy. He was a senior adviser to the global investment firm Kohlberg Kravis Roberts (KKR).

Prior to joining the private sector, Bryson served as president of the California Public Utilities Commission and chairman of the California State Water Resources Control Board. Before joining Edison, Bryson was a partner in the law firm of Morrison and Foerster. Shortly after earning his J.D. from Yale law school, he and some classmates received a grant from the Ford Foundation to form the Natural Resources Defense Council in 1971. Bryson is a graduate of Stanford University. He and his wife Louise have four daughters.

Bio: Steve Case, Chairman, Startup America Partnership

Steve Case is one of America's best-known and most accomplished entrepreneurs and philanthropists, and a pioneer in making the Internet part of everyday life.

Steve co-founded America Online (AOL) in 1985, when the Internet was in its infancy. Under Steve's leadership as Chairman and CEO, AOL became the world's largest and most valuable Internet company. AOL helped drive the worldwide adoption of a medium that has transformed business and society. AOL's early focus on ease of use and social media set the stage for its rapid growth, and at its peak nearly half of Internet users in the United States used AOL. In 1992, AOL became the first

Internet company to go public, and was the best performing stock of the 1990s, with a 11,616% return. At the peak of the Internet boom, Steve negotiated what remains the largest merger in business history, bringing together AOL and Time Warner in a transaction that gave AOL shareholders a majority stake in the combined company. To facilitate the merger, Steve agreed to step down as CEO when the merger closed in 2001. He served as Chairman of the Board of the combined company (then known as AOL Time Warner) until 2003.



Steve then went back to his entrepreneurial roots, and in recent years has partnered with more than a dozen entrepreneurs as an investor and mentor. Steve created a holding company called Revolution in 2005 to oversee his rapidly expanding investments. Revolution now has four divisions: Revolution Growth, which invests in high-growth consumer companies (including Zipcar, LivingSocial, and Exclusive Resorts); Revolution Ventures, which backs early-stage technology companies (including Vinfolio, Snagfilms, and

UberMedia); Revolution Health, which invests in health and wellness businesses (including SparkPeople, Extend Health and Brainscope); and Revolution Places, which develops real estate and hospitality businesses (including Grove Farm and Maui Land & Pineapple in Hawaii, Cacique in Costa Rica, and Miraval in Arizona). The success of AOL, coupled with Steve's post-AOL track record building businesses through Revolution, led CNBC to call Steve "one of the nation's greatest entrepreneurs."

Steve is also Chairman of the Case Foundation, a private family foundation he established in 1997 with his wife Jean. Built on the principles of leadership, collaboration and entrepreneurship, the Case Foundation seeks to tap the power of the Internet, new technologies and entrepreneurial approaches to help strengthen the social sector. The Case Foundation has invested in hundreds of organizations, initiatives and partnerships in the U.S. and around the globe. Steve and Jean joined The Giving Pledge, started by Bill Gates and Warren Buffett in 2010, and publicly reaffirmed their commitment to give away the majority of their wealth to fund worthy charitable causes.

Steve was born and raised in Hawaii and retains active ties to his home state, but has lived in the Washington D.C. area for more than 25 years. He was a leading voice in shaping government policy regarding the Internet, including bridging the digital divide, making the Internet a safe place for children, and nurturing civic engagement. Later, he was a member of the State Department's Advisory Committee on Transformational Diplomacy. Currently, Steve is Chairman of the Startup America Partnership, and co-chair of the National Advisory Council on Innovation and Entrepreneurship. Both efforts are aimed at celebrating and accelerating entrepreneurship. He is also co-chair of The Democracy Project, an initiative of the Bipartisan Policy Center to bring bipartisan and diverse voices together to help enhance the ability of government to grapple with the nation's challenges.

10:40 – 11:00 am – Democratic Governors Meet with HUD Secretary Shaun Donovan

Background on the Mortgage Settlement: After many months of negotiation, 49 state attorneys general and the federal government have reached agreement on a historic joint state-federal settlement with the country's five largest loan servicers: Ally/GMAC, Bank of America, Citi, JPMorgan Chase, and Wells Fargo. The settlement will provide as much as \$25 billion in relief to distressed borrowers and direct payments to states and the federal government. It's the largest multistate settlement since the Tobacco Settlement in 1998.

The agreement settles state and federal investigations finding that the country's five largest loan servicers routinely signed foreclosure related documents outside the presence of a notary public and without really knowing whether the facts they contained were correct. Both of these practices violate the law. The settlement provides benefits to borrowers whose loans are owned by the settling banks as well as to many of the borrowers whose loans they service.

Talking Points: Historic Agreement to Help Homeowners and Strengthen the Housing Market

- Recently, the Federal Government and 49 state attorneys general announced a landmark agreement of at least \$25 billion with the nation's five largest mortgage servicers – Bank of America, JP Morgan, Citigroup, Wells Fargo, and Ally Financial – to address mortgage loan servicing and foreclosure abuses.
- This historic agreement is good news for the housing market and good news for homeowners all across the country. The agreement represents the largest federal-state civil settlement ever agreed to.
- This agreement not only provides substantial financial relief to homeowners, it establishes new homeowner protections for the future.
- Last fall, the Administration unveiled a series of steps to help responsible homeowners refinance their mortgages to take advantage of historically low rates. Last week, the President urged Congress to pass a plan that would help millions more refinance and stay in their homes. We need to keep doing everything we can to help homeowners and our economy. The American people need Congress to act.

- Today, with the help of Democratic and Republican attorneys general from nearly every state in the country, we took a major step on our own.
- While the government cannot fix the housing market on its own, the President believes that homeowners should not have to sit and wait for the market to hit bottom to get relief when there are measures at hand that can make a meaningful difference.

Highlights of the Agreement

\$20 billion dedicated to relief for homeowners:

- At least \$10 billion to reduce principal for borrowers who owe more on their mortgages than their homes are worth, making it easier for them to avoid foreclosure.
- At least \$3 billion refinancing program for underwater homeowners who are current on their mortgages.
- Up to \$7 billion to provide other relief for homeowners, including principal forbearance for unemployed borrowers, support for anti-bligh programs, short sales and transitional assistance, and benefits for our brave men and women in uniform who were forced to sell their homes at a loss because they were required to change bases.

\$5 Billion to state and federal governments:

- \$1.5 billion to provide cash payments to borrowers whose homes were sold or taken in foreclosure. Borrowers will be eligible for a uniform payment which will be about \$2,000 per borrower depending on the level of response.
- \$3.5 billion will go to state and federal governments to be used to fund housing counselors, legal aid, and other uses at discretion of state attorneys general.

This announcement creates special protections for America's Servicemembers:

- Servicemembers will be required to make payments to any servicemember who was a victim of a wrongful foreclosure or who was wrongfully charged a higher interest rate. This compensation for servicemembers is in addition to the \$25 billion settlement amount.

Settlement comes on the heels of the President's housing plan:

The President will continue to do everything he can to strengthen the housing market and help homeowners. This agreement comes on the heels of President Obama's housing plan he laid out last week. A few steps he announced last week include:

- The President's plan will provide responsible borrowers who are current on their payments with an opportunity to refinance and take advantage of historically low interest rates, cutting through the red tape that prevents these borrowers from saving hundreds of dollars a month and an average of \$3,000 per year.
- The President also put forward a single set of standards, or a Homeowner Bill of Rights, to make sure borrowers and lenders play by the same rules. Servicemembers are now agreeing to extensive new servicing standards that would begin to implement these rules.
- Additionally, during the State of the Union, the President asked the Attorney General to create a special unit of federal prosecutors and leading state attorneys general to expand our investigations into the abusive lending and packaging of risky mortgages that led to the housing crisis. This new unit will hold accountable those who broke the law, speed assistance to homeowners, and help turn the page on an era of recklessness that hurt so many Americans. This effort marshals new resources to investigate misconduct that contributed to the financial crisis under the leadership of federal and state co-chairs.

Bio: Secretary Shaun Donovan, Department of Housing & Urban Development

On January 26, 2009, Shaun Donovan was sworn in as the 15th United States Secretary for Housing and Urban Development. He has devoted his career to ensuring access to safe, decent, and affordable housing, and has continued that effort in the Obama Administration. Secretary Donovan believes that America's homes are the foundation for family, safe neighborhoods, good schools, and job creation.

His tenure as HUD Secretary has reflected his commitment to making quality housing possible for every American. Sworn in at a time when the foreclosure crisis had devastated American families, under Secretary Donovan's leadership HUD has helped stabilize the housing market and worked to keep responsible families in their homes. The agency has instituted reforms that have solidified the Federal Housing Administration's financial position and protected the taxpayer against risk, while still preserving FHA's mission of providing responsible access to homeownership.



Secretary Donovan has reaffirmed HUD's commitment to building strong, sustainable, inclusive neighborhoods that are connected to education and jobs and provide access to opportunity for all Americans. He has launched new initiatives like Choice Neighborhoods, which will enable distressed communities to use proven mixed-use, mixed-finance tools to transform not just federally-assisted housing, but the neighborhoods around that housing. And through the new Sustainable Communities partnership with the Department of Transportation and the Environmental Protection Agency, HUD is helping regions and communities develop comprehensive housing and transportation plans that create jobs and help American businesses out-innovate their global competitors.

Secretary Donovan has a long history of working to provide affordable housing to American families. He previously served as Commissioner of the New York City Department of Housing Preservation and Development (HPD). He created and implemented HPD's New Housing Marketplace Plan to build and preserve 165,000 affordable homes, the largest municipal affordable housing plan in the nation's history. His work at HPD included the New York City Acquisition Fund, an award-winning collaboration with foundations and banks to finance affordable housing; an innovative inclusionary zoning program; an ambitious supportive housing plan; and the Center for New York City Neighborhoods, one of the earliest responses to the foreclosure crisis. Before his service as HPD Commissioner, Secretary Donovan worked in the private sector on financing affordable housing, and was a visiting scholar at New York University, where he researched and wrote about the preservation of federally-assisted housing.

He was also a consultant to the Millennial Housing Commission on strategies for increasing the production of multifamily housing. The Commission was created by the United States Congress to recommend ways to expand housing opportunities across the nation. Secretary Donovan rejoins HUD after his previous service in the Clinton administration as Deputy Assistant Secretary for Multifamily Housing, where he was the primary federal official responsible for privately-owned multifamily housing. At that time, he ran housing programs that helped 1.7 million families access affordable housing.

He also served as acting FHA Commissioner during the Clinton/Bush presidential transition. Prior to his first service at HUD, he worked at the Community Preservation Corporation (CPC) in New York City, a non-profit lender and developer of affordable housing. He also researched and wrote about housing policy at the Joint Center for Housing Studies at Harvard University and worked as an architect. Secretary Donovan holds a B.A. and Masters degrees in Public Administration and Architecture from Harvard.

Bio: Senior Advisor Valerie Jarrett

Valerie B. Jarrett is a Senior Advisor to President Barack Obama. She is also the Chair of the White House Council on Women and Girls.

Prior to joining the Obama Administration, she was the Chief Executive Officer of The Habitat Company. She also served as Co-Chair of the Obama-Biden Presidential Transition Team, and Senior Advisor to Obama's presidential campaign.

Ms. Jarrett has held positions in both the public and private sector, including the Chairman of the Chicago Transit Board, the Commissioner of Planning and Development for the City of Chicago, and Deputy Chief of Staff for Mayor Richard M. Daley. She also practiced law with two private law firms.

Jarrett also served as a director of corporate and not for profit boards, including Chairman of the Board of the Chicago Stock Exchange, Director of the Federal Reserve Bank of Chicago, and Chairman of the University of Chicago Medical Center Board of Trustees.

Jarrett received her B.A. from Stanford University in 1978 and her J.D. from the University of Michigan Law School in 1981.

- President Obama will make brief remarks and recognize Governor O'Malley for remarks
- Governor O'Malley will make remarks and open the floor for discussion with the President

12:00 to 12:30 – Press Stakeout

NOTE: All of the Governors will gather around. Governor O'Malley will lead and then turn to Govs. Gregoire, Malloy and Patrick to say a few words. Then the press will just throw questions to the whole group.

- Today we met with the President today to talk about job creation and how we can partner with the federal government to improve the lives of people in our states.
- As we continue to climb out of this historic recession, we must make job creation the top priority. We've now seen 23 straight months of private sector job growth – we're not out of the woods yet, but we're making much-needed progress.
- The President has laid out a number of commonsense proposals that would help us create jobs and expand opportunity. Some the things that will particularly help us in our states include:

Leveling the playing field for companies that manufacture and create jobs in the United States.

The current system puts American businesses – especially those in areas like manufacturing which are critical to a strong economy and subject to more intense international competition – at a disadvantage. President Obama would cut business tax rates, encourage investment in the U.S. rather than overseas, and strengthen manufacturing and small businesses without adding a dime to the deficit.

Helping start-ups and small businesses succeed and create jobs by reforming regulations and expanding tax relief. Start-ups and small businesses create most of the new jobs in this country. The President is proposing to build on measures he has already taken to enact 17 small business tax cuts and expand access to capital for small businesses by reforming regulations that prevent entrepreneurs from getting financing and by expanding tax relief to start-ups and small businesses that are creating jobs and increasing wages.

Forging new partnerships between community colleges and businesses to train skilled workers. The President proposed a new initiative to train and place 2 million Americans in good jobs through partnerships between businesses and community colleges that give workers the skills employers explicitly need.

Reforming job training and unemployment insurance to help put Americans back to work. The President believes we need to reform outdated and inefficient unemployment insurance and job training systems and restore the basic bargain that if you're willing to do the work, you deserve the chance to gain the skills you need to find a job or land a better one.

Keeping students in high school by preventing them from dropping out. The President is challenging state governments to require students to stay in school until they graduate or turn 18. Studies show that stronger dropout laws keep students in school longer and increase their lifetime earnings as a result.

Helping to spur innovation by investing in research and development. The President made clear that we need to maintain our commitment to funding research and development that can support our economy and improve our quality of life.

- House Republicans would slash the very things we need to expand opportunity: priorities like Pell Grants that put the dream of a college education within reach of more middle-class families. We urge Republicans to work with the President to enact these commonsense job creation measures.

Gov. Shumlin applauds federal rules granting health care reform flexibility to certain states

*Change eases Vermont's efforts to control skyrocketing health care costs;
implement single payer system*

MONTPELIER – Gov. Peter Shumlin today applauded the Obama Administration for finalizing a federal rule granting states, including Vermont, more flexibility in efforts to control health care costs for families and businesses, and guarantee that affordable coverage is available to more Vermonters. The rule would allow states to obtain a waiver from certain requirements of the federal Affordable Care Act and implement reforms that deviate from the federal model.

“Vermont is moving aggressively to control health care costs for individuals and small businesses, and to get the cost of health care off the backs of employers,” Gov. Shumlin said. “I appreciate the President’s recognition that states like Vermont have good ideas for going beyond the requirements of

the ACA to cover everyone and control costs. States should be able to move further, faster in tackling this problem.”

The U.S. Department of Health and Human Services announced the final rule recently, which in part “provides states with additional flexibility to improve healthcare for their citizens in a way that works for them while retaining the basic protections” of the federal health care law. Gov. Shumlin has spoken with the President and administration officials about Vermont’s plans.

In announcing the final rule, the Obama administration reiterated its support for making the state flexibility waivers available sooner than currently allowed under federal law.

“The President understands the urgency of this problem,” Gov. Shumlin said, “and he understands that states have good ideas for solving it.”
