 - b. New AQB background check requirements will not affect Vermont. The Board feels comfortable with the new requirements that have been already submitted and approved by legislature in 2014.
 - c. Trainee orientation requirement letter will go out with all new trainee orientation classes to make it clear that all courses must also have Vermont specific requirements.
