Dear Governor Shumlin,

On behalf of businesses engaged in the advanced energy industry, I am writing to recommend the appointment of [REDACTED] to the Public Service Board (PSB) of Vermont for the term beginning in March 2015. Advanced Energy Economy (AEE, www.aee.net) is an association of business leaders who are making the global energy system more secure, clean, and affordable. Advanced energy encompasses a broad range of products and services that constitute the best available technologies for meeting energy needs today and tomorrow, including but not limited to electric vehicles, natural gas, energy storage, energy efficiency, smart grid, and renewables.

Public utility commissioners are incredibly important to ensuring that our energy system is secure, clean and affordable. The opportunities created by advanced energy technologies are enormous—from more resilient grids that keep the lights on during a storm, to low-emitting or pollution-free power generators that keep our air clean, to energy-efficient products that lower energy bills. [REDACTED] has a long career spanning multiple advanced energy fields, most notably energy efficiency. [REDACTED] has held positions at [REDACTED]


