1. The meeting was called to order at 1:25 pm

2. The Chair called for approval of the Minutes of the April 10, 2014 meeting. Dr. Boardman made a motion to approve the minutes of the April 10, 2014 meeting as presented. Dr. Yankauskas seconded the motion. Motion passed.

3. **Case Managers Report:**

Carla Preston reported on the number of current cases. There are currently nine (9) pending cases. One (1) is pending a hearing, three (3) are ready for Investigative Team meetings, two (2) are under investigation, and three (3) are recommended for closing (to be reviewed at today's meeting).

4. **Hearings/Reports of Concluded Investigation:**

Order Removing Conditions – Christopher Mangini, DVM – docket # 2009-460 (M2012-51) - Dr. Yankauskas made a motion to approve the order for removal of conditions from Dr. Mangini's Veterinarian license. Dr. Canales seconded the motion. Motion passed.

Report of Concluded Investigation – 2013-337 – Ms. York made a motion to accept the closing report as presented. Dr. Canales seconded the motion. Dr. Yankauskas did not participate in the vote as she was the Investigative Team member. Motion passed.

Report of Concluded Investigation – 2013-346 – Dr. Canales made a motion to accept the closing report as presented. Ms. Johnston seconded the motion. Dr. Yankauskas did not participate in the vote as she was the Investigative Team member. Motion passed.

Report of Concluded Investigation – 2012-107 – Dr. Yankauskas made a motion to accept the closing report as presented. Ms. York seconded the motion. Dr. Canales did not participate in the vote as he was the Investigative Team member. Motion passed.

5. **Continuing Veterinary Medical Education (CVME) request:**

Ms. York made a motion to approve Patricia Fehl's request for four (4) hours of CVME approval for the "**Equine Ophthalmology**" course that was held June 6, 2014. Dr. Canales seconded the motion. Motion passed.

Dr. Boardman made a motion to approve Barry Genzlinger's request for four (4) hours of CVME approval for the "**Bat Rehabilitation Workshop**" course that will be held September 20, 2014. Dr. Yankauskas seconded the motion. Motion passed.

Luana Nelson from AHVMA submitted a request for approval of the "**2014 American Holistic Veterinary Medical Association Annual Conference**" to be held September 13-16, 2014. Ms. Nelson requested approval of 104 CVME credits. The Board did not approve the request from Ms. Nelson, however they requested Ms. Morrison inform her that if a Veterinarian is going to attend the conference they would review individual requests for pre-approval.

6. **Other Business:**




7. **Public Comment:**
