BOARD OF BARBERS AND COSMETOLOGISTS
Unapproved Minutes
January 14, 2008**

1. The meeting was called to order at 9:00 a.m.

Members Present: Josephine Thomas, Chair; Janice Crossan, Vice Chair;
Madeline Roy; and Dolores Martineau. Absent: Gregory Josselyn.

OPR Staff Present: Larry Novins, Board Counsel; Carla Preston, Unit
Administrator Judith Cutler, Esq., Prosecuting Attorney; & Kara Shangraw,
Administrative Assistant.

Others Present: Sara Fantoni.

2. The Chair called for approval of the Minutes of the November 19th meeting. Ms.
Roy made a motion, seconded by Ms. Crossan, to approve the Minutes of the
November 19, 2007 meeting as presented. Motion passed unanimously.

3. **Hearings/Stipulations**

- a. The Board reviewed the *Stipulation and Consent Order* in the matter of
Docket numbers CO08-1105/CO10-1105/CO11-1105 (Walter D. Wood
and Metropolitan Hair). The Respondent was not present. Judith Cutler,
Prosecuting Attorney was present for the State. Attorney Novins presided
for the Board. Based on the information submitted, the Board voted to
accept the *Stipulation and Consent Order* as submitted. Ms. Crossan,
Investigating member, did not participate in the vote.
- b. The Board reviewed the *Stipulation and Consent Order* in the matter of
Docket number CO05-0707 (Lindsey Costello). The Respondent was not
present. Judith Cutler, Prosecuting Attorney was present for the State.
Attorney Novins presided for the Board. The Board voted to reject the
Stipulation as submitted. Ms. Roy made a motion, seconded by Ms.
Crossan to accept the *Stipulation and Consent Order* as amended. Ms.
Thomas, Investigating member, did not participate in the vote.
- c. The hearings scheduled in the matters of CO07-1106/BB03-1106
(Diversity Hair and Nails and James McMillan) was continued to the
March meeting.
- d. Kim LeBlanc requested a hearing regarding her preliminary denial of a
license, Docket number APP-CO16-1007. Ms. LeBlanc did not attend.
Ms. Roy made a motion, Seconded by Ms. Crossan to dismiss the appeal.
Motion passed 3-0. Ms. Thomas, did not participate in the vote.

- e. The Board held a hearing regarding Sara Fantoni's request to modify her Stipulation and Consent Order to waive or reduce the \$750 Administrative Penalty imposed pursuant to an Order dated May 21, 2007, Docket Number CO-04-0906. The Respondent was present. Attorney Novins presided for the Board. Ms. Fantoni mentioned her financial difficulties and asked the Board to waive the penalty or at least allow more time in which to pay it. The Board went into deliberative session at 10:35 a.m. and continued until 10:40 a.m. The Board asked Ms. Fantoni additional questions and she answered them. The Board decided to grant her a 10:41 a.m. and out at 10:55 a.m. Based on the testimony heard, the Board decided not to waive the penalty, but did grant Ms. Fantoni additional time in which to pay the penalty fee. Payments must be not less than \$50 a month and shall begin in February, 2008.
