ANNUAL TOWN OF ATHENS TOWN MEETING

The legal voters of the Town of Athens are hereby notified and warned to act on the following articles and elect Town Officers required by law on the 1st of March AD 2022 at 10:00 am at the Athens Elementary School. All voting for Town Officers will be by Australian ballot. Polls will be open between 10:00am until 7:00pm at the Athens Elementary School.

- ARTICLE 1: To see if the Town shall eliminate the position of elected Road Commissioner and that the Select Board perform all the duties now conferred by law upon the Road Commissioner of the town as of the first Tuesday in March of 2023.
- ARTICLE 2: Shall the Town of Athens expand the Select Board from 3 to 5 members.
- ARTICLE 3: To see if the Town shall vote to authorize the Select Board to borrow money, respectively, if necessary, for current expenses in anticipation of collection of taxes.
- ARTICLE 4: To see if the Town shall vote to collect taxes on the 10th of September, 2022.
- ARTICLE 5: To see if the Town shall vote to publish a list of Delinquent tax payers in the Town Report.
- ARTICLE 6: To see if the Town will approve \$578,489.20 with \$374,232.31 to be raised by Taxes to defray Town expenditures.
- ARTICLE 7: Shall the Town of Athens vote to start a matching grant fund using \$15,000.00 of surplus from the 2021 budget year to be used for highway and Town of Athens projects approved by the Select Board.
- ARTICLE 8: To see if the Town of Athens will vote to appropriate the sum of \$250.00 to support Women's Freedom Center to provide quality advocacy and support to the women and children of Athens.
- ARTICLE 9: To see if the Town of Athens will vote to appropriate the sum of \$330.00 to support Youth Services to serve the needs of youth and families in and around Windham County.
- ARTICLE 10: To see if the Town of Athens will raise and appropriate \$1,000.00 to Southeastern Vermont Community Action (SEVCA) to assist Athens in responding to the emergency needs of the community and providing all available and applicable services.
- ARTICLE 11: To see if the Town will vote to appropriate the sum of \$250.00 for the Bellows Falls Senior Center.
- ARTICLE 12: Shall the Town appropriate the sum of \$1,350.00 to help support the home health, maternal and child health, and hospice care provided in patient's homes and in community settings by the Visiting Nurse Association & Hospice of VT and NH.
- ARTICLE 14: To see if the Town of Athens will raise and appropriate \$1,000.00 to assist Grafton Cares in providing a variety of assistance to the people of Athens.
- ARTICLE 15: To see if the Town shall raise and appropriate the sum of \$300.00 to assist Senior Solutions.

ARTICLE 16: To set the time of future Town meetings.

ARTICLE 17: To transact any further business proper to come before said meeting.

Athens Brick Meetinghouse (ABMH) Town Report 2021

While still meeting remotely, the ABMH committee began the year compiling a scope of work for the projects still to be completed. Bids for painting, window restoration, floor sanding and refinishing, plaster repair and future ADA access to the building were solicited for purposes of completing grant applications. We were thrilled to learn that the facade improvement project was awarded a Paul Bruhn Historic Revitalization Grant in the amount of \$50,000 in February 2021. This is a subgrant through Preservation Trust Vermont funded by the National Park Service. Being a federal grant, it comes with many guidelines and restrictions. As a consequence of those requirements, it wasn't until November that we received the letter of acceptance from the Vermont Division of Historic Preservation to go ahead with the project as stated in our scope of work. The committee will now begin reaching out to contractors for bids on the project with hope that the work can begin in spring of 2022.

Fundraising and social events for the Meetinghouse went ahead and are more and more successful each year. The very popular Memorial Day plant sale was well attended even in 40 degree, rainy weather. The committee is thankful for the help and support of the Athens Garden Club for contributing to the plant sale's success. The plant sale was followed by a tree-planting memorial for Eleanor Beamis, a long time member of the Brick Meetinghouse Committee.

Further activities included a visit to the Brookline Meetinghouse, a well-attended concert and Ice cream social, and, in August, a booth at the Windham County History Fair on the Newfane Green. A silent auction was held for a lumber donation. We also saw the return of the MH firewood raffle.

In the Fall, the committee planted daffodils around the Meetinghouse and to bring an end to the season, had our second annual tree lighting with another beautiful Christmas tree donated by Jay and Ginger Maciejewski, an event that was attended by at least 27 townspeople and two 4-legged friends.

The committee is very thankful for all the support and cooperation of the residents and taxpayers of Athens, as well as its many friends and supporters as we continue to improve and restore this beautiful part of our history.

Cemetery Commission Report

It was a quiet year for repairs in the cemeteries, with no volunteer work having been scheduled in 2021. Chairman Don Capponcelli is looking to the resumption of monument and tablet repairs in both cemeteries in 2022, as well as the completion of row marker installation in the new section of the West Cemetery.

The Commission wishes to thank the Ivor Stevens Grounds Maintenance crew for their work during the 2021 season. The crew has been maintaining the cemeteries for more than a decade now, and commissioners have noted earlier in the year how favorably the work in the Athens cemeteries compares with other cemeteries in the area. The Commission also wishes to thank Matt Perry for his continued work in maintaining the area around Memorial Rock.

The year 2021 ended with a town ledger fund balance for cemeteries in the amount of \$23,340.47. The Commission allots this fund balance into the following categories:

. The \$16,482.08 dedicated to Valley Cemetery major repairs is currently what remains of the liquid assets (checking account balance, stocks & CDs) transferred from the Athens Valley Cemetery Association to the Town of Athens in 2006, plus plot sales since that time.

. The \$1,500.00 dedicated to West Cemetery major repairs is the total of cash sales for plots in the new section of the cemetery since its opening.

. The loans to the Colton and Holden Trust Funds were needed in 2020 in order to bring those funds to a balance of \$500.00 each, thereby avoiding monthly bank fees applied to smaller account balances.

Regular meeting times for the Athens Cemetery Commission are on the first Wednesdays of the months of April, June, September and December at the Athens Town Office (or other locations as warned). Meetings are posted at bulletin boards located at the Town Garage, the Athens Town Office and the Athens Brick Meeting House, and are posted on the Town of Athens website. The Commission continues to face a backlog of work with regard to monument & tablet repairs and levelling as well as map& records updating. CAMPBELL FUND TRUSTEES REPORT 2021

The Campbell Fund was established in 1876 at the Bequest from David R. Campbell of \$4,000.00 to the residents of the town of Athens "to support and aid the paupers,, indigent, and poor of said town of Athens." The principal amount is to remain unused with the interest or income to be used in the aid and benefit of Athens residents. This fund is administered by three (3) elected Trustees by the Town of Athens.

In 2001 the Campbell Fund Trustees published in the Town Report, guidelines for the use of such funds as follows:

The following guidelines have been established for financial assistance from the Campbell Fund of Athens.

1. Fuel oil, propane, heat, etc.
2. Utility payment when accompanied by a disconnect notice.
3. Food for the table.
4. Emergency prescriptions.
5. Doctor's visits.
6. Hospital bills, under some circumstances

Because the Campbell Fund was given to be self-perpetuating, persons receiving aid are asked to repay the amount. There is no time limit and no interest is charged. Campbell Fund Request Applications are available at the Athens Town Office and may be returned to the town office in a sealed envelope marked "Campbell Fund Trustees".

Funding available at present is from the Savings Account only until the Certificate of Deposit matures on 9-24-22.

For 2021 Annual Report

The Windmill Hill Pinnacle Association was formed 30 years ago to ensure public access to the Pinnacle peak and cabin and to honor the late Jamie Latham, who had grown up in Westminster West. At about 1,683 feet, the Pinnacle is the highest and most scenic peak in the town of Westminster, with views on a clear day stretching to Mount Greylock in Massachusetts to Equinox Mountain and Killington.

Today, our mission is to maintain a series of trails while protecting more than 2,700 acres in six towns—Athens, Brookline, Grafton, Rockingham, Townshend, and Westminster.

The Pinnacle network includes more than 26 miles of trails for people to hike, bike, and enjoy nature, both along the Windmill Ridge and other conserved land in Grafton and Athens to the west and the Bald Hill Reserve to the east in Westminster.

The lands we hold are protected in perpetuity through conservation easements, most held jointly by the Vermont Land Trust and the Vermont Housing and Conservation Board. WHPA is committed to making the land available as an educational and inspirational resource to individuals and to local public and private institutions. Hunting is also allowed on most Pinnacle property.

The WHPA is a volunteer non-profit 501(c)(3) organization with over 1,300 members. Last year the Pinnacle paid almost \$12,000 in property taxes on the land it is protecting and keeping open to the public.

Accomplishments in 2021:

— The WHPA acquired the 615-acre Massey property in Brookline, Athens, and Townshend, helped both by local donations and grants from groups interested in protecting open land.

Now known as Lily Pond Highlands, the parcel is just west of the Pinnacle ridgeline, directly within view of the Pinnacle summit, and is part of a high-priority block of habitat in the Grassy Brook headwaters. The land includes bear and moose habitat and two pristine ponds that are home to beaver colonies, a heron rookery, and several species of ducks.

— As part of our educational mission, the WHPA sponsored a naturalist from The Nature Museum in Grafton who provided programming on the trails for students from the Westminster Center School. In addition, students from the Compass School worked

on trail maintenance on the Bald Hill trails, under the direction of Compass teacher Ron Bos-Lun.

— Working with West Hill Shop and High Meadows Farm, Pinnacle volunteers helped host the annual West Hill Grinder in late September, drawing more than 90 people from New England who biked Pinnacle trails and routes in Windham County.

— The Pinnacle sponsored several events to get people into the woods or onto the Windmill Ridge, including a Bald Hill hike in November; the annual Accessibility Day offering rides to a spot on the ridgeline with sweeping views, for people who are unable to hike; and an Athens Dome loop walk in October.

— While also ensuring COVID-19 precautions, the WHPA reopened the Pinnacle shelter for hikers and for overnight stays, with a reservation.

— The WHPA annual meeting included a video recounting the dedication of the Jamie Latham trail and an interview with Libby Mills and Rosalyn Shaoul, board members and authors of *The Windmill Hill Pinnacle Association's Story: How did they get all that land?* (copies of the book are available for a \$25 donation).

—After heavy rains and washouts, road repairs were undertaken and waterbars were upgraded near Paul's Ledges and Old County Road.

—The WHPA completed a strategic planning process and welcomed two new board members, Nora Gordon and Sean Long.

Grafton Cares
Town of Grafton 2022

Grafton Cares was established in 1993 by a group of townspeople concerned with providing help and support to their neighbors. Many new programs have been instituted in the past few years, along with efforts that have been in place for many years. The virus has put a few of our programs on hold. This includes the Wednesday Lunch and the two community suppers. We hope to be "back in business" when this is finally over. The following programs are still functioning.

Financial Assistance Committee

This committee, often working in collaboration with other organizations, offers a helping hand to those with a variety of temporary or long-term needs, ranging from transportation to medical appointments, to financial assistance for families or individuals with urgent needs. Grafton Cares also offers, for temporary or long-term use, a variety of medical equipment for special health needs. A Fuel Assistance Program that includes cordwood has been in operation for many years with the generous support of various donors. This program has filled an important niche by providing emergency fuel aid for those with a temporary need or who are awaiting more long-term support from other agencies.

Gas Card Program

The gas card program began many years ago with the generous contribution of gas cards from Old Tavern guests, via the Windham Foundation. Grafton Cares now funds this program. We distribute these cards to community members to meet emergency needs involving medical transportation issues or financial hardship.

Meals On Wheels

Meals On Wheels are available from the Dam Diner. Delivered by Grafton Cares' volunteer drivers. Meals On Wheels, is available through Senior Solutions (formerly the Council On Aging). Call Dennis Hunt at 869-2674 for more information.

Sunshine Baskets

Sunshine Baskets, filled with fresh fruit, are given to our older neighbors and to those who have had surgery just to give a boost to all. Board members enjoy visiting with these people as much as delivering the baskets.

Strong Living

Strong Living is a popular program where participants ages 40 and up attend two, one hour sessions per week. Led by trained folks through a series of stretching and weightlifting exercises, this program has become a fixed date on many participants' calendars and a great way to catch up on the local news. A donation is suggested to cover the cost of equipment and facilities.

Welcome Bags

The Welcome Bag Program has been greatly appreciated by recipients who are new to Grafton and Athens. It contains a variety of "goodies" and all kinds of information to welcome new folks to town.

Grafton Cares Knitters

A group of local knitters keeps busy with various projects such as beautiful shawls for those in need of comfort and baby blankets, which are combined with board books and a book bag from the Grafton Library, to welcome little ones born to area families.

To facilitate the coordination of transportation needs, a rides coordinator can help with rides for medical appointments. If you or a family member requires transportation to medical appointments, you can give this program a try.

80+ Luncheon. Each Fall, we invite all 80+ year olds and guests from Grafton and Athens to our annual luncheon at the Chapel. Our goal is to celebrate their contributions to the quality of life in our two towns. The Sixth Grade joins us to help serve the meal and visit with guests. This year, because of the virus, we cancelled the luncheon and delivered over 40 “goodie bags” to the 80+ folks.

Athens Report

As Vermont forges toward the goal of an endemic with COVID-19, the Windham County Sheriff's Office continues to work on modernization of our profession as we continue to serve our community. This year, our department adopted the statewide policy which controls how force is used by our deputies as well as every law enforcement officer in Vermont; contributed to the development of the statewide policy on body worn cameras; furthered our work in de-escalation, fair and impartial policing, law enforcement response to mental health calls; all while working to support partners through changing times. This is not to say the work is done. We continue to navigate legal, interpersonal, and complex issues with stakeholders with the vested interest of getting the above work right.

We had a few new initiatives start this year, which build toward our future to serve the people of Windham County. We deployed the first all-electric law enforcement vehicle in Vermont, as part of a pilot project to examine the costs and viability. To date, we are finding an 85% reduction in operational costs of the EV compared to a gas powered equivalent. We established a civilian panel known as the Windham County Sheriff's Advisory, who is charged with providing input on the local issues important to Windham County and the operations of the department. We've begun offering the Regional Animal Control Officer (ACO) program to help assist member towns with animal control issues under the municipality's statutory responsibilities. Our ACO comes with many years of experience including as an ACO in New Hampshire and as a veterinary technician in Vermont. This is a service that we've built separate from our law enforcement capacity, with the hope that one day all towns in Windham County join as members. If your town would like to learn more about becoming a member, your town's leadership can contact my office.

We have also been navigating through a variety of financial changes and hardships. While federal funds have been allocated to state and municipal governments, county funds were re-distributed outside of the county. Additionally, the state increased our contributions to the Vermont State Employees Retirement System by 58% over last year, as policymakers toil with solutions to aid the underfunded system. Our request to leave the retirement system was denied, citing mandatory participation. We've faced increases in the cost of nearly everything along with delays in receiving necessary equipment, supplies, training, and personnel. As a result, we were left with no other solution than to either increase our hourly rates, or significantly reduce or stop providing services all together. We continue to look for funding sources, grants, and pursue legislation to help alleviate this burden.

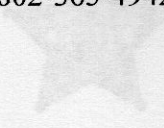
The Sheriff's Office continues to support the interdisciplinary Consortium on Substance Use, working to resolve the opioid and substance use issues that have affected Windham County. The Sheriff's Office continues to support the following programs and initiatives: coordination with the Windham County Highway Safety Task Force; daily Are You Okay? welfare check phone calls; Police Liaison social worker program; Work Zone Safety Enforcement; and Toys for Kids. We continue to maintain secured anonymous drug disposal bin in our lobby to help the citizens of our community safely dispose of unwanted/unused prescription medications. It is the continued support of Athens and other towns which help contribute to our ability to provide these no-cost services to Windham County as a whole.

For the 2021 fiscal year (July 1, 2020 to June 30, 2021), the Sheriff's Office was able to provide 90.5 hours of service. The services provided included motor vehicle enforcement and response to calls for service, or calls where response would not be provided by the town's primary law enforcement agency. During the contract period, we issued a total of 51 tickets with the potential net revenue for Athens of \$4,202. Additionally, deputies have issued 23 warnings and responded to 68 calls for service.

Special Town Meeting

December 15, 2021

The Special Town Meeting was held at the former Athens Elementary School in Athens, Vermont. Moderator David Bemis called the meeting to order at 6:00pm.

The moderator read the warning. He stated the meeting would follow Roberts Rule of Order and would not be in conflict of Vermont Law. The moderator asked that all attending wear masks. The moderator asked that all issues be directed to the moderator.

The clerk took a roll call of the checklist. A total of 84 registered voters answered the roll call of 286 voters on the checklist.

Article 1: Shall the Town of Athens elect its Town officers At all future Annual and Special Town Meetings by Australian ballot pursuant to 17 V.S.A. §2680(b)?

Janet Perry made the motion the Town of Athens elect its Town officers At all future Annual and Special Town Meetings by Australian ballot pursuant to 17 V.S.A. §2680(b). Don Capponcelli seconded. Discussion followed. Wichie Artu asked for clarification on who could speak at town meeting. David said if it was not a registered voter, there would have to be a majority of the voters giving permission for that person to speak. There were concerns about the process needed to put your name on the ballot, how the turnout could be affected by Australian ballot, and how the Australian ballot was handled at last year's Town Meeting. Tom Taylor called the question and asked for a paper ballot. A paper ballot was taken. The results of the ballot were 50 yes, 34 no. The Town officers will be elected by Australian ballot at the annual Town Meeting.

Article 2: Shall the Town of Athens adopt all budget articles and monies At all future Annual and Special Town Meetings by Australian ballot pursuant to 17 V.S.A. §2680©?

Carol Bingham made the motion the Town of Athens adopt all budget articles and monies At all future Annual and Special Town Meeting by Australian ballot pursuant to 17 V.S.A. §2680(c). Denise Randall seconded. Discussion followed. Harold Noyes moved the article. A vote was taken. The results were yes to move the article. A paper ballot was taken. The results of the ballot were 71 yes, 13 no. The motion was defeated. All budget and monies will not be voted by Australian ballot.

Further business. Don Capponcelli wished to thank the teens who helped clean out the school's attic.

There being no further business, Denise Randall made the motion to adjourn. Don Capponcelli seconded. Put to a vote. The motion carried. The meeting adjourned at 7:06pm.
