Bland, Leslie–Vermont requires certain courses to be part of an original degree conferred. With the information provided it is clear that the degree was begun at Winston Salem as a Rehabilitation Counseling degree which was then transferred into a counseling degree from University of Arkansas. The Board does not have the legal latitude to use courses more than once. Under Vermont rules she is deficient in Group 1 course for Human Growth and Development and Treatment Modalities. The board needs confirmation from the school regarding course work and internship hours.

Coburn, Laura–Approved for licensure by endorsement from Ohio.

Cotter, Sandra–Education approved.

- Dreher, Sarah–The Board needs detailed syllabi before they can make a determination on her education.
- Fogg, Danielle–Course work needs to be supplemented
- Gerrard, Lani–Course work needs to be supplemented. She is approved to sit for the exams..
- Headlam, Ronald–The board needs syllabi for certification of internship from the school. His supervision has been approved.
