Hi Walter,

I have only been General Counsel for this Department since 2013 so I am not personally aware of any specifics regarding past members of the Board. I vaguely recall some news coverage regarding former board members, prior to becoming an employee of the Department.

Under 10 V.S.A. § 4041, Fish and Wildlife Board members are appointed by the Governor's office. Here is the language.

(b) There is hereby established a Fish and Wildlife Board. The Board shall consist of 14 members, one from each county, appointed by the Governor with the advice and consent of the Senate. The members of the Board shall be appointed for a term of six years, or unexpired portion thereof, and during their terms shall reside in the county from which they are appointed. In the event a member no longer resides in the county from which he or she was appointed, the Governor shall appoint a member from that county for the unexpired portion of the term. Appointments shall be made in such manner that either two or three terms shall expire each year. A member serving a full six-year term shall not be eligible for reappointment. The Governor shall biennially designate a chair.

The statute does not address your questions and there is no set procedure.

It is my understanding that the Governor's office sometimes consults with the Fish and Wildlife Department regarding Board appointments.

I think it would make sense to wait until Jessica Gingras comes back from vacation so that you can have the benefit of her experience.

Finally if a member of the board violates public policy that they have jurisdiction over, who if anyone have jurisdiction over that member?
