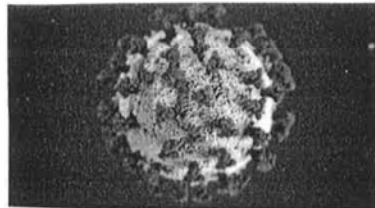


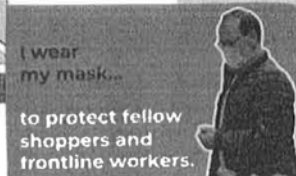
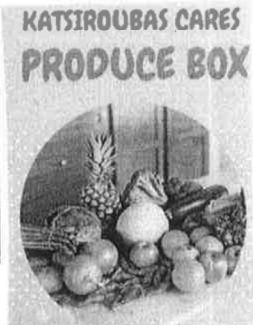

The legal voters of the Town of Windham, Vermont are hereby warned and notified to meet in The Meeting House in said town on Tuesday, March 2, 2021 between 10:00 a.m. and 7:00 p.m. to transact the following business by Australian ballot:

Article 1: To elect a Town Moderator for the year ensuing.

Article 2: Shall the voters accept the Town Report prepared by the Auditors?

Article 3: To elect all Town Officers as required by law:

Article 4: Shall the voters authorize the Town Treasurer to collect current taxes?

Article 5: Shall the voters set the due date for property taxes as November 1, 2021 (postmarked on or before that date)?

Article 6: Shall the voters authorize General Fund expenditures for operating expenses of \$229,662, of which \$208,521 shall be raised by taxes, and net \$21,141 shall be applied from FY20 non-tax revenue which includes FY20 (\$5,169) deficit?

Voted 2020: \$185,503, of which \$148,276 was raised by taxes and \$37,227 was raised in non-tax revenue and surplus (when adjusted to reflect the additional \$30,000 for the Fire Company voted as a separate article, which is now part of the General Fund, the comparable figure for FY20 is \$215,503)

Article 7: Shall the voters authorize Roads Budget expenditures of \$488,568, of which \$482,520 shall be raised by taxes, and \$6,048 shall be applied from FY20 non-tax revenue and surplus?

Voted 2020: \$482,520 (FY19 Roads Budget surplus of \$39,522 was applied to New Road Machinery Fund)

Article 8: Shall the voters appropriate \$90,000 for Repaving and \$15,000 for the Bridges and Large Structures Fund?  
(We will also apply \$45,908 from FY20 Roads Budget surplus to the Bridges and Large Structures fund.)

Voted 2020: \$90,000 for Repaving and \$15,000 for Bridges and Large Structures

Article 9: Shall the voters appropriate \$200 for Senior Solutions to promote the well-being and dignity of older adults; and \$325 to SEVCA to empower individuals and communities to alleviate the hardships of poverty?

Article 10: Shall the voters appropriate \$1,300 for an Animal Control Officer as a shared service with other municipalities through a separate agreement with the Sheriff's Department for the period July through December 2021?

Article 11: Shall the Town establish a Rainy Day Reserve fund to be used for Rainy Day expenses in accordance with 24 VSA §2804 and transfer \$4,500 from the Audit Savings Designated Fund to fund the Rainy Day Reserve fund?





## AUDITORS' REPORT

We have examined the financial records and have compiled the accompanying financial statements of the funds of the Town of Windham, Vermont for the year 2020. We verified the existence of stated cash, balances and securities and examined supporting documents and securities relative to expenditures on a randomly selected basis.

We have reviewed all of the town's bank accounts and found them to be in order. For various financial reports we have relied on information provided from the records for the town.

Our examination should not be construed to be an Audit, Review, or Compilation as defined by the American Institute of C.P.A.s, but merely a review of account balances and activities that were conducted during the year. Our examination revealed no irregularities and we believe the accompanying financial statements reflect fairly the financial condition and the results of activities of the Town of Windham on December 31, 2020. We do not examine financial records of any other organizations or agencies included in this report.

Preparing the 2020 Town Report, while observing Covid-19 protocols, presented many challenges. Our efforts to keep everyone involved in its preparation safe included wearing masks, social distancing, limiting the number of in-person meetings, and working from home when possible. We would like to thank Town Treasurer Kathy Scott, Assistant Treasurer Gail Wyman, Town Clerk Michael McLaine, and Assistant Town Clerk Peter Chamberlain for their cooperation in these efforts as well as all the extra work that they did to help make our job easier.

The Revenue and Expenses Report is not included in the Town Report this year as the numbers contained in this report include information from previous years and does not reflect balances in the current year.

## SELECTBOARD REPORT 2020

Hello 2021. It's hard to imagine that there's anyone not willing to let go of 2020. No need to recap events of the year here. But we would like to gratefully acknowledge the responsibilities of the Town Officials were performed practically seamlessly. The Road Crew is to be commended for keeping us safe on the roads – a Herculean task, for sure. They do it day in and day out, always with a smile. The Town Clerk's office didn't miss a beat either. The hours were slightly adjusted, but all the work got done. The same can be said for the Treasurer, the Listers, the Planning Commission, the Auditors, the Delinquent Tax Collector, the Fire Company and the Health Officer, who all performed their duties in less-than-ideal circumstances.

Acting committees in Town also had their meetings and got their work done. With the go-ahead from the State and the availability of remote meeting platforms such as Zoom, we were able to meet online and still continue to do so. Some of us have taken to it quite easily; others not so much! A positive by-product of this has been an increase in public participation, and Kord's running joke is that Maureen may never leave her house again!

In all seriousness, we did the best we could, with all of you in mind. We have assumed full ownership of The Meeting House, even though its use was greatly curtailed this past year. The Committee is diligently working to figure out the best way to approach repairs, maintenance and uses for the building. It has rekindled a long-dormant collaboration with the Preservation Trust of Vermont to get things moving in the right direction. It is our hope that The Meeting House will once again become an important place for the community to meet, as its name implies. We look forward to the day when the Library can again open its doors to everyone, when we can have Chicken BBQs and Harvest Suppers and when we can come together on the first Tuesday in March for Town Meeting Day.

With Vermont gathering restrictions still in place, Town Meeting 2021 is going to look quite a bit different than it normally does here in Windham. The State has given the Selectboard the authority to temporarily adopt the Australian Ballot method of voting, which we have done. That means that there will be pre-printed paper ballots used for voting, as for General Statewide and Federal elections. Questions on the ballot will be worded as yes/no questions, with the exception of the election of Town Officers. **There will be no actual meeting on March 2.** The Meeting House will be set up for socially-distanced voting just like it was for the November elections. You will be able to request an absentee/early ballot from the Town Clerk after February 10. This can be done by phone (874-4211), mail (5976 Windham Hill Road), or email ([windham.town@gmail.com](mailto:windham.town@gmail.com)). Requesting a ballot in person is not recommended. Completed ballots can be returned by mail in a stamped envelope, in person through the secure slot next to the door at the Town Office or you can drop them off in person at The Meeting House (polling place) on March 2.

Due to the Australian Ballot, the Selectboard is required to hold an informational meeting. This is set for February 20 on Zoom. Accessing the meeting should be easy; details follow below. You will be muted upon entry. Once the meeting begins you will be given the opportunity to ask questions by raising your hand. We will give you further instructions when the meeting begins.

It was filled with events and circumstances many of us could have never imagined and may change how we live our lives forever. Yet, through all this, Windham Elementary School still persists. With our numbers dropping as low as they have been in my sixteen years, as a result of a pandemic, we still managed to put together a budget that all three board members voted in favor of. A budget that is not only less than last year, but is less than it was in 2010! How many other school districts can say that? The school board members have worked very hard to keep costs down, so that we can keep educating the children of this town right here in Windham.

Currently we have eight students enrolled in the school, with the projection for next year as high as possibly eighteen students. This number is certainly dependent upon the pandemic and how families feel about sending children back into school again. Although our current standardized test results on the Aims Web are well above the fiftieth percentile for the school average in math and right about that for language arts, we are not solely focused on academic achievement here at the Windham Elementary School. The staff, school board, and community are doing all we can to provide a wholistic school experience that incorporates visual arts, performance, music, hands on activities, physical activity, outdoor experiences, and anything else we can find to enhance and diversify the experience that is Windham Elementary School.

#### **Staffing**

The students are currently broken down into two classroom spaces, although movement between rooms by both students and adults is becoming more and more common as students are able to work with the group that is most appropriate for where they are academically in a given subject. This allows students who excel in math or language arts to move up into a higher "grade level" for the instruction they are yearning for. With one kindergartener, three first graders, three second graders, and one third grader, we are able to be fluid with our groupings for instruction, so that students are getting exactly what they need at their individual instructional level. Mickey Parker-Jennings is the highly qualified teacher and principal, while Sara Wunderle is the classroom aide and administrative assistant.

Other key members of our school community this year are: Sally Newton, Carla West, Craig Bailes, Abbey Welch, Kord Scott, Lisa Beshay, Paul Wyman, Dan Chotain, Susan Gunther-Moore, Meadows Bee Farm, and Susan Haefner. Sally Newton clearly needs no introduction and has continued to volunteer her time with our students doing outdoor education, cross country skiing, ukuleles, and subbing for either Mr. PJ or Sara when needed. Sally continues to be a very valuable part of the Windham School community, even though she has retired! Carla West has returned for another year of teaching physical education and health to our students. Carla comes twice a

week to get the students moving in PE class and thinking and reflecting on their own well-being and habits in health class. Craig Bailes has been an integral part of our school the past few years as a substitute teacher, and continues to be so this year in that role, if needed. Craig also is working with Sally on outdoor education for the students. Craig took the lead with Sally and the students in building an outdoor classroom in the woods off the soccer field. The outdoor classroom is covered by the old teepee canvas that was donated by Alan Partridge. Thanks to Craig, Sally, and Alan for this amazing space to be used by all students!

We also have several people who come in during the month to help in various other ways. Abbey Welch is our school nurse and comes up once a month to check on things and administer any health related items. Abbey has been invaluable this year with all the new health guidance coming from the state every week. Kord Scott continues as our bus driver and as Mr. PJ's personal, resident furnace and heating expert. Kord's knowledge about heating and cooling has been crucial with all the work being done on the furnace and heating system to keep the air quality clean and safe in the building so that we can have in person instruction this year. Paul Wyman continues as our school custodian and Mr. Fix It. Paul comes in a few times per week to clean up and help make sure everything is working properly in the building. Along with Paul, we have Dan Chotain this year helping on Wednesday to do a very deep cleaning of the school building. Dan is here for about three hours every Wednesday to sanitize, disinfect, clean, and do any other minor repairs or small painting jobs. Susan Gunther-Moore continues as our school social worker. Susan is here once a week to meet with individual students and works with groups of students on mindfulness, wellness, and strategies for being happy and a good friend. Although students cannot attend Meadows Bee Farm in person as they have in the past, this partnership remains strong. Students this year are working on a new sewing badge here at school. This entails three distinct sewing projects for the students to complete over the course of the year. The first project, a pillow, was completed just prior to the holidays so students could give it as a present. Susan Haefner is coming back to Windham again this year to work with our students on performing arts. Susan is part of the Early Stages program from the Weston Playhouse and has worked with our students many times over the past several years. She comes with experience on Broadway and many years of working with students. Those are the dedicated staff of adults who are doing all they can to provide the most comprehensive educational experience possible.

### **Adequate Yearly Progress (AYP) 2019-2020**

Reporting on adequate yearly progress is always challenging for us because we never have ten students in one grade to officially report out results for that grade. Our sample size "n" has not been met for state approval to share out our results. In addition to that, the state assessment known as the SBAC, the Smarter Balanced Assessment Consortium, was not administered last year because of the pandemic and schools being remote. The plan is for the SBAC to be administered in the spring this year. The data we do have for this school year is from the Aims Web standardized assessment. This assessment is given three times a year in the fall, winter, and spring. Again, we do not have enough students at any one grade level to report out, but I will share some averages of the school as a whole. There are five students in the school that have been here all year, and therefore took the fall and winter Aims Web benchmark assessments.

The average national percentile for all our students this fall in math and language arts together was the 44<sup>th</sup> percentile, while the average this winter is the 60<sup>th</sup> percentile, which is an increase of sixteen percent over the past four months. These results are very encouraging since our students are some of the only ones in the state who have been in person this entire school year. Our students should have a distinct advantage going forward given their in person instruction throughout this year.

### **Special Programs and Projects**

As was already mentioned, we are continuing our partnership with Meadows Bee Farm, in its sixth year, by having the students earn their sewing badge. This is done by completing three distinct sewing projects that evolve slightly in skill level as they progress. The goal is to get back to the farm as soon as possible to continue the onsite learning there with the animals, farm chores, ceramics studio, and the blacksmith shop. Also, continuing this year is the Early Stages program. This program has served the students of Windham for many years providing multiple opportunities for students to perform on stage at the Weston Playhouse. This years' experience, as with so many other things, will be slightly different and will not culminate with a performance on stage in Weston, but rather a virtual performance here at school in the spring. Our partnership with the Brattleboro Museum and Arts Center has also been a great way to increase students' cultural and artistic awareness. We hope to continue this partnership next year, when we can get back into the museum again in person. The winter sports program from Stratton was put on hold this year, but thankfully, Bromley Mountain opened up their ski program to students in Windham.

### **Facilities and Improvements**

There have been several improvements here at the school to the facility itself. The main heating unit in the library that had not been working for many years has been repaired and is heating the main space of our building very well. The roof fan on top of the building is now activated to help improve air circulation all over the building. There are three new air purifiers in the school, one in each classroom, and one in the library to help with improved air quality. There is a new CO2 sensor in the library for us to monitor the air quality in the building throughout the day, while new CO2 sensors have also been added to each room as part of the remote monitored heating system. All the heating units have now been connected to one another so that we can use a phone or computer to monitor and adjust the heating and cooling of the building remotely.

## School Directors' Report for the 2020 Town Report

The year 2020 has been like no other. In March, we were confronted with the COVID-19 pandemic and ordered by Governor Scott to close. Shortly thereafter, a virtual learning system was set up for our students, which continued until the end of the school year. Fortunately, a magnificent socially distanced graduation was held outdoors for our six graduates complete with Sara Wunderle's talented husband, Troy, on stilts!

On September 8, the Windham School was able to open for in-person, four day-a-week education for all of our children. Other schools had half the students attend on Monday and Tuesday, with a deep cleaning day on Wednesday, and the other half attend on Thursday and Friday. Because we have the same children attending all week, Principal Mickey Parker-Jennings is currently in conversation with Superintendent Bill Anton to allow the children to attend on Wednesdays as well.

The benefit of having our students attending in person can't be underestimated. There is a national conversation occurring about how students who have been studying virtually have been falling behind. It is also a great benefit to our families who need to go to work knowing that their children are being well-educated and cared for.

We are proud to report that the Windham School Board passed its FY2022 budget unanimously. Carolyn moved that we approve a budget of \$387,892.00, Russ seconded, and we all voted in favor. This is a \$20,695.00 decrease in the budget from last year due to decreases in our WCSU assessments. The good news is that this brings us significantly under the Excess Spending Threshold by more than \$1,800. In fact, our Equalized Per Pupil Spending will be dropping from \$18,187.40 to \$16,959.00

Had our Common Level of Appraisal (CLA) not dropped from 102.23% to 97.83%, our tax rate would have seen a drop to \$1.70 per hundred from \$1.76 this year. The good news is that even with the 4.4% drop in the CLA, our tax rate is projected to only go up a penny or two to \$1.78 per hundred.

What is also good news is that last year the Vermont General Assembly passed legislation that maintains our Average Daily Membership count at what it was last year. This is extremely helpful to maintain our tax rate with only a very small increase. It is anticipated that we will see a significant number of additional students attending next fall, but this is part of the challenge confronting any school board. We have to make judgments based on data that may change.

This year (and potentially next), it has been a great benefit to our Windham families to have our children attending school here in town. Had they not, children would have been studying virtually a good deal of the time.

## Listers' Annual Report for 2020

The job of the Windham Listers is to assess each property accurately, fairly and impartially in order to determine its fair market value. The total assessed value of all property is stated on the Grand List. The Grand List and the budget approved by Windham voters at Town Meeting are used to set the municipal tax rate. The total Grand Lists of all Vermont towns and the school budgets of all Vermont towns are the basis upon which the state legislature sets the statewide education rate. The Listers do not set the tax rate.

The state has formulas to determine the accuracy of each town's appraisals as stated in its Grand List, and there are financial penalties to a town if it is too low. If we are very high or low, the state can force us to do a total reappraisal with a visit to every property in town.

The two main numbers that affect Grand List value and which can force a town-wide reappraisal are the Common Level of Appraisal (CLA) and the Coefficient of Dispersion (COD). The CLA is the sum of the assessed values of Windham's properties sold over the past three years divided by the sum of the sale prices of those same properties. The COD looks at each individual property sold over the last three years, measures the difference between its sales price and the assessed value, then calculates the town's overall appraisal accuracy.

The chart below shows the years the CLA and COD rates were applied. The rates are based upon the sales of the previous three years. Thus, the rates for 2020 are based on sales in 2017, 2018, and 2019. The lower the COD, the closer the assessed values to the sales prices and the more accurate and equitable the appraisal.

(This usually involves completion of a new house, additions to an existing house, or completion of a barn or garage.) Letters will not go out to those whose values have not changed.

TOWN OF WINDHAM  
HEALTH OFFICER REPORT  
2020

During the past year I followed up on two dog bite reports, checking for current rabies vaccination and medical care for the person that was bitten. In one incident I collaborated with the select board which led to a new town ordinance to contain roaming dogs.

At the beginning of the COVID19 pandemic I disseminated handouts at the March Town Meeting regarding preparation for a pandemic and prevention of infection. These handouts were also available at the town office. With members of the select board we prepared a list of elderly residents and those who lived alone. I composed a community health checklist of important topics to discuss by phone. We divided up the names of the residents and maintained phone contact with them until we were assured they were managing well with either family or neighbor assistance. Throughout the many months of the pandemic I was a resource to clarify restrictions and dispel rumors.

The Vermont Department of Health offered webinars for Health Officer continuing education. I participated in all that were offered. The topics covered were: recycling laws related to rental units, coronavirus, asbestos regulations, disinfecting water wells, inspecting for mold in rental units and its treatment, and cyanobacteria in recreational waters.

I continue to write articles for the Windham News and Notes relating to health issues such as safety from tick bites and importance of annual flu shots.

The Vermont Department of Health advises that coliform/E.coli bacteria testing be done annually of home drinking water. I have developed a handout that explains the procedure and gives the necessary information regarding ordering the kit. The Vermont Department of Health offers many air and water test kits which can be found on [www.healthvermont.gov](http://www.healthvermont.gov). The latest news from the Department of Health can also be found at [facebook.com/healthvermont](https://facebook.com/healthvermont) and [twitter.com/healthvermont](https://twitter.com/healthvermont).

If homeowners of Windham have any concerns regarding health issues of their home or environment, please contact me. I have handouts on a variety of subjects and can direct a question to the appropriate source if needed. Also I have emergency preparedness workbooks for anyone who would like one. This is an excellent source the state has published that will help you organize you and your home to be ready for any emergency.

## **LONDONDERY SOLID WASTE GROUP Serving the towns of Landgrove, Londonderry, Peru, Weston, Windham**

**COVID-19 and Solid Waste** has been the focus of everything so why should trash be any different? During the COVID-19 state of emergency, the Vermont Department of Environmental Conservation (DEC) asks the public to please take the following precautions when visiting solid waste facilities and drop offs. Only visit if you are healthy, keep it simple, only bring waste that can't wait like trash and food scraps, minimize the number of trips, practice social distancing by keeping 6 feet of space between other customers and staff, and please wear a mask. Keep yourself and the staff healthy.

**Vermont's Extended Producer Responsibility (EPR)** legislation makes manufactures of products like Computers, Batteries, Paint, Mercury Light Bulbs and Mercury Thermostats take responsibility for their products at the end of their useful life. To find year-round drop-offs call 1-855-63-CYCLE or go to VTrecycles.com. Legislation for packaging will be the next focus for EPR. This will offer financial relief for the collection, hauling and processing of packaging materials.

**Household Hazardous Waste Events:** If you missed our two events this past year, visit [londonderryvt.org/recycle](http://londonderryvt.org/recycle) and click on the A-Z list for information on how to dispose of *architectural paints, alkaline and rechargeable batteries and cell phones, mercury thermostats, fluorescent bulbs, prescription medications and electronics*. Londonderry Group members can also dispose of materials at the Rutland County Solid Waste District, but there are charges involved. For more information, visit <https://www.rcswd.com/hhw/>.

**Food Scrap Ban:** As of July 1, 2020, food waste has been banned from disposal in landfills. Residents, institutions, businesses and schools should divert their food waste by contracting with their haulers, bringing food to the transfer station, composting at home, feeding food scraps to domestic animals, donating to food banks and reducing the amount purchased to avoid wasting food. Haulers are required to offer collection for businesses, schools, institutions, and apartments of four units or more so contact your hauler for assistance if you're in one of these categories.

**Single Use Plastics:** After July 1, 2020, stores and food service establishments are no longer providing *plastic carryout bags* at check-out. Plastic bags are allowed in stores and food service establishments for certain materials (e.g., fruits, vegetables, nuts, coffee, hardware items, frozen foods, meat, fish, prescription medications) or for laundry, dry cleaning, and other large garments. Stores and food service establishments may provide paper carryout bags at check-out for a minimum of \$0.10 each. Food service establishments will no longer offer *plastic stirrers* to customers. *Plastic straws* may still be given to customers, but only upon request. Stores and food service establishments will no longer provide or sell food or beverage containers made of expanded *polystyrene* (known as Styrofoam) including plates and cups, trays, egg cartons, and take-out containers. Expanded polystyrene is still allowed for trays used to package uncooked meat, fish, poultry, or seafood, products packaged out-of-state or packaged for sale out-of-state.

**Be Careful What You Put Down the Drain:** Many materials, especially household hazardous waste, should NOT be poured down the drain, either to a septic tank or field. These chemicals are toxic, will kill the organisms that break down waste, and will enter surface and groundwater supplies. Flushing prescription drugs down the toilet should also be avoided as these have been shown to harm fish and amphibians. ## The Windham Regional Commission

The mission of the Windham Regional Commission (WRC) is to assist towns in Southeastern Vermont to provide effective local governance and to work collaboratively with them to address regional issues. The region is comprised of 27 member towns: the 23 towns of Windham County; Readsboro, Searsburg and Winhall in Bennington County; and Weston in Windsor County.

The Commission is a political subdivision of the state composed of and governed by town-appointed Commissioners. After Town Meeting each Selectboard appoints up to two representatives to serve on the Commission for one-year terms. Windham is currently represented by Carolyn Partridge and Bill Dunkel. Each Commissioner represents their town's interests within a regional context before the Commission, brings information back and forth between the Commission and their town, and serves on at least one of a number of WRC committees that address regional and municipal issues and concerns. Committees and meeting schedules can be found on our website [www.windhamregional.org](http://www.windhamregional.org). All WRC meetings are open to the public and subject to open meeting law.

We assist towns with a wide variety of activities, including developing and implementing town plans and bylaws; community and economic development planning and implementation; local emergency and hazard mitigation planning, including flood hazard and river corridor bylaw assistance; natural resources, including assisting towns with watershed restoration projects and implementation of the state's new clean water law; enhanced town energy planning enabled by Act 174; transportation, including traffic counts (vehicle, bicycle, pedestrian), inventories (bridges, culverts, signs, road erosion), road foremen training, and serving as a liaison with VTtrans to report damage to town road infrastructure as a result of flooding to the state; redevelopment of "Brownfields" (sites that are or may be contaminated by hazardous substances); review of projects applying for permits through state Act 250 (land use) and Section 248 (energy generation and transmission, telecommunications) and federal permitting processes; grant application and administration; training of municipal officials and volunteers across a range of topics; and mapping and geographic information system (GIS) analyses. The maps in your town office were likely produced by the WRC.

We help towns, both individually and collectively, make the most of the financial and human resources they have, assisting with projects in and among towns, building and augmenting the capacity of volunteer-based town boards and commissions, and providing professional services to towns that may want to take on projects that are beyond what they can comfortably manage with their own staff and volunteers. Our relationship with towns is inherently collaborative. For instance, towns may choose to have their plans reviewed by the Commission; town plan review and approval by the WRC is not mandatory, but is a requirement of some state programs (Designated Downtowns and Village Centers) and municipal grant programs. The regional plan, which was updated in 2014 following a two-year process, is developed in consultation with member towns, reflects town plan policies, and is ultimately approved by our towns.

In 2020 we were able to continue to function with minimal disruption, and transition to remote operations, to serve the towns and people of the Windham Region. As the realities of the pandemic became evident, we organized training for towns on continuity of operations planning. We worked with the legislature, state agencies, and the Vermont League of Cities and Towns to make changes to statute to enable towns to continue with their operations while still conducting business in a publicly transparent manner. We arranged for a regular conference call for town emergency management directors and Selectboard chairs with local Vermont Emergency Management, Department of Health, and Agency of Human Services staff. Our website hosts a comprehensive COVID-19 resource guide for individuals, which was developed and maintained by local service organizations and other volunteers. Municipal applications to the Local Government Expense Reimbursement program were and continue to be supported by the WRC. Performance of our normal responsibilities and projects never ceased. Among these was the development of a regional broadband feasibility study and subsequent business plan to provide broadband internet access to the unserved and underserved in the region. The Deerfield Valley Communications Union District organized itself to implement this plan. We are here to support the towns of the region to meet the needs of their residents, conduct their business, and engage in looking forward through and beyond the pandemic.

Funding for the WRC is provided through contracts with state agencies, federal grants, and town assessments. Town assessments make up approximately 5 percent of our total budget for FY 2021, and is the only funding we receive that has no conditions placed upon it by entities beyond the WRC's borders. Each town's individual assessment makes it possible for us to leverage the resources to serve all towns. The town's assessment for this year is \$972.07. 2019 Windham Town Meeting & School District Meeting Minutes  
Windham, VT  
March 3, 2020

Having been warned, the legal voters of the Town of Windham met at the Meeting House in Windham, Vermont on Tuesday, March 3, 2020 at 10:00 a.m. The meeting was called to order at 10:01 a.m. by Michael McLaine, serving as duly elected 2019 Town Moderator, pending vote on Article 1. He announced Presidential primary voting open to registered voters until 7 p.m. and outlined the procedure to be followed. He explained that Roberts Rules of Order will govern all aspects of the Annual Meeting except where Vermont law takes precedence. After reviewing the process for moving articles, speaking on a question, and requesting paper ballots, he led the pledge of allegiance. Announcements followed, including information available on the Emerald Ash Borer and Broadband survey. Marcia Clinton, Health Officer, spoke briefly about the Coronavirus and distributed information. Mike announced a Special Town Meeting to be held on April 2, 2020 at 6 p.m. to act on the petition to move from a three-member Selectboard to a five-member Selectboard. Dr. Roger Fox and Elsie Smith spoke briefly about the status of Mountain Valley Medical Clinic.

Article 1: To elect a Town Moderator for the year ensuing.

Motion: To nominate Michael McLaine as Town Moderator for the year ensuing—moved by Russ Cumming.

Motion: To close nominations and have the clerk cast one ballot for Michael McLaine as Town Moderator—moved by Walter Woodruff.

Vote: Michael McLaine was elected Town Moderator.

Mike McLaine asked Maureen Bell to serve as parliamentarian during the Annual Meeting.

Article 2: To see if voters will accept the Town Report prepared by the Auditors.

Motion: To accept the Town Report as prepared by the Auditors—moved by Carolyn Partridge, seconded by Kathy Scott.

Discussion followed. Ernie Friedli presented a rationale against accepting the Town Report due to errors, omissions, and lack of explanations. He noted a year-end balance on December 31 of \$1.9 million as shown on page 15 of the annual report, while the municipal budget is approximately \$800,000. Russ Cumming explained that the balance is necessary to allow the Town to continue operating until the municipal budget is voted on in March and taxes are collected in October. The Town operates on a calendar year (January through December) and the school operates on a fiscal year (July 1 through June 30). Ernie cited the absence of a cash flow report which he feels should be included as part of the annual report. Imme explained that the information on page 15 is required by the State as part of the report even though the information is largely irrelevant. Discussion followed on detailed information listed on pages 16 through 21.

Motion: To call the question and end discussion—moved by Alison Trowbridge, seconded by Kathy Scott. Motion carried.

Vote: Article 2 passed as written.

Article 3: To elect the following Town Officers:

Selectman—3 year term (Kord Scott-incumbent)

Motion: To nominate Kord Scott as Selectman for 3-year term—Walter Woodruff.

Motion: To close nominations and have the clerk cast one ballot for Kord Scott as Selectman—moved by Michael Simonds, seconded by Joyce Cumming.

Vote: Kord Scott elected Selectman for 3-year term (2020-2023).

Lister—3 year term (Alison Cummings-incumbent)

Motion: To nominate Alison Cummings as Lister for 3-year term—moved by Russ Cumming, seconded by Heath Boyer.

Motion: To close nominations and have the clerk cast one ballot for Alison Cummings as Lister—moved by Walter Woodruff, seconded by Chris Cummings.

Vote: Alison Cummings elected Lister for 3-year term (2020-2023).

Auditor—3 year term (Imme Maurath-incumbent)

Motion: To nominate Imme Maurath as Auditor for 3-year term—moved by Sally Hoover, seconded by John Hoover.

Motion: To close nominations and have the clerk cast one ballot for Imme Maurath as Auditor—moved by Walter Woodruff, seconded by Mary McCoy.

Vote: Imme Maurath elected Auditor for 3-year term (2020-2023).

Constable—2 year term (Joe Lamson-incumbent)

Motion: To close nominations and have the clerk cast one ballot for Eileen Widger as North Windham Cemetery Commissioner—moved by Walter Woodruff, seconded by Ellen McDuffie.

Vote: Eileen Widger elected North Windham Cemetery Commissioner for 5-year term (2020-2025).

Library Trustee—5 year term (Chris Dunkel-incumbent)

Motion: To nominate Chris Dunkel as Library Trustee for 5-year term—moved by Carolyn Partridge.

Motion: To close nominations and have the clerk cast one ballot for Chris Dunkel as Library Trustee—moved by Walter Woodruff, seconded by Mary McCoy.



Vote: Chris Dunkel elected Library Trustee for 5-year term (2020-2025).

Article 4: Shall the voters authorize the Town Treasurer to collect current taxes?

Motion: To authorize the Town Treasurer to collect current taxes—moved by Howard Ires, seconded by Carolyn Partridge.

Vote: Article 4 passed as written.

The Town Meeting was recessed at 10:45 a.m. in order to conduct the School District Annual Meeting.

**Windham School District Annual Meeting**

Article 1: To elect a Moderator for a term of one (1) year.

Motion: To nominate Michael McLaine as School Moderator for a term of one year—moved by Carolyn Partridge, seconded by Howard Ires.

Motion: To close nominations and have the clerk cast one ballot for Michael McLaine as School Moderator—moved by Walter Woodruff, seconded by Kathy Scott.

Vote: Michael McLaine elected School Moderator for a term of one year.

Article 2: To act on the report of the Auditors.

Motion: To act on the report of the Auditors—moved by Carolyn Partridge, seconded by Alison Trowbridge.

Discussion followed on the audit report. Joyce Cumming questioned whether action on this item was appropriate given that Laurie Garland, Chief Financial Officer at Windham Central Supervisory Union (WCSU), had not had a chance to review the report as of the evening prior. Carolyn Partridge stated her assumption that the Town auditors (not the WCSU) had conducted the school audit. The Moderator asked whether the Town auditors were prepared to speak to this. Imme Maurath, Town Auditor, explained that the Town auditors do not conduct the school audit and she assumed the audit was conducted by the Supervisory Union. Walter Woodruff suggested putting the question on hold until a later date. Colin Blazej asked about whether it could be added to the April 2 Special Town Meeting. Maureen noted that the School District would need to warn a Special Meeting for April 2 to be held in tandem with the Special Town Meeting. The Moderator explained that a motion to postpone to a time definite would require a second, is debatable, and subject to amendment.

Motion: To postpone action on the report of the auditors to a time definite—moved by Walter Woodruff, seconded by Kathy Scott.

Discussion followed. Kathy Scott acknowledged that while the audit was done, Laurie Garland of the WCSU did not have a chance to review the auditor's report. Kathy noted that the cost of the audit was approximately \$5,500 and she felt it was important to allow time for review. Carolyn noted the need for an Emergency Meeting of the school board in order to warn the Special Meeting.

Motion: To call the question on postponing action on the report of the auditors to a time definite—moved by Walter Woodruff, seconded by Kathy Scott. Motion carried.

Vote: To postpone action on the report of the auditors to a time definite. Motion carried.

In response to a question from Antje about conducting an emergency meeting of the school board at this point, Mike McLaine explained that it was not included in the warning and could not be added. Carolyn suggested including it as part of Article 6 (To transact any other business that may legally come before this meeting).

Article 3: To elect all other officers required by law to be elected at the Windham School.

School District Treasurer—1 year term (ending 2021)

Motion: To nominate Kathy Scott as School District Treasurer for 1-year term—moved by Antje Rupert, seconded by Peter Chamberlain.

Motion: To close nominations and have the clerk cast one ballot for Kathy Scott as School District Treasurer—moved by Walter Woodruff, seconded by Colin Blazej.

Vote: Kathy Scott elected School District Treasurer for 1-year term (2020-2021).



School District Director—3 year term (ending 2023)

Motion: To nominate Carolyn Partridge as School District Director for 3-year term—moved by Antje Rupert.

Motion: To nominate Russ Cumming as School District Director for 3-year term—moved by Peter Chamberlain.  
Bob Bingham requested voting by paper ballot which was supported by more than 7 voters. Mike McLaine explained the process for voting. Beth McDonald requested an opportunity to hear from both candidates. Both candidates spoke briefly before voting commenced.

Vote: Russ Cumming was elected School District Director for 3-year term (2020-2023) by a vote of 66 to 44 (total of 110 ballots cast).

Article 4: To compensate the School Directors \$750 each as included in the proposed School Budget for 2020-2021.

Motion: To compensate the School Directors \$750 each as included in the proposed 2020-2021 School Budget—moved by Howard Ires, seconded by Antje Rupert.

Vote: Article 4 passed as written.

Article 5: "Shall the voters of the Windham School District approve the school board to expend \$535,075 which is the amount the school board has determined to be necessary for the ensuing fiscal year?" It is estimated that this proposed budget, if approved, will result in education spending of \$24,855 per equalized pupil. This projected spending per equalized pupil is 16% higher than spending for the current year.

Motion: To approve the school board to expend \$535,075, the amount determined by the school board as necessary for the ensuing fiscal year—moved by Antje Rupert, seconded by Alison Trowbridge.

- Antje Rupert, Windham School Director, requested an opportunity to address the voters.
  - Last year, opposition to merger included asking Newfane, Jamaica, Townshend and Brookline to vote against Windham joining; and extension to 6/30/20 on prior vote to close WES, sell it to the town, and tuition students out.
  - Significant budget increase for second year led to the creation of an ad-hoc committee to research factors driving the increases and explore possible options to reduce taxes.
  - Deficit from 2019 of approx. \$93,000 due to increased expenses such as \$10,000 additional (beyond \$16,000 budgeted) for regular education pre-K, \$54,000 additional pre-K Special Education expense, \$10,000 increase in health insurance, legal fees of \$1,500, and \$1,800 shortfall in expected revenue. After applying surplus funds of \$29,466 against deficit of \$92,947, a deficit of \$63,481 remains and is included in the FY21 proposed budget.
  - Board has considered all options including merger, tuitioning students out, school choice, etc. but is not sure if any other schools have capacity to accept Windham students.
  - If school closes, tax rate would be reduced slightly but at the cost of closing the school which cannot reopen because it doesn't meet building code requirements.
  - School needs to plan replacement for teacher retiring in June, hence the need to get this budget approved. Board will work hard this coming year to come up with better solution.
- Heath Boyer spoke as member of the ad-hoc committee (not speaking for the committee).
  - Russ initiated an examination of the tax situation which led to formation of ad hoc committee; members are not elected or appointed; simply a group of residents across socio-economic spectrum who agree that taxes have become intolerable and a solution must be found.
  - Some budget increases are not discretionary and are responsible for per pupil spending beyond the excess spending threshold for which we are penalized. By itself, the penalty constitutes approximately 1.5% of the tax rate.
  - Relief may be realized through legal redress and/or lobbying for adoption of the weighting study.
  - A detailed budget review meeting is scheduled for March 9. Subsequent meetings will be scheduled as needed to determine the future of WES.
  - Spreadsheets and budget comparisons from year to year will be forwarded to the webmaster for posting on the Town website.
- Leigh Merinoff has heard from many concerned residents who cannot afford tax increases. She asked if there is a way to help people pay taxes in the short-term so they don't leave town.
- Crystal Corriveau spoke about how she has advocated keeping her grandchildren at Townshend Elementary. She is not comfortable advocating for close of WES but has to do what is right for her family.

- Dan Reilly thinks the tax system is broken. The school system can't be fixed if we can't fix the tax situation. People are moving away from Windham. Vermont is one of 14 states which taxes Social Security making it difficult for retirees.
- Kathy Scott noted that unfunded mandates are responsible for excess spending and penalties. With 19 students, our budget would need to drop to \$356,000 to avoid penalties. Of that, almost \$280,000 is not discretionary leaving approximately \$84,000 for salaries, transportations, telephone, electricity, etc.
- Ernie Friedli would prefer a separate meeting to allow more time for discussion of the school budget which has increased 18% over the past two years.
- Lisa Beshay believes that families won't move here if there is no school; WES is best for her family.
- Kermit Woods took a more philosophical approach to the issue comparing boomers to generation x to millennials, etc.
- Bill Dunkel spoke as member of the ad-hoc committee, retired educator and school administrator.
  - He has always voted to support the school budget—this is first time questioning the budget. The tax burden is unsustainable and more time is needed to consider options.
  - Still not convinced to close the school. Some data shows minimal or no impact on taxes while other data shows significant impact on taxes.
  - Voting down the budget, not to protest the School Board, but to protest the State's unfair policies which penalize taxpayers for excess spending while one of the factors in the excess is the cost of State-mandated health insurance coverage for school employees.
  - We all agree on the need to provide a good education at a reasonable cost. The school board and ad-hoc committee will continue to work together toward this goal.

Motion: To call the question and end discussion—moved by Vance Bell, seconded by Nate Kehoe. Motion failed.

- Carolyn Partridge noted that if the school closes, it will not negate our responsibility to provide pre-K special education services. She believes the weighting study will benefit Windham by increasing our equalized pupil count. She encouraged voters to go to Montpelier and testify at the Senate Education Committee Hearing on March 11. (Room 11 at the State House, 4 – 6 p.m.) Even if legislation passes, it will take 1 or 2 years. Current projections show the tax rate will decrease in a few years and then rise again in 2024. There is nothing that will substantially reduce the tax rate at this point. She also asked for support of H.B. 661 to fund pre-K special education at the same rate as K-12.
- Debbie Greene and her brother-in-law plan to attend the Senate Education Hearing Committee Meeting on March 11.
- Joe Pawelczyk feels budget should be voted down to send a message to Montpelier. We can't continue to kick the can down the road—we need change.
- Russ Cumming noted that Windham is 1 of just 7 towns in the excess spending category. Our per-pupil spending at \$24,855 is \$6,098 over the threshold amount of \$18,756. The excess amount is doubled as a penalty (\$6,098 x 2 = \$12,196) and then added to the threshold amount (\$18,756 + \$12,196) meaning we need to raise \$30,953 in taxes for each student. He feels the penalty should not apply if excess spending is due to unfunded State mandates.
- Jim McCandless, non-resident, was accorded an opportunity to speak. His wife and son are teachers and he suggested we get together with the other towns which are penalized and pursue legal recourse.
- Ernie Friedli suggested using the existing revenue to fund expenses until June or July when the State notifies us of our tax rate. Antje responded that we cannot wait until June or July as contracts must be signed in April.

Motion: To call the question and end discussion—moved by Mary McCoy, seconded by Howard Ires. Motion carried.

Bob Bingham called for vote by paper ballot which was supported by 7 or more voters.

During the tallying of the votes, Bill Dunkel addressed the voters as a member of the Energy Committee and explained the Window Dressers program which provides inexpensive energy-efficient storm windows. Windows are measured and custom-made using pre-cut, pre-drilled frames in an assembly-line process. Residents receive training and participate in the 'community build' event which would likely be held in November if sufficient residents are interested in the program. Measurements would be taken over the summer. If interested, please contact Bill or sign-up.

Vote: Article 5 failed. Yes: 43 No: 57 (entrance checklist: 99 exit checklist: 100)

A recess was called at 1:35 p.m. for lunch.

The meeting reconvened at 2:25 p.m. The Moderator reminded voters that the School District Meeting was still underway.

On behalf of the ad-hoc committee, Heath Boyer announced that the school budget will be reviewed again on March 9 at 4 p.m. at the school. Anyone interested is welcome to participate. The school budget will be voted again at a Special Meeting to be warned.

Article 6: To transact any other business which may legally come before this meeting.

Carolyn reported that the School Board met over lunch break and scheduled a Special Meeting to act on the Auditor's Report for April 2 at 6 p.m.

The School District meeting was adjourned at 2:31 p.m.

#### **Town Meeting Resumed**

Article 5: Shall the voters appropriate \$148,276 for the General Fund?

Voted 2019: \$180,556 (When adjusted to reflect the removal of \$30,000 for the Fire Company—see Article 9—as well as the addition of \$300 that was voted as a separate article for The Collaborative, which is now part of the General Fund, the comparable figure is \$150,856)

Motion: To appropriate \$148,276 for the General Fund—moved by Kathy Scott, seconded by Carolyn Partridge. Victoria Silsby, representative from The Collaborative, spoke briefly about The Collaborative which recently celebrated its 20<sup>th</sup> anniversary, and thanked the voters for their support.

Vote: Article 5 passed as written.

Article 6: Shall the voters appropriate \$482,520 for the Winter and Summer roads? (Voted 2019: \$497,084)

Motion: To appropriate \$482,520 for the Winter and Summer roads—moved by Colin Blazej, seconded by Russ Cumming.

Vote: Article 6 passed as written.

Article 7: Shall the voters appropriate \$90,000 for Repaving and \$15,000 for the Bridges and Large Structures Fund?

(Voted 2019 \$90,000 for Repaving, \$15,000 Bridges/Large Structures)

Motion: To appropriate \$90,000 for repaving and \$15,000 for the bridges and large structures fund—moved by Colin Blazej, seconded by Carolyn Partridge.

Vote: Article 7 passed as written.

Article 8: Shall the voters appropriate \$30,000 for the New Road Machinery Fund? Voted 2019: \$60,000 (We will apply \$39,522 from 2019 Roads Budget surplus to this fund.)

Motion: To appropriate \$30,000 for the New Road Machinery Fund—moved by Russ Cumming, seconded by Kathy Scott.

Discussion followed. Phil McDuffie inquired regarding how the appropriation amount is determined each year; is there a spreadsheet listing each piece of equipment and its viable life span? Kord responded yes, there is a draft equipment replacement schedule listing expected life of machinery. In response to follow-up questions from Phil, Kord reported that the replacement value of all equipment (grader, loader, large plow truck and the F550) comes to \$750,000 - \$1,000,000; that \$60,000 annually is greater than expected because the fund is in "catch-up" mode after several expensive repairs/replacement costs in recent years; the F550 is next to replace and quotes have been obtained for a new truck and extended warranty for better trade-in value.

Vote: Article 8 passed as written.

Article 9: Shall the voters appropriate \$30,000 to the Windham Volunteer Fire Company? Voted 2019: \$30,000 (as part of General Budget)

Selectboard Chair Maureen Bell presided over the question as Michael McLaine is a member of the Windham Volunteer Fire Company.

Motion: To appropriate \$30,000 to the Windham Volunteer Fire Company—moved by Carolyn Partridge, seconded by Bob Kehoe.

Vote: Article 9 passed as written.

Article 10: To transact any other business that may legally come before this meeting.




- Russ Cumming inquired about status of the Meeting House. The Windham Congregational Church will quit-claim its rights to the church; paperwork is being drawn up and closing is anticipated by next week.
- Jerry Amsden mentioned photos on display in the entry which include his grandfather who owned a pew in the church.
- Ginny Crittenden explained that information on the Emerald Ash Borer is available in the back of the room and encouraged everyone to take and share the information.
- Carolyn Partridge offered a brief legislative report. Representative Matt Trieber has resigned and accepted another position; candidates are being considered.
- Bill Dunkel inquired about testimony on March 11 at the State House and what residents can do to be most effective. Carolyn explained that anyone interested in testifying should arrive by 2:30 p.m. with remarks limited to 1 – 2 minutes. The weighting study assigns more weight (i.e., each student will be counted as more than 1) to ELL students, students in poverty, students in sparsely populated areas, and students attending schools with less than 100 students. It could mean that our current count of 18 equalized pupils would increase to 24 equalized pupils.
- Ellen McDuffie addressed the assembly about information she distributes via email to keep residents informed. Please let her know if you are not receiving the emails but would like to, or you are receiving the information but want to be removed from the list.
- Colin Blazej thanked Richard Paré and the members of the road crew for all their hard work.
- Jan Wyman announced that the new fire truck is on display across the street. She invited anyone interested to attend meetings of the Windham Volunteer Fire Company which are held on the first Thursday of each month at 6 p.m. at the fire house.



## What is DVFiber?

DVFiber exists because of advocacy. For years, Vermonters around the state have decried the lack of reliable internet mixed with disinterested corporate provider response. Because Vermont is largely rural, financial incentives to serve every home and business simply do not exist for large or small corporate providers.

Communications Union Districts (CUDs) were first authorized under Vermont law in 2015. ECFiber became the first CUD in 2016, after operating as an association of towns since 2008. In June 2019, Gov. Scott signed H.513, which significantly expanded state support for CUDs, including planning grants, loan guarantees, and technical assistance from the Public Service Department. At Town Meeting 2020, the Deerfield Valley Communications Union District (DVCUD) sprang to life after strong yeas in Halifax, Marlboro, Stratton, Whitingham, and Wilmington. Work began immediately. Since March, fourteen more towns have expanded the district. Across the State, eight other CUDs are functioning at this point.

Each town sends one representative and one or more alternates to the governing board, which meets monthly. The governing board oversees all development, plans, and operations. Three committees, comprised of board members and community residents, move the work forward. They are our Vendor, Finance, and Communications Committees. Everyone involved volunteers time and energy.

DVFiber is the name of the service organization that DVCUD is creating. DVFiber is a municipality that functions like a not-for-profit business that is rapidly transforming into a regional service organization to secure reliable, affordable high speed access to the Internet. To date, DVFiber is powered by grants received from the Vermont Public Service Department, the federal government, Vermont Community Foundation, the Brattleboro Development Credit Corporation, and a number of private funders. We are guided by a business plan produced by the Windham Regional Commission. This plan includes an engineering plan, market analysis, sequence and schedule of work, finance models, and estimated construction costs, which will be considerable. Many who read this report may become disheartened when they understand the likely time it will take to bring broadband to their homes and businesses. But for the first time we have a path to the possible when there was none before.

Because DV Fiber cannot use tax money, we will undertake a continuous effort to fundraise, write grants, and advocate with State and Federal Legislatures for continued build-out financing until we are delivering high speed internet service to all home and business customers and our revenue streams are sufficient to offer municipal bonds.

### Windham Report

Each year as we prepare town reports, we get to reflect on the time gone by. I don't think anyone will argue that this was a bizarre year, but with the closing 2020, we continue our tradition of sharing with you what's going on. One of the focal points of this year was SARS-CoV-2 (COVID19), which like similar hardships brought our community together, despite the words "socially distant." We were grateful to receive donations of personal protective equipment from area businesses and non-profits when emergency services faced shortages in the supply chain. We coordinated with community groups to ensure people received food and that our neighbors were okay. Our deputies created the "Bring Birthdays Back" program to celebrate the birthdays of children isolated from their friends and families by the lockdown, raising over \$1020 and countless toy donations. In short, the community came forward to support our department and we worked to support the community during this trying time.

COVID-19 brought about numerous changes for us. While we continued to provide policing, service of civil process, and emergency dispatching services, we suspended non-essential activities such as civilian fingerprinting, evictions as required by Act 101, prisoner transports, extraditions, and traffic control for construction, as well as closed our facility to public access. We implemented protocols for safe contacts between the public and our personnel. Foregoing many of these services resulted in a significant financial burden as our expenses remained largely the same, though our non-tax funded revenue sources dropped. Through the efforts of Windham County's Legislative delegation and with the support of the Assistant Judges Barnett and Duff, we were able to obtain emergency funding through the Local Government's Emergency Response grant which diminished the financial impact and allowed our essential services to continue. While several of our services were reinstated over the Summer and Fall, we monitor daily and adjust as the environment changes.

Another important issue brought about this year was regarding police reform and racial justice. Many of us stood in horror as we watched the homicide of George Floyd which sparked conversation and debate nationally and locally. Historically, Vermont has done a lot of work toward better policing initiatives, but we must acknowledge that this isn't a conversation with a finish line. We continuously improve. I am thankful of the many people willing to share their experiences, perspectives, and time to help the Windham County Sheriff's Office measure itself and identify what changes it needed. We reviewed policies, training, data and engaged in community dialogue. As part of our introspection, I established the Windham County Sheriff's Advisory, a group of citizens to help provide community input toward the policies and operations of the Sheriff's Office. We engaged with individuals, organizations, researchers, and public bodies, to listen candidly. We worked with 40 agencies in Vermont to uniformly share traffic stop and race data reporting of all traffic stops. We obtained a grant-funded study from an independent researcher to evaluate us.

Since 2007, we've engaged in various forms of training on de-escalation of force, explicit/implicit bias, fair and impartial policing, and interacting with persons suffering from mental illness. The department has long prohibited the use of chokeholds. We declined to deploy tools such as tasers, acknowledging the power of de-escalation through dialogue and our low occurrences of use-of-force techniques by deputies. We've captured race data on our traffic stops to help us monitor for deputies engaged in biased policing. While many action items of the President's 21<sup>st</sup> Century Policing Task Force report have been accomplished, we continue to address other areas. The Sheriff's Office continues to support the interdisciplinary Consortium on Substance Use, working to resolve the opioid and substance use issues that have affected Windham County. This year, we welcomed a Police Liaison social worker through a partnership with HCRS, Dover PD, and Wilmington PD. The Sheriff's

Office continues to support the following programs and initiatives: coordination with the Windham County Highway Safety Task Force; daily Are You Okay? welfare check phone calls; Work Zone Safety Enforcement; Toys for Kids; and snow mobile patrols. We continue to maintain secured anonymous drug disposal bin in our lobby to help the citizens of our community safely dispose of unwanted/unused prescription medications. It is the continued support of Windham and other towns which help contribute to our ability to provide these no-cost services to Windham County as a whole.

For the 2020 fiscal year (July 1, 2019 to June 30, 2020), Windham contracted with the Sheriff's Office to provide a total of 120 hours of service throughout the year. The Sheriff's Office was able to provide 186.75 hours of service, at no additional cost to the town. The services provided included motor vehicle enforcement and response to calls for service, or calls where response would not be provided by the town's primary law enforcement agency. During the contract period, we issued a total of 52 tickets with the potential net revenue for Windham of \$6519.20. Additionally, deputies have issued 12 warnings and responded to 61 calls for service.
