

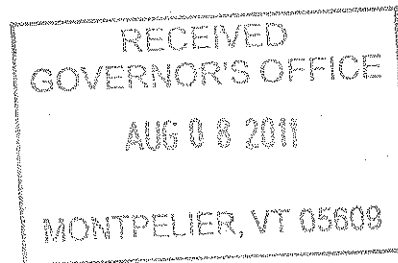

Re: Ongoing Public Records Requests regarding your OJT Contract with MSB Healthgroup

Dear Mr. Fleisher:

In response to your statement that you believed us to be withholding certain records, Commissioner Noonan and I requested all departmental employees named in your email to double check their files and email folders for additional documents. They have done so, and several additional emails have been discovered. They were produced to you on July 7, 2011.

In response, you specifically requested additional documents, namely emails between our employee Becky Trudeau and MBA Healthgroup employee Tamika Fleury on the subject of your OJT grant, and any response from John Vowles to Becky Trudeau's email of March 26, 2010 (previously produced).

In response to your email, I asked both John Vowles and Becky Trudeau to once again check their files and email records for documents responsive to your request. They have responded that they could find no such documents, with one exception: a March 8, 2010 email exchange involving Becky, John, Tamika and another MBA employee about a deduction made from an OJT grant payment to MBA by the Department of Taxes. A copy of that email exchange is enclosed. In addition, I requested both our internal departmental IT staff and the state's Department of Information and Innovation to search their email servers for any documents responsive to your request. Neither were able to



locate any documents responsive to your request.
