5. Administration, Education, Practice, Licensure

Executive Director's Report: The Board received the written Executive Director's Report and related documents provided in the Board meeting packet. The report included:

- **Board Meetings:** The Board of Nursing will be meeting at the Chapel in College Hall at the Vermont College of Fine Arts in November.
- **Board of Nursing Move:** The Office of Professional Regulation will be moving to temporary office space in December at The Vermont College of Fine Arts. A permanent move will occur towards the summer of 2013.
- **OPR Board Retreat:** The Office of Professional Regulation cancelled the OPR Board Retreat because of the Office being moved.
- **Blue Ribbon Commission:** The Blue Ribbon Commission on Nursing had its final meeting on September 11, 2012. They have written recommendations for the Governor on the future of nursing in Vermont.
- **SANE:** L. Davidson attended the SANE Board meeting on September 12, 2012. L. Davidson participates in the Certification & Compliance Committee. The Committee reviewed 2012 SANE applications and discussed certification issues that have arisen.
- **ERP Program:** The State is moving towards electronic processing of employee time records and expense sheets. L. Davidson attended a training seminar for supervisors in reference to this implementation.
- **50th Anniversary of Castleton Nursing Program:** On Saturday, September 29, 2012 E. Hansen and L. Davidson attended a celebration in recognition of the 50th Anniversary of the Castleton Nursing Program. J. Carr was a guest speaker at the event
- **Licensure:** The office is on track for the LNA Renewal cycle. Notices will be going out mid-October.
- **Workforce Data Survey;** Work continues on embedding the minimum data set for the RN/APRN renewal cycle.
- **Discipline:** As of September 30, 2012 there are 198 open cases, 64 follow-up cases and 6 Alternative Program participants.

- A. Strategic Initiatives and Goals:** The Board received the Strategic Initiatives and Goals. The Board discussed possible Board retreat days. The Board will send possible retreat agenda items to L. Davidson. The Board will solidify a date and agenda for the retreat at the November meeting.

- B. Criminal Background Checks (update from NCSBN)** - The Board will discuss Criminal Background Checks at the Board Retreat. NCSBN has put together a team to educate and assist Boards of Nursing wishing to move forward with this initiative.

- E. Education Committee Report:** The Education Committee did not meet in September. The next meeting will be October 22nd to review the annual reports for the nursing programs.
