2 The Committee on Ways and Means to which was referred Senate Bill
3 No. 11 entitled “An act relating to prohibiting robocalls” respectfully reports
4 that it has considered the same and recommends that the House propose to the
5 Senate that the bill be amended as follows:

6 First: By striking out Secs. 2–3 in their entireties and inserting in lieu
7 thereof the following:

8 Sec. 2. [Reserved.]

9 Sec. 3. [Reserved.]

10 Second: By striking out Secs. 49–51 in their entireties and inserting in lieu
11 thereof the following:

12 Sec. 49. APPROPRIATION; DOWNTOWN AND VILLAGE CENTER TAX
13 CREDIT PROGRAM

14 There is appropriated the sum of \$2,700,000.00 from the General Fund to
15 the Vermont Downtown and Village Center Tax Credit Program to be used in
16 fiscal years 2023 and 2024. Notwithstanding 32 V.S.A. § 5930ee, the funds
17 shall be used to increase the amount of tax credits that may be awarded to
18 qualified projects. Of those tax credits awarded in fiscal years 2023 and 2024,
19 up to \$2,000,000.00 may be awarded to qualified projects located in designated
20 neighborhood development areas.
