UNAPPROVED MINUTES OF THE
VERMONT BOARD OF ALLIED MENTAL HEALTH PRACTITIONERS
OCTOBER 21, 2021 – REMOTE MEETING

1. The meeting was called to order at 9:00 a.m.
2. **Minutes** Mr. Waldron moved, seconded by Mr. Irwin, to approve the minutes of the September 16, 2021 meeting with reversing the order of the agenda items. Approved.
3. Lara Govendo attended the Board meeting to discuss her supervision. Mr. Waldron moved, seconded by Mr. Irwin, to waive Rule 3.15(b), which states that “only supervised practice hours acquired within 5 years of a final decision on licensure may be excepted” for licensure, and to accept Ms. Govendo’s supervision hours from five or more years ago, subject to confirmation from her medical provider that Ms. Govendo was unable to acquire supervised practice hours over the previous five years. Approved.

Mr. Waldron moved, seconded by Mr. Irwin, to approve the following continuing education courses:

6. Applications
- Hirce, Catherine – The Board reviewed course descriptions submitted by the applicant. Mr. Irwin moved, seconded by Mr. Waldron, to find that courses CNL 545, CNL 527 and PCN 527 appear to meet the requirements of the Administrative Rules for coursework in addictive disorders and crisis intervention. Approved.
- McCann, Allie (Andrus) – The Board requested additional information.
- Mitchell, Caitlin – The Board is unable to find a stand-alone Diagnosis, Assessment and Treatment course within her degree conferred and noted other regulatory deficiencies in the degree. Mr. Irwin moved, seconded by Mr. Waldron, to preliminarily deny this application. Approved.
- Peterson, Lynn – Traditional endorsement from North Dakota. The Board found that the Licensed Professional Counselor licensing requirements in North Dakota are not substantially equivalent to Vermont's LCMHC licensing requirements. Mr. Irwin moved, seconded by Mr. Waldron to deny Ms. Peterson's endorsement application. Approved. Applicant may apply through examination.
- Turner, Linda – Traditional endorsement from Florida. The Board found that Florida's Licensed Mental Health counselor licensing requirements are substantially equivalent to Vermont's LCMHC licensing requirements. Mr. Irwin moved, seconded by Mr. Waldron to approve this application in accordance with Rule 3.23(b). Approved. The applicant must complete the NCMHCE to become licensed.
- Bowman, Katie – Tabled due to lack of quorum.
- Zambetti, Ronald – Tabled due to lack of quorum.
