Dear Governor Shumlin,

We are writing to follow up from our previous correspondence with your predecessor dated March 22, 2010. Like most states across the United States, Vermont has high quality public water systems. We are writing to ask for your leadership in protecting them. For over six years Corporate Accountability International has been leading the Think Outside the Bottle Campaign to raise awareness about the environmental and social impacts of bottled water and to galvanize support for strong public water systems. Over the past ten years (1997-2007) the U.S. bottled water market has more than doubled. More than 75% of people in this country drink bottled water, and one in five drinks only bottled water. State governments contribute to this trend when purchasing bottled water for offices, meetings, and other state-sponsored events.

As we work to stimulate our economy, spending taxpayer money on bottled water is a misallocation of limited resources. Last year, we released our Getting States Off the Bottle Report which found that, in Vermont, annual spending on bottled water in 2008 was \$228,874. State spending on bottled water undermines confidence in Vermont's public water supply and pollutes the environment. Plastic water bottles in the U.S. require the equivalent of 32 to 54 million barrels of oil a year to manufacture, and 70 percent end up incinerated, buried in our landfills or are discarded on our roadways or in our waterways as litter.

We hope you have followed the recent national attention on the negative impacts of bottled water and the growing concern about the privatization and commodification of our water. Increasing numbers of cities, restaurants, institutions, and individuals are turning back to the tap and away from expensive, branded bottled water. The U.S. Conference of Mayors passed a resolution at their 2008 annual meeting encouraging cities across the country to phase out government use of bottled water and promote the importance of strong public water systems. Already, more than 100 cities have responded to this resolution and have taken common sense actions to protect the environment, save money, and restore confidence in our public water supplies. Now states are heeding the call. Illinois, Colorado and New York issued policies cutting state spending on bottled water. We are eager to see similar actions taken here in Vermont.

Recent studies show that government spending on public water systems pays huge dividends for our economy. Public water systems are the backbone of our country's infrastructure, public health and economic prosperity—it's time we start nurturing them. Yet, last year, the American public spent more than \$10 billion buying bottled water. This at a time when our public water systems are in need of increased public support, facing at least an annual \$23 billion investment shortfall between what these systems require and what is allocated.

Governor Shumlin, we want to extend the opportunity for you to become a local and national leader on this issue by ending state contracts with bottled water suppliers, promoting public water systems across the state, and advocating for a renewed national commitment to water infrastructure funding. We have enclosed a copy of



our previous letter to your predecessor on this matter as well as copies of hundreds of petitions from people across the state calling on you to cut taxpayer spending on bottled water and support strong public water systems.

As our state's leading public official, we ask you to show your commitment to our public water systems by issuing a policy to cut budget spending on bottled water.
