Subject: Your PRA request

Hi Sandy, left you a voicemail just now. Just trying to clarify your PRA request. The Governor's Office has received your request directed to the Governor and we are processing it. I will be in touch further on Monday. I understand the Department of Public Service has agreed to work with you too, and to be further in touch March 27. My understanding is the majority of potentially responsive records are likely to be housed at the Department.

As a practical matter, it is likely most cost-effective to have the DPS continue to seek information as worked out in your agreement before CLF seeks records directly of the other agencies. To the extent you wish to pursue more records following their response (potentially resulting in additional costs), it likely makes sense to submit requests addressed to ACCD, AoA, ANR, and potentially the PSB at that time. Does this work for you?
