The Highway Department is working to improve the roads by removing more trees and brush. Work was done on Camp Road with aid from grant funding received. They have applied for several grants for 2019. More information is in the Road Commissioner's report. My thanks to the road crew for their hard work on the Town's roads.

Again, thank you to all the volunteers at the Hubbardton Fire Dept. for all you do. The Town appreciates the time and dedication each of your members has shown over the years. It is not easy getting up in the middle of some of the coldest nights or fiercest weather conditions to go help your neighbors, but you all do it. Thank you!

In 2017, a property owner approached the Board with the idea of selling his property to the Town for recreational use. The Board has been researching ways to make this happen without having to raise funds using tax dollars. This can be achieved with grants, private donors – personal and from foundations. There is an article on the warning regarding this purchase.

The Town Hall basement has been refinished and is now ready for use.

The Hubbardton-Castleton Food Distribution Center has closed. The appropriation approved at the 2018 Town Meeting was recently returned to the Town. Pastor Chris Poluikis and his wife have moved. They gave a lot to the Town in their short time here and will be missed.

I look forward to seeing many of you at the Town events held each year – Hubbardton Day and the Spring Pot Luck. If you haven't attended one or both in the past, they are a good way to meet and enjoy the company of neighbors.

I would like to take a moment to remember those who left us in the past year; Aldo Breda, Douglas Houghton, Marilyn Kaehler, Robert Navin and John Nunez. Rest in peace dear neighbors.

In closing, I would like to say a big "Thank you!" to all who serve our community.

Road Commissioner's Report

Another year has gone by and the Highway Department has been busy completing many tasks and several projects.

Some of the projects were completed with financial assistance received from grants. One Better Road Grant, \$20,000 for culverts, ditching and brush removal on Camp Rd. was received, a Bridge grant for \$175,000 was received to replace a bridge on Biddie Knob Rd. and a FEMA grant for \$31,447.09 was received. This was for washout damage on Young Rd. due to a 2017 rain storm at the end of June and start of July. The Camp Rd. undertaking was quite extensive. Brush and several trees that were encroaching on the road were removed, ditching was done, and they were lined with stone, and culverts were replaced.

A road inventory and erosion report were completed to meet state requirements. This is a mandatory part of the Municipal Roads Permit.

Tree trimming and removal plus brush work were done on Pencil Mill and Woods roads, Monument Hill Rd. is next on the list. There are areas with thick canopies and trees leaning. The trees threaten the road safety and will be trimmed and removed as needed. By thinning the canopy light is allowed onto the road increasing winter safety (ice can melt when and if there is sun) and the roads will dry quicker in both the winter and summer months decreasing the amount of moisture accumulating under the surface.

The crew will continue its ongoing maintenance of tree and brush removal.

Several grants have been applied for in anticipation of the upcoming season. So far, a small grant was received for work to be done on Ganson Hill. The crew will ditch, work to remove brush and trees plus replace a couple of culverts.

All the work could not have been accomplished without the Town's Road Crew. Thank you, Bruce Chapman, Joshua Davis and our newest member John Jackson. The team works well together. Each member holds a Class A CDL license. The Highway Dept. works continuously to increase their skill levels and have attended multiple workshops. They have been working with Stu Johnson from Vermont Local Roads learning to grade.

As always, I would like to extend my thanks to all Town employees, Hubbardton Fire Department, the Hubbardton Town Constable and the Hubbardton Select Board for their continued support throughout the year. The Highway Department will continue to maintain a good working relationship with all departments in Town and with other agencies throughout the state.

To the residents of the Town of Hubbardton, thank you for your cooperation and understanding and know that the crew and I are always available to help and or answer any questions you might have.

Buildings and Grounds Report

The Town Offices and Hall Basement became the primary focus of work done in 2018. The repairs, approved at the 2018 Town Meeting, came about because of the mold problem encountered when repairing the drainage problem last year. Because of the mold issue the basement kitchen and bathrooms were demoed.

The walls and ceilings were replaced; the floors and walls painted. A new, smaller kitchen was installed. One bathroom was redone, the toilet and sink were not replaced. The second downstairs bathroom is now a storage room for the Town Office.

New chairs and tables were purchased for the Town Hall. The ones being replaced were relocated to the downstairs kitchen.

Throughout the Town regular routine maintenance was performed on all buildings as needed. Inspections are done annually on the buildings by the Town's insurance provider and fire systems. All recommendations are followed to ensure the Town is in compliance.

Overall, it has been a productive year. Having Co-Commissioners is working well as there is always someone around to view an issue and tend to having them fixed.

HUBBARDTON HISTORICAL SOCIETY

The Hubbardton Historical was established in 2000 by a group of like minded Hubbardton citizens and the help of the Pittsford Historical Society located in Pittsford, Vermont.

Our first project was to establish our society. Second, be participants at the Vermont History Expo held June 17th and 18th that year in Tunbridge, Vermont at the fairgrounds. Our first exhibit was the encampment display of the Battle of Hubbardton, July 7, 1777. The display had grass, a tent, and a scenic backdrop. The backdrop was created by Debbie Duval, a local Hubbardton artist. Jim Dassatti of the Living History Association (LHA), served as the display's interpreter. We were hooked on history.

By participating in the Vermont History Expos most of the years it was held, we learned more about our own history, Hubbardton history. Soon we connected with other historical societies throughout Vermont.

Hubbardton Historical Society was soon working closely with the Vermont Division for Historic Preservation and the Living History Association presenting the Battle of Hubbardton Reenactment and Encampment each year. This year is the 242nd Anniversary of the Battle of Hubbardton. The reenactment will be held July 6th & 7th, 2019. We hope to see you there!

Several years ago, we had soldier signs made to help visitors find the way to the Battlefield. Everyone visiting looks for the soldiers to make certain they are following the right route. We have been fortunate over the years to have several young people as active participants. They help us tell Hubbardton's story at the Expo and volunteer Reenactment weekend.

Our website, Hubbardton.net, has had several inquiries from people seeking information about relatives who have lived or fought in Hubbardton. We learned much from George Dikeman and his family. Information dating back as far as the Revolutionary War. Thank you, George for sharing your wealth of knowledge about Hubbardton with us.

Did you know? We have at least one WWII veteran who was given the Quilt of Valor – what an honor!!

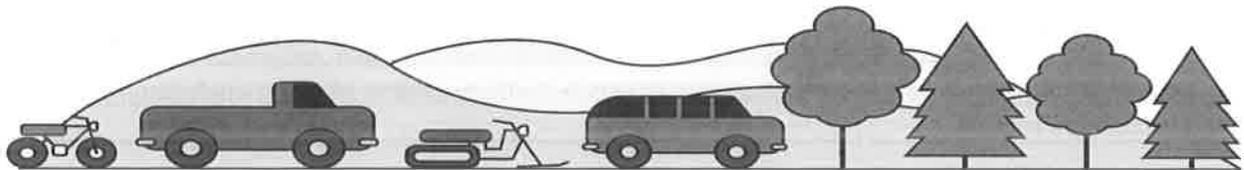

Vermont Department of Health 2019 Local Report

At the Vermont Department of Health our twelve Local Health District Offices around the state provide health services and promote wellness for all Vermonters.

Your local office is in Rutland at the address and phone number above. Available to help individuals and families at worksites, schools, town meetings, or by appointment, we work hard to provide you with knowledgeable and accessible care, resources, and services. We also partner with local organizations and health care providers to ensure we're equipped to respond to the community's needs. In 2018, we worked in partnership with communities to:

- Donate almost 300 pairs of adult and children's snowshoes to loan out at 21 free public libraries throughout Rutland County through a 3-4-50 grant.
- Increase capacity to prevent underage and binge drinking and reduce prescription drug misuse and marijuana through Regional Prevention Partnerships (RPP) and our local Partners for Prevention community network.
- Prevent and control the spread of infectious disease. In 2018 we spent \$13,729,406 on vaccines provided at no cost to healthcare providers around the state to make sure children and adults are protected against vaccine-preventable diseases. We also responded to 244 cases of infectious disease.
- Promote wellness by focusing on walking and biking safety, reducing tobacco exposure, and increasing access to healthy foods through the implementation of local projects and municipal strategies.
- Support healthy families by helping kids stay connected with providers and dentists following transfer into foster care.
- Serve families and children with the Women, Infants, and Children (WIC) Nutrition Education and Food Supplementation Program. In 2018, we served over 1300 families in Rutland County.
- Provide trainings on Help Me Grow to Healthcare and Early Childhood Education Providers to support improved access to resources and services for parents and families with young children.
- Share new data and reports including the *Vermont Lead in School Drinking Water Testing Pilot Report* which is helping Vermonters understand and address the risk of lead in school drinking water, and the *Injury and Violence in Vermont* report, which is shedding light on the risk of suicide among youths.
- Work with businesses in planning and starting worksite wellness strategies to improve on-the-job opportunities for health for local residents, including creating Breastfeeding Friendly locations to support growing families.
- Work with local partners, including, schools, hospitals, and emergency personnel, to ensure we are prepared to distribute medicine, supplies, and information during a public health emergency.
- Improve understanding of how to stay healthy at work, home, and in the community through initiatives and resources related to 3-4-50, Help Me Grow, WIC, Building Bright Futures, Be Tick Smart, 802Quits, and the Breastfeeding Friendly Employer project.

ARTICLE 19. To act on any other business that may properly come before this meeting.

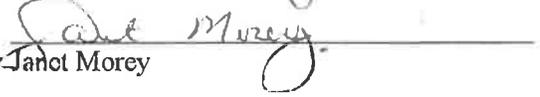

RHR Smith & Company has stated that the audit was conducted in accordance with auditing standards that require them to plan and perform the audit in order to obtain reasonable assurance whether the financial statements are free of material misstatement.

The audit was conducted for the purpose of forming an opinion on the financial statements that collectively comprise the Addison Rutland Supervisory Union basic financial statements.

This year is the 242nd Anniversary of the Battle of Hubbardton. The reenactment will be held July 6th & 7th, 2019. We hope to see you there!

Several years ago, we had soldier signs made to help visitors find the way to the Battlefield. Everyone visiting looks for the soldiers to make certain they are following the right route. We have been fortunate over the years to have several young people as active participants. They help us tell Hubbardton's story at the Expo and volunteer Reenactment weekend.

Our website, Hubbardton.net, has had several inquiries from people seeking information about relatives who have lived or fought in Hubbardton. We learned much from George Dikeman and his family. Information dating back as far as the Revolutionary War. Thank you, George for sharing your wealth of knowledge about Hubbardton with us.

Did you know? We have at least one WWII veteran who was given the Quilt of Valor – what an honor!!

ADDISON RUTLAND S.U. 2017-2018 Revenue Report

In the area of special education we continue to see increases in the intensity of service needs of our students. We are experiencing significant social, emotional and behavioral needs that are emerging at younger grade levels resulting in a need for intensive supports and interventions and a need for more specialized providers. We are implementing several alternative classrooms and programs at the elementary and high school levels and have plans for the development of alternative programming at the middle school level in the near future. We are working collaboratively with our local and state resource providers to ensure that our students and families have access to the supports they need to be successful in school.

During the last two years, the issue of special education finance has been in the forefront of the work of the Vermont Education committees and the Legislature. As a result of this ongoing work, we will be implementing a new special education funding model for the 2019-2020 school year. The new laws and funding mechanisms are an attempt to get a handle on the cost of special education while improving the quality of teaching and learning for all struggling students.

Based on this new legislation, special education funding will shift to a census-based grant from the current reimbursement system, meaning that districts will receive funding based on the total size of their student population, rather than all funding being tied to students identified as needing special education. This funding can be used at the discretion of local schools, freeing us up to implement programs and hire specialists to serve struggling students before they get to a level where they are in need of special education. The overall goal is to increase educational opportunities and outcomes for ALL students.

We congratulate the following recipients of this year's special awards: Joseph Metrolle and Benjamin Worthing each received UVM Outstanding Teacher Awards, Nicole Gagnon, Trevor Kelso, Kimberly St. Phillips, Benjamin Worthing, and Kerry Struczkopf each received an ARSU Outstanding Teacher Award, FHGS PBS Leadership Team, Laura Bryanton-Jilinski and CHS ACE's Team each received the ARSU Executive Awards, Carreann Wolcott, Nicole Aldous, Noor Hussain, Claire Bartholomew and Claire Carpenter each received an ARSU Instructional Assistant Award, Rodney Baischick, Brandon Schultz, FHGS Parent Teacher Organization, FHUIS PBL Steering Committee, and Marcy Hart each received the ARSU Special Service Awards, Kathleen Hart, Sheila Bourque, Patricia Davenport, Gary Boulton, and Tom Painsoneach each received an ARSU Substitute of the Year Award.

In closing, I would like to take this opportunity to reaffirm our Organizational Belief Statements.

TOWN OF HUBBARDTON COMMUNITY SCHOLARSHIP

Information Sheet

Intent: A scholarship awarded to a senior who resides in the Town of Hubbardton. The purpose of this monetary award is to assist in meeting the cost of attending an accredited two or four-year institution in order to pursue a post-secondary education.

Eligibility: Candidates must be residents of the town of Hubbardton during their final two years of high school. At the time of application, the candidate must be currently enrolled and attending any high school, private or public. The scholarship will be renewed each year (for up to three more years) as long as the student is attending school and in good standing, and providing sufficient funds are available. Annually, the student must submit an official transcript to the Hubbardton School Board, no later than **August 1st**.

Candidates are selected based on grade point averages, class rank, academic achievements, extra-curricular activities and community involvement. Each application is individually considered; however, a minimum grade point average of 3.0 is required. Decisions of the School Board are final.

The student's family must retain residency in Hubbardton in order to continue receipt of the scholarship.

Amount: \$500.00 per year, to a maximum of four years, so long as sufficient funds are available.

Process: Application for this scholarship is accomplished by completing the form available at your Guidance Office, the Hubbardton Town Office, or in the Annual Town Report. A copy of the applicant's high school transcript must accompany the completed application form. Applications must be received by March 27, 2019 at the FHUHS Guidance Office or Hubbardton Town Office.

Payment: A draft will be issued in the recipient's name by August 1st, prior to each post-secondary school year. The recipient agrees to return the funds if the first semester is not completed satisfactorily (except in cases of emergency). Proof of successful enrollment must be provided for each renewing year.

NOTICE TO VERMONT VOTERS

BEFORE ELECTION DAY:

CHECKLIST POSTED at Clerks Office by February 3, 2019. If your name is not on the checklist, then you must register to vote. **SAMPLE BALLOTS** will be posted by February 23, 2019.

HOW TO REGISTER TO VOTE: There is no deadline to register to vote. You will be able to register to vote on the day of the election. You can register prior by visiting the town clerk's office or going online to olvr.sec.state.vt.us.

REQUEST EARLY or ABSENTEE BALLOTS: You or a family member can request early or absentee ballots at any time during the year of the election in person, in writing, by telephone, email, or online at mvp.sec.state.vt.us. The latest you can request ballots for the March 5, 2019 Election is the close of the Town Clerk's office on March 4, 2019. (Any other person authorized by you who is not a family member must apply in writing or in person for a ballot for you.)

WAYS TO VOTE YOUR EARLY BALLOT:

- You may vote in the town clerk's office before the deadline.
- Voter may take his or her ballot(s) out of the clerk's office and return in same manner as if the ballots were received by mail.
- Have ballot mailed to you, and mail or deliver it back to the clerk's office before Election Day or to the polling place before 7:00 p.m. on Election Day.
- If you are sick or disabled before Election Day, ask the town clerk to have two justices of the peace bring a ballot to you at your home. (Ballots can be delivered on any of the eight days preceding the day of the election or on the day of election.)

ON ELECTION DAY:

If your name was dropped from the checklist in error, or has not been added even though you submitted a timely application for addition to the checklist, you can fill out a new registration form.

- ! If the clerk or Board of Civil Authority does not add your name, you can appeal the decision to a superior court judge, who will settle the matter on Election Day. Call the Secretary of State's Office at 1-800-439-VOTE (439-8683) for more information.

If you are a first-time voter who submitted your application to the checklist individually by mail and did not submit the required document, you must provide a current and valid photo identification, or a bank statement, utility bill, or government document that contains your name/current address.

If you have physical disabilities, are visually impaired or can't read, you may have assistance from any person of your choice. If any voters, you know have disabilities let them know they can have assistance from any person of their choice.

If you know voters who cannot get from the car into the polling place let them know that ballot(s) may be brought to their car by two election officials.

If you have any questions or need assistance while voting, ask your town clerk or any election official for help.

NO PERSON SHALL:

- ! Vote more than once per election, either in the same town or in different towns.
- ! Mislead the board of civil authority about your own or another person's true residency or other eligibility to vote.
- ! Hinder or impede a voter going into or from the polling place.
- ! Socialize in a manner that could disturb other voters in the polling place.
- ! Offer bribe, threaten or exercise undue influence to dictate or control the vote of another person.

FOR HELP OR INFORMATION: Call the Secretary of State's Office at 1-800-439-VOTE (439-8683). (Accessible by TDD)

If you believe that any of your voting rights have been violated, you may file an Administrative Complaint with the Secretary of State's Office, 128 State Street, Montpelier, VT 05633.

If you believe you have witnessed efforts to commit any kind of fraud or corruption in the voting process, you may report this to your local United States Attorney's Office.

If you have witnessed actual or attempted acts of discrimination or intimidation in the voting process, you may report this to the Civil Rights Division of the United States Department of Justice at (800) 253-3931.

INSTRUCTIONS FOR VOTERS using Paper Ballots

CHECK-IN AND RECEIVE BALLOTS:

- Go to the entrance checklist table.
- Give name and, if asked, street address to the election official in a loud voice.
- Wait until your name is repeated and checked off by the official.
- An election official will give you a ballot.
- Enter within the guardrail and go to a vacant voting booth.

MARK YOUR BALLOT: For each office listed on the ballot, you will see instructions to "Vote for not more than one, or Vote for not more than two, etc."

- To vote for a candidate, fill in the oval to the right of the name of the candidate you want to vote for.
- WRITE-IN candidate(s). To vote for someone whose name is not printed on the ballot, use the blank "write-in" lines on the ballot and either write-in the name or paste on sticker, then fill in the oval.

CHECK OUT:

- Go to the exit checklist table and state your name in an audible voice.
- Wait until your name is repeated and checked off by the official.

CAST YOUR VOTE by depositing your voted ballot in "Voted Ballots" box.

LEAVE the voting area immediately by passing outside the guardrail.
