We'd like to address some of the HIA recommendations directly in the bill. I had a few additional questions for you some of them:

With regards to prevention, do you know what substance misuse

prevention, education and screening in schools and pediatric offices we currently have?

Should we piggyback off of / direct funds to existing programs or create something new?

Do you have something in mind for a statewide education campaign, both in terms of substance and how to stage implementation?

What would the process look like for expanding screening in primary care practices and getting providers the information they need? Does this require legislation? Do we already have information handouts for providers?

I know these are big questions. Is there someone I can work with to get some clarity on these issues?

#### Sec. 1. LEGISLATIVE INTENT

The purpose of this act is to end the failed policy of prohibition and create a regulated market for marijuana in the interest of keeping marijuana and other drugs out of the hands of underage kids; wiping out the black market and getting rid of the illegal drug dealers; using revenue from legalization to expand drug prevention programs; strengthening law enforcement's capacity to improve the response to impaired drivers under the influence of marijuana on Vermont's roads; and banning the sale of edibles.

#### Sec. 2. COMPREHENSIVE STATEWIDE APPROACH TO THE PREVENTION OF MARIJUANA USAGE

(a) Prevention is the most important tool available to the state to educate Vermonters about the negative health impacts of marijuana and curtail usage among youth. While there are a number of programs and organizations devoted to raising awareness about the impacts of marijuana, a coordinated and properly funded statewide approach is needed to ensure that we are devoting appropriate resources and programming to preventing use before it happens. Comprehensive and collaborative education and prevention should continue to be supported and expanded in an effort to prevent marijuana use amongst

Vermont's youth. Proper funding will increase the state's ability to educate children about the impacts of marijuana and to provide needed services to prevent usage.
