

ORDER FOR RECOUNT

---

WHEREAS, Annette Smith, a Progressive Party candidate for governor filed a petition for recount of the primary election results for the progressive candidate for governor on September 6, 2012, which request was timely, and

WHEREAS, The results of the election are such that she qualifies for a recount pursuant to law, that is, the vote difference between her candidacy and that of Martha Abbott is less than 2% of the total votes cast,

IT IS ORDERED That a recount shall be held, commencing on September 13, 2012 and shall be conducted pursuant to 17 V.S.A. § 2602 et seq.

1. All candidates for the office of governor shall be notified of the recount, and
2. Each candidate shall immediately submit a list of nominees for individuals to serve on a recount committee for each county to the clerk of this court. Notice is also to be given to the state Progressive Party so it may submit a list of nominees for those counties which do not have a county committee. The court understands that the Democratic and Republican Parties have county committees in each county.

3. If any candidates do not intend to submit a list, they are requested to notify this court as soon as possible. The court urges all to participate and assist in the recount process.
4. The recount shall be held commencing on September 13, 2012 at 9:00 am..
5. Each county clerk shall conduct the recount in accord with 17 V.S.A. § 2602b-k.
6. The court will conduct a status conference with regard to the matter on Monday, September 10, 2012 at 4:15 pm at the Civil Division of the Washington Superior Court.


AND WHEREAS, this court has determined she is entitled to a recount pursuant to law,

IT IS HEREBY ORDERED THAT pursuant to 17 V.S.A. § 2602(c), you are authorized and ordered to appoint two election officials to transport all ballots cast in the primary election from your city or town to the county clerk in your respective counties. In addition to the paper ballots, the officials should transport the entrance checklists. The recount will be a hand recount, thus machines are not required to be delivered unless you are subsequently so notified. The two election officials shall not be associated with the same political party.

The recount is scheduled to commence on September 13, 2012 at 9:00 am. at the civil division of the Superior Court in the respective counties. Ballots and checklists must be received by the county clerks not later than the close of

business on September 12, 2012.




