**Analysis of Bill**

**1. Summary of bill and issue it addresses.**

This bill proposes to automatically send motor vehicle driver's license and non-driver identification applications to the Secretary of State for the purpose of voter registration.

**2. Is there a need for this bill?**

Yes. This bill is required to change the existing process of motor voter registration.

**3. What are likely to be the fiscal and programmatic implications of this bill for this Department?**

The provisions in this bill require the Department of Motor Vehicles to collect and transmit the following information from applicants on driver's license applications: Applicant's citizenship; place and date of birth; town of legal residence; street address or physical description of location of applicant's address sufficient for town clerk residency verification. The bill would necessitate changes to the Driver License Application, Commercial Driver License Application, and the Non-Driver Identification Application. The required changes are not anticipated to have a major impact, and will not result in increased costs.

**4. What might be the fiscal and programmatic implications of this bill for other departments in state government, and what is likely to be their perspective on it?**
