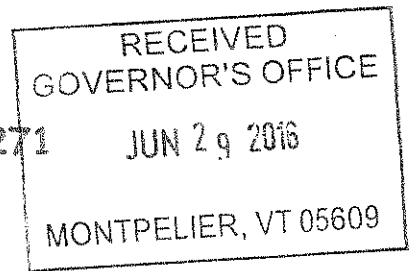

Dear Governor Schumlin:

My hope is that you will file this letter so , even though you will not be in office next year, that whomever is will not endorse another "Annual Ethan Allen Day" without reading this enclosed information.

I sent the enclosed letter in to the Burlington Free Press when I first saw your proclamation but it was too late to stop it. As you will see, June 24 was one of the worst days in Ethan Allen's life and not appropriate for celebration. May 14, the day that he and the Green Mountain Boys took Fort Ticonderoga would have been a much better choice. I belong to a group of Vermont historians who are trying to identify and locate the original Green Mountain Boys so we are all very familiar with Ethan Allen's life. It was a bit shocking to see the two full pages in the Burlington Free Press in such a big error. Hopefully, if someone there keeps the enclosed information it won't happen again and make your distinguished office look so bad.

June 23 being touted by Gov. Schumlin and the Ethan Allen Homestead as "the second biggest day in Ethan Allen's life" is a matter of opinion as to what one considers a "big day". According to the Library of Congress's Journals of the Continental Congress, 1774-1789, Volume II, 1775, Col. Allen (Colonel in the Vermont Militia only) and Captain Seth Warner (Captain of the Militia) were at the Congress on that day asking that their men who had taken Crown Point and Ticonderoga be paid for their efforts and ranked as were other soldiers in the American Army.

After discussion the Congress resolved that "their (the Boys) pay be the same as that of the officers and privates in the American Army; the highest of the officers not to exceed that of a captain...."

So, Ethan Allen and Seth Warner got their men designated as employed in the army and paid, but also it was declared that their men (the Green Mountain Boys) would appoint their own officers. The Congress did not appoint Allen and Warner as officers on June 23, 1775. Actually, that day was the beginning of a very bad patch in Ethan Allen's life. When they returned home from the Continental Congress in Philadelphia, the Green Mountain Boys chose Seth Warner as their regimental leader, not Ethan Allen and in the words of the author Willard Randall, "Ethan Allen was not even elected a Lieutenant!" Finally after imprisonment and torture by the British, two and a half years later, May 14, 1778, the Continental Congress awarded Ethan Allen an honorary title of Colonel with a monthly pension "for fortitude, firmness and zeal in the cause of his country".

Perhaps May 10 would be a better day next year to celebrate Ethan Allen. May 10th was the day he and the Boys captured Fort Ticonderoga, the first victory of the American Revolution.

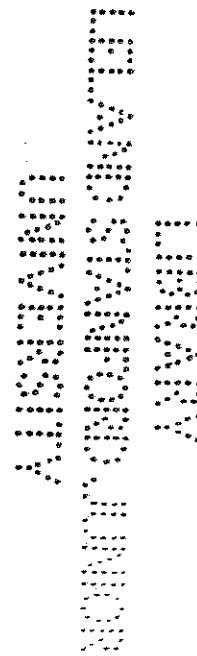

*Resolved*, That the colony of Pennsylvania raise two more companies of riflemen, and that these, with the six before ordered to be raised by them, making eight companies, be formed into a battalion, to be commanded by such field officers, captains and lieut<sup>ns</sup>, as shall be recommended by the Assembly or convention of the above colony.

*Resolved*, that this Congress will to Morrow resolve itself into a Committee of the whole to take into consideration the state of America.

Adjourned till to Morrow at 9 o'Clock.

FRIDAY, JUNE 23, 1775

The Congress met according to adjournment.

A letter from the officers of Crown Point, dated June 10, 1775 was laid before the Congress.

Information being given, that Col. Allen and Capt<sup>n</sup> Seth Warner who brought the letter were at the door, ||and had some things of importance to communicate,||

*Ordered*, That they be called in. After they withdrew, the Congress took the letter and information into consideration.

*Resolved*, That it be recommended to the Officer commanding in the New York department, to procure, as soon as possible, a list of the men employed in taking and garrisoning Crown Point and Ticonderogo, and keeping possession of the lakes, and also of their disbursements, in order that they may be paid.

*Resolved*, That their pay be the same as that of the officers and privates in the American Army; the highest of the officers not to exceed that of a captain, and that the pay commence the third day of last May, and continue until they are discharged.



*Resolved*, That it be recommended to the convention of New York, that they, consulting with General Schuyler, employ in the army to be raised for the defence of America, those called Green Mountain Boys, under such officers as the s<sup>d</sup> Green Mountain Boys shall chuse.

Upon motion, *Resolved*, That a committee of five be appointed to draw up a declaration, to be published by General Washington, upon his arrival at the Camp before Boston.

That the committee consist of the following members, viz: Mr. J[ohn] Rutledge, Mr. W[illiam] Livingston, Mr. [Benjamin] Franklin, Mr. [John] Jay, and Mr. [Thomas] Johnson.

Agreeable to the order of the day the Congress resolved itself into a committee of the whole, to take into further consideration the state of America, and after some time spent therein, the president resumed the chair, and Mr. [Samuel] Ward reported that the committee had come into certain resolutions which they desired him to report, but not having yet finished, they had ordered him to move for leave to sit again.

## Brevets Conferred from 1776 to 1812.

Copied by permission of Brevet Major General J. B. Fry, U. S. A., from his work entitled "History of Brevets in the U. S. Army,"—this work being compiled from the Official Records of the War Department.

**ALLAIN.**

January 13, 1779. The Board of War report, that the following named French gentlemen, having served as volunteers in Col. Armand's corps, with much reputation, as appears by the certificate of Col. Armand, and the recommendations of the Marquis de la Fayette and others are about to return to France, and therefore recommend that brevets be granted them, under the exceptions in the Resolutions against granting brevets, except to officers in the line, or in cases of merit, viz., to Monsieur Allain " " " the brevet of Lieutenant.

*Resolved*, That Congress agree to said report.  
*Resolved*, That the sum of 400 dollars be paid to each of these gentlemen to enable them to prosecute their voyage to France.

**ALLEN, ETHAN.**

May 14, 1778. *Resolved* That a brevet commission of colonel be granted to Ethan Allen, in reward of his firmness, fortitude and zeal in the cause of his country, manifested during the course of his long and cruel captivity, as well as on former occasions.

September 24, 1778. Whereas Congress did, on the 14th of May last, grant to Ethan Allen the rank of colonel by brevet in the army of the United States of America, in reward of his fortitude, firmness and zeal in the cause of his country, manifested during the course of his long and cruel captivity, as well as on former occasions; and whereas, on the 16th day of the same month, all the benefits and privileges of lieutenant colonel in the service of these States were granted to the said Ethan Allen during the time of his late captivity; and whereas it is represented to Congress that Colonel E. Allen's circumstances have been greatly reduced by his late long and cruel confinement, and his brevet commission does not entitle him to pay.

*Resolved*, That 75 dollars per month be allowed to Colonel E. Allen from the date of his brevet, during the pleasure of Congress, or until he shall be called into active service.

**ARCHER, JOHN.**

June 26, 1779. *Resolved*, That the brevet of captain be given to Mr. Archer, the bearer of the general's letter, and volunteer aid to Brig. Gen. Wayne.

**BEAULIEU.**

January 13, 1779. *Resolved*, That Congress agree to said report (cited in the case of Allain, and which recommends that the brevet of lieutenant be also granted to Monsieur Briffault).

*Resolved*, That the sum of 400 dollars be paid to each of these (French) gentlemen to enable them to prosecute their voyage to France.

January 15, 1786. *Resolved*, That Monsieur Briffault, who, on the 13th of January, 1779, was appointed to the brevet rank of lieutenant in the army of the U. S., receive a commission of lieutenant in Col. Armand's corps, to bear the date of his brevet.

**WHEREAS**, each year, hundreds of visitors, many of them school children and many veterans from all over America, tour the Ethan Allen Homestead Museum; and

**WHEREAS**, Ethan Allen's house, built according to his specifications in 1786 and restored exactly two centuries later, allows museum visitors to see how people lived day-to-day during Vermont's frontier days; and

**WHEREAS**, the Homestead -- house, garden and grounds -- is the state's only surviving home of a founder and his family -- a Founding Father of Vermont and of the United States; and

**WHEREAS**, Ethan Allen was Founder of the Green Mountain Boys, America's largest paramilitary force when the Revolution broke out; and

**WHEREAS**, Allen and 83 of the Boys, farmers, storekeepers, lawyers, freed blacks and impoverished immigrants, bloodlessly captured Fort Ticonderoga, providing the cannon needed by George Washington to drive the British out of Boston; and

**WHEREAS**, Allen's Green Mountain Boys were honored by the Continental Congress on June 23rd, 1775 and duly constituted one of the first Continental Army Regiments, with Ethan Allen commissioned as lieutenant-colonel its commanding officer; and

**WHEREAS**, Allen, impatient to launch a surprise attack on Montreal, was captured and spent nearly three years under harsh conditions as a prisoner-of-war of the British, his ordeal the subject of his bestselling captivity narrative, which went through eight editions during the Revolution and still remains in print; and

**WHEREAS**, champion of Vermont statehood, Allen was the author of at least four books and scores of pamphlets. Allen courageously went on to become the first published American philosopher, much of his writing, read by American leaders and French philosophers in Paris as well, took place in this Homestead, where he died in 1789; and

**WHEREAS**, Ethan Allen lived and farmed here with his wife Fanny, Ethan's three daughters, a son, two farmhands (a free African-American and a partially scalped Highland Scot who had fought at his side from Ticonderoga to Montreal) and possibly a lady's maid; and

**WHEREAS**, Ethan Allen was also a Founder of Burlington as the Allens, in this Homestead, were one family among only a handful in the Burlington area when they settled here; here, on Vermont's northwest frontier; and

**WHEREAS**, the Homestead is Vermont's Mount Vernon just as Ethan Allen is its George Washington;

**NOW, THEREFORE**, I, Peter Shumlin, Governor, do hereby proclaim June 23, 2016 as

**ETHAN ALLEN DAY**  
in Vermont.
