I am writing in regarding a tax situation that I experienced for the first time this year. My husband and I are considered middle class. We rent our home, we both work full time and we have worked very hard to save any money we are able to for our future. We also get our health insurance through Vermont Health Connect. This comment is in regards to our 2020 taxes. My husband is a farmer and I work at an online recycling receptacle/trash can company. The CEO of my company gives bonus's based on how much money we make per week/month/year. Last year during a time that was devastating to much of the economy, our business did incredibly well. We received bonus's on many paychecks that I immediately put into our savings account. As I'm sure you know, with VT Health Connect, you have to estimate what you think your income will be during the current year and you receive credits towards your insurance expense. I used the previous year's income for this estimation. Obviously, no one could have predicted the year we ended up having. Because of the bonus's I received, our 2020 income pushed us past the eligible limit to qualify for credits by a single digit percentage and we now have to pay the entire amount of our credits back. That totals \$7664.00. This will be all the money that we not only saved last year, but multiple years prior. This system is ridiculous and I am so disappointed that after a year of uncertainty and hard work, we now owe everything that we have worked so hard for. We feel helpless and defeated. I am a proud Vermonter. I honestly don't know where to go from here. Please pass this along to Lieutenant Governor Gray so we can, hopefully, prevent this from happening to other hardworking Vermonters.
