**Bills delivered today, due Thursday, May 14:**

- [H.62](#), relating to prohibiting a sentence of life without parole for a person who was under 18 years of age at the time of the commission of the offense. Public signing May 14.
- [H.241](#), relating to rulemaking on emergency involuntary procedures.
- [H.496](#), West Fairlee Charter.

- [H.361](#), Education bill. House conferees: **Sharpe, Juskiwicz and Donovan.**

- [S.73](#) rent-to-own. Senate will now consider House amendments.
- [H.508](#) approval of amendments to the charter of the Town of Middlebury.
