**1. Call to order:** The meeting was called to order at 1:33 P.M.

**2. Changes to the Agenda:**

**3. Approval of previous minutes:**

- Dr. Charles Foster motioned to approve the minutes from July 05, 2022 as presented. Dr. Michael Sommers seconded the motion. Motion passed.

**4. Legislative Updates:**

- American Chiropractic Association Support letter for H.R. 2654/ S. 4042
  - The Board reviewed the letter from the American Chiropractic Association Support regarding H.R. 2654/ S. 4042. Attorney Layman advised the Board about requirements and restrictions for lobbying by board members.

**5. Topics for discussion:**

- Developing Telehealth Licensing Rules Discussion
  - Attorney Layman reviewed the draft telehealth licensing and telehealth registration rules. The Board provided feedback. Attorney Layman advised the Board that the rules would be included in a broader rule regulating telehealth licensing and telehealth registration for 23 health care professions regulated by OPR.
- Board Officer Elections
  - Attorney Layman discussed the process for electing board officers. Dr. Charles Foster nominated Dr. Michael Sommers as the chair, Dr. Marna Bisaccia as the Vice Chair, and Dr. Charles Foster as the Secretary. Dr Marna Bisaccia seconded the motion for the slate of nominees. Motion passed.
- Veterinary Chiropractic practice
  - Dr. Charles Foster brought up the discussion of the Veterinary Chiropractic practice. Concerns were raised regarding the training of and education of a veterinarian that provides chiropractic services. Attorney Layman discussed
