### **MINUTES**

**August 14, 2023  
Remote Meeting**

1. **Call to Order:** The meeting was called to order at 9:01 a.m. by the Chair, Jennifer Laurent.

### **2. Approval of Minutes from July 10, 2023**

Daniel Coane moved to approve the minutes of July 10, 2023. Jennifer Lyon seconded. The motion passed unanimously. Douglas Sutton and Matthew Choate abstained. Jennifer Laurent advised of a spelling error; Jessican Burke should be Jess Burke. This was corrected.

### **3. Executive Officer Report**

Shiela Boni:

- Update on OPR office renovations: delayed due to flooding. In person meetings will resume once renovations are completed in late fall/early winter.
- Senate Health, Education, Labor and Pension Committee said that VT has a reasonable solution with LNA clinical competency evaluations being done with schools. Conflicting advice was obtained from the Vermont CMS representative. More clarity is being sought directly from CMS.
- DAIL sent an RFP out for LNA testing. Excel Testing was selected for the LNA testing contract starting in the fall.

- Shiela Boni requested the board review Lisa Turpin's request for reinstatement of LNA licensure.
  - Lisa explained her experience and history within the nursing field.

  - After review Douglas Sutton moved to approve the reinstatement of Vermont LNA licensure, Matthew Choate seconded. The motion passed unanimously.

## 6. Public Comment

- Tracy Dolan, Director of State Refugee Office with AHS discussed how her office works with Afghans and Ukrainians to facilitate joining the work force. These individuals would like to work in the nursing profession. There are a couple of barriers: translation of & transportation to proctored licensing exams. She would like to propose LNA testing provider provide interpreter/translation services for those who English is their second language.
  - Lauren Layman discussed that this in keeping with the SOV language access plan. The Nursing Board is obligated to provide language access for LNA exams. Now that DAIL has Excel Testing as the LNA provider they are familiar with providing interrupter access. It is on the test provider to use SOV interpreter services for any tester who needs it.
  - Shiela informed the Board that DAIL currently has interpreter services available through a State contract enabling interpretation for a variety of languages.
