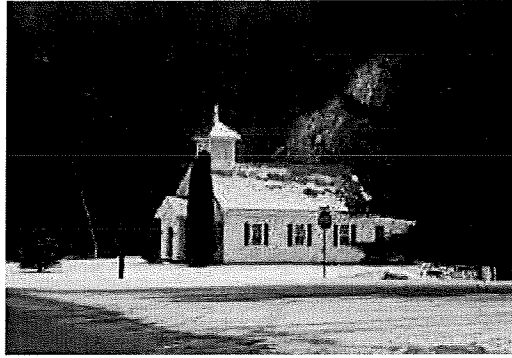

ABOUT OUR TOWN OFFICES

Serving in local office is a great way to give something back to your community. Your Town is always looking for those who wish to take part in their local government and who care to make a difference in their community. We currently have the following vacant positions: ***Two Auditors, 2^d Constable, Three Listers, Zoning and Planning and Cemetery Commission.*** If you are interested in any of the above positions, please contact any Woodford Town Officer.

MODERATOR (elected, 1 year term) -- Conducts the Town's meeting and other meetings upon request of services, using the "Robert's Rule" of conduct. 17VSA 2646(1)

TOWN CLERK (elected, 3-year term) -- Records, preserves and certifies the public records of the town, issues dog, marriage, and civil union licenses. Runs the local elections, serves as a Board of Civil Authority, and files tax abatement requests. Should be a good ambassador for the town. 17 VSA 2646(2)

TREASURER (elected, 3-year term) -- Is a Trustee of Public Funds. Keeps the Town's financial accounts, invests money, keeps a record of the taxes paid and pays orders drawn on by the officials. Should be very precise, detail oriented and good at math and communication. 17 VSA 2646(3)

SELECT BOARD MEMBERS (elected, 3-year term) -- General supervision and control over town, enacts ordinances, regulations and policies for town, oversees town property and personnel, prepares, presents and manages budget, oversees roads, including laying out, discontinuing and reclassifying roads. Sits as local board of health, liquor control commission. Should know the town well, be able to understand all sides of complex issues. 17 VSA 2646(4); 17 VSA 2649

TRUSTEE OF PUBLIC FUNDS (3-year term) Trustees include the three Select Board Members and the Treasurer. 17 VSA 2646(12); 24 VSA 2431 et seq.

GRAND JUROR (appointed, 1 year term) - Helps to prosecute criminal offenses that occur in the town by giving information to state and local law enforcement. 14 VSA 2646(10). This position was **repealed** as an elected position July 1, 2018 (H829) 24VSA 871 but Selectboard may appoint if desired.

TOWN AGENT (Repealed July 1, 2020 (H143) Act 84.

LISTERS (elected, 3-year term) -- Appraise property within the town for the purpose of property tax assessment. Should be able to conduct themselves in a polite, yet firm and fair manner. 17 VSA 2646(5)

DELINQUENT TAX COLLECTOR (elected, 3-year term) -- Collects delinquent taxes for the town. Should be good with numbers and also able to work with people who are in difficult circumstances. 17 VSA 2651(d)

CONSTABLES (elected, 1 year term) -- Confronts animal control issues through a civil process. Should be good at de-escalating and resolving conflicts. 17 VSA 2646 (7)

AUDITORS (elected, 3-year term) -- Review and audit all town accounts and prepare the annual town report. Responsible for the proper financial accountability of the Town by ensuring that an annual audit is done. Should be very detailed oriented through "internal controls". 17 VSA 2649

SCHOOL DIRECTORS (elected, 3-year term) – Develops educational policies, develops and follows school mission, responsible for keeping school property & equipment in good repair, reports to the public finances, conditions and needs of the school, determines budgets and tax levels, may serve as arbiter in disciplinary actions brought to the board. 16 VSA 563

MAUHS REPRESENTATIVE (elected, 3-year term) –Responsible for the same as school director. Consider the operations of MAUHS and MAUMS in the best interests of all sending districts.

CEMETERY COMMISSION (appointed, 3-year term) -- A board of five members. Maintains the mowing, cleaning, and Veterans graves. Records sales of lot purchases and locations of lots. 18 VSA 5373

REGIONAL PLANNING -- Independent. Two-member board. Works with the Bennington Regional Planning Commission.

HEALTH OFFICER -- Select Board Members. Enforces the rules and regulations for the prevention of public health hazards. 18 VSA 601

ZONING ADMINISTRATOR (appointed, 3-year term or longer) -- Receives and files sewer, water, and building/construction permits. Follows up on the progress of permits issued and records them for the lister's information. Also "warns" the permitting process, if necessary. 24 VSA. 4448

ZONING AND PLANNING -- (appointed, 1 year or longer) Five-member board. Prepares a municipal plan, making recommendations on matters of land development, conservation, preservation, and participating in a regional planning program. Makes site plan and subdivision permit decisions. Should have a good working knowledge of all aspects of the town and be able to listen to many sides of an issue. 24 VSA 4460

JUSTICES (elected, 2-year terms) -- Five-member board. Performs weddings and other pertinent duties for the town, such as notary requests, election officials at town elections by Australian ballot and statewide elections. They are Board of Civil Authority and Board of Abatement members. 17 VSA 2103(10)

Office of the Town Clerk

I hope this letter finds everyone healthy as we have all struggled through yet another year of the Covid-19 pandemic. Once again we have been challenged in new and unexpected ways during 2021. We can only hope that the end of this pandemic is near and that we can all return to what each of us consider to be a normal life with normal family vacations and gatherings, social activities, conversations and adventures. Let's hope 2022 will be that year. I hope everyone had a happy, safe and healthy 2021 holiday season. With another new year ahead of us, we can now put this past year behind us and look forward to what the new year will have in store for us. As we again survive these unprecedented times with all its challenges we can continue to work towards a happy, healthy and safe life. As we put 2021 behind us let's move forward to a healthy, happy and prosperous 2022.

This year was very busy with property sales and transfers, much more than normal for our town. We lost longtime residents and long term nonresident property owners. However, we gained more new residents from people who purchased from a nonresident and have chosen to live in our community. We welcome all of them and look forward to meeting them in person soon. If you are new to our town and would like to be included on our town's list serve to receive meeting minutes, notices and town information, please notify the town clerk's office with your email address and we will get you added. This is a good way to stay informed as to the business of the Town and upcoming events.

The following is information I hope you will find helpful. If you have any questions on anything or have something specific you would like to be included in the Town Report please don't hesitate to reach out to any Town Official.

ELECTION INFORMATION

This year the legislature made several changes to the election laws. Following the temporary changes made in 2020 due to Covid-19 the State has enacted S.15, Act 60. The most significant change is that ballots for each November General Election, beginning with the 2022 General Election, will be **mailed** to all active registered voters and therefore an absentee ballot request for this election will not be necessary. These ballots will begin to be mailed through the Secretary of State Office no later than 43 days before the election and completed no later than October 1. Mailing addresses will be taken directly from the Town's voter checklist so be sure the Town has your current mailing address on file. This process is the same process used during the 2020 General Election due to the Covid-19 pandemic. This law does not remove in person voting for this election, which is always an option whether or not you receive your ballot by mail and the polls will be open as usual. This law only applies to the **General Election**, all other elections are conducted as they have been in the past unless the Select Board votes otherwise. Absentee ballots for all other elections are available upon request as always. If you are not a registered voter but would like to be, voter registration is available on any election day while the polls are open, through automatic voter registration at the motor vehicle office (the motor vehicle dept. automatically registers you to vote in the town you live when you renew your license unless you specify otherwise), online at <http://olvr.sec.state.vt.us> and during the Town Clerk's Office hours.

- Absentee Ballots: Voters may vote absentee/early ballot in many different ways:
 - **Vote in Office**- Voters may fill out a request and vote in person at the clerk's office, complete and sign the certificate and return the ballots without leaving the clerk's office. This can be done during all regular business hours before the closing of the town clerk's office and on the day before each election.
 - **Take from Office**- Voters may fill out a request and, **only the voter**, may take the ballot from the clerk's office. The ballot can be returned by anyone as long as it is in the certificate envelope.
 - **Mail**- Voters can request absentee ballots through the My Voter page, email or phone call. The ballot will be mailed to you and must be returned to the clerk before the close of polls on Election Day.
 - **Electronic**- Ballots can be electronically delivered to overseas or military voters along with ill, injured or disabled voters for State elections. This process can only be done through My Voter Page. This allows voters with a disability to use the online accessible ballot marking device from home during the early voting period. Once the request is approved by the clerk the system will send an email to the voter that night with instructions on how to access the ballot. Local ballots are sent through the Town Clerk's office with specific instructions. All electronic ballots must be returned by US mail.
 - **Home Delivery**- Pairs of Justices of the Peace may deliver absentee ballots to voters who are ill or voters with disabilities. The request must be made by the close of the town clerk's office the day preceding the election. Once the JP's have reached an absentee voter, the JP's must work as a pair to present the ballots and envelope to the voter, who may then vote in private or in the presence of both JP's.

The law allows a voter to make a single request for absentee/early ballots for all ballot elections scheduled in a given year (including town/school votes, special elections, state primaries) as long as the "mail to" address is the same for all elections. Please note that this single request must be made annually.

Any voter, family member, health care provider or authorized person can request an absentee ballot in Vermont without any reason. Voters who want to vote by absentee ballot may apply to the clerk before the closing of the town clerk's office on the day before the election. Only a voter, family member (spouse, child, brother, sister, parent, spouse's parent, grandparent or spouse's grandparent), or health care provider may request a ballot for another person by phone. All requested ballots for any person other than the voter themselves will be mailed to the voter. An application for an early voter absentee ballot may only be valid for any elections within the same calendar year.

- My Voter Page, launched in 2016, is the State of VT's newest election management platform. By using My Voter Page, a registered voter can check voter registration status, view information on upcoming elections, poll location and hours, view a sample ballot, request and track an absentee ballot, view registration information on file with the town office, challenge letter response and take the oath. To use this system registered voters can log in at: <http://mvp.sec.state.vt.us>.

- The Accessible Voting System is available for all state and federal elections. It was introduced and used for the first time in 2018. The system was designed for those voters who may be blind or have any other disability but this voting option is available for any voter who may be interested in using it. It's a very simple system to use so if interested just ask any election official at the polls.

UNCLAIMED PROPERTY: Included in the town report is a list of those people who currently live in Woodford or did at one time who has unclaimed property in 2021, usually money. If you have lived in more than one Vermont town then be sure you check those also. You can check at <http://www.vermonttreasurer.gov/unclaimed-property> for the most current listing. The process to claim your property is very simple and worth checking into.

DOG LICENSE: April 1, 2022 is the deadline to register your dog. Any dog that is more than six (6) months old must be registered and licensed annually on or before this date. Proof of sterilization and rabies certificate must be provided at the time of licensing if not already on file. The fee for a spayed or neutered dog is \$9.00 (\$11.00 after April 1st) and \$13.00 for unneutered or unspayed dog (\$17.00 after April 1st).

Rabies clinics are available at Tractor Supply in Bennington on 2/12, 3/12, 4/09 and 5/07/2022 from 4-5:30pm.

HELP: You may be eligible for free tax help through the IRS, AARP or MyFreeTaxes.com. To learn where to find tax help visit tax.vermont.gov/free-prep. Tax forms and instructions are available online at tax.vermont.gov, call 855-297-5600 or email tax.formsrequest@vermont.gov.

HOMESTEAD DECLARATIONS: Homestead declarations need to be submitted by April 15th, 2022 in order to qualify for the resident education tax rate. By submitting this form on time you will receive an accurate tax bill and avoid any late penalties or fees. Filing for an extension for your income tax does not include the homestead declaration.

GREEN MOUNTAIN PASSPORTS: Green Mountain passports are available at the Town Office for \$2.00. This entitles you to free admission to Vermont State Parks (including Woodford State Park), Vermont Historic Sites and events which are fully State sponsored. To be eligible you must be a legal resident of Vermont and Woodford and be either 62 years of age or older or a veteran of the uniformed services.

SOUTHERN VT COMMUNICATION UNION DISTRICT (SoVT-CUD)

Communication Union District is a governance structure allowing multiple towns to band together to resolve their internet problems as a region and bring high speed internet to all. The Town of Woodford voters approved by ballot in 2020 to join the SoVT-CUD along with 13 other towns. Each town has a representative as part of the governing board with decision making capabilities. Currently, Woodford does not have a representative and is looking to fill this position. You can find more information or minutes of past meetings at <https://sovcud.net>.

ZONING AND PLANNING

PERMIT INFORMATION

The Town of Woodford has zoning regulations in place. Before any land or building is devoted to a new use or change of use, or before the erection of any building or land development, a zoning permit shall be obtained prior to any activity. If you are planning on doing any construction or renovation projects, please inquire to see if you will need a permit before you start. This will save everyone time, money and frustration. You can contact the Town Office at woodfordvt@comcast.net or James Kinney, zoning administrator, at woodfordzoning@comcast.net.

Permits are required for:

- ♦ Construction of anything larger than 36 sq. ft. This includes new homes, additions, decks, porches, mud rooms, garages, outbuildings or sheds and cargo or shipping containers, portable and non-portable;
- ♦ Change in residential property use such as a home occupation or a business activity;
- ♦ Commercial property improvements or use change;
- ♦ Subdivisions or boundary line adjustments;
- ♦ Addition of a pond or swimming pool;

A permit application must be submitted with all required documentation as stated on the application form, including the fee of \$75.00. The application will be reviewed and forwarded to the governing body authorized to approve the permit, the Zoning Administrator, Zoning Board of Adjustments or Planning Commission. Once an application is approved the permit is good for 2 years before it expires and a new or extended application needs to be submitted.

In addition to the Town of Woodford Regulations, Woodford Lake lots must also comply with the Woodford Lake Association Regulations.

In some instances state permits may be required. Landowners are responsible for obtaining all necessary state permits pertaining to their particular project along with local permits. All septic and wastewater permits are issued through the State of Vermont and not approved at the local level.

The Planning Commission recently revised and updated the zoning regulations. These revised regulations were approved through separate public hearings by the Planning Commission and the Select Board. Final approval was completed on July 15, 2020. Revisions are made periodically in order to keep up with the current and future needs of the Town and to make them compliant with any new State laws. The board appreciates any suggestions, comments and ideas from Woodford tax payers and welcome all to attend any meetings. If you would like an electronic copy of these regulations or a zoning application, contact the Town Clerk or Zoning Administrator as noted above.

THE WOODFORD TOWN SCHOLARSHIP

- Purpose:** To recognize the achievements and to encourage the potential of Woodford students graduating from High School.
- Eligibility:** The Woodford Town Scholarship Fund will be awarded after the review of the selection committee. The selection committee consists of the Woodford Hollow Elementary School Principal and the Woodford Town Treasurer. The award is to that graduating senior that resides in the Town of Woodford, has applied to and been accepted in a program of further education and who, in the opinion of the committee and on the basis of their high school record, has demonstrated the greatest potential for success in academic or vocational study. The Scholarship will be awarded by the Woodford Select Board based on the recommendation of the selection committee. Notification of the awardees' scholarship will be given to the Woodford Board of Education.
- Presentation:** Award will be made at the Mount Anthony Awards Night or other high school's awards night. The award is given to the college in the name of the awardee upon notification of the college that the awardee is in attendance.

By dialing **2-1-1** or by texting your zip code to **898211**, you will receive up-to-date information and referrals on health and human services for your area and region. (Text between 8:00am-10:00pm, Monday-Friday.) Our 2-1-1 system in Vermont is at the fingertips of every resident and every phone. 2-1-1 is cost-effective, high quality, personal, flexible and community-based.

Can't find what you need? You can always reach one of our trained professionals by phone or by text. Vermont 2-1-1 is here to offer help and to offer hope.

- One call or text gives you access to resources across your community. 2-1-1 is efficient, fast and easy to use.
- No more wrong numbers; no more wasted time trying to find the right resource(s).
- 2-1-1 is a private and confidential call or text; most often the name of the caller is not even taken. Language translation services are also available.
- 2-1-1 maintains the integrity of the 9-1-1 system; saving that vital community resource for life and death emergencies.
- 24-hour availability every day of the year by phone or by clicking on vermont211.org
- 2-1-1 is an easy way to find or give help in your community.

In times of disaster, Vermont 2-1-1 plays a critical role in bringing information to the people most affected by the events and relaying the needs of callers back to the government officials and the first responders.

What are the needs in your community?

Vermont 2-1-1 collects town, county and statewide data and feeds it back to communities to help make systemic change. Monthly reports showing the needs of your county are available on our website.

In 2021, residents of **Bennington County** contacted 211 by phone or text **1,442** times, resulting in **1,633** referrals. The top services sought were housing/shelter, public assistance, and public safety. There were **386** searches of 211's database conducted by people identifying themselves as Bennington County residents.

County-wide, 48% percent of referrals were for Basic Needs, most of which were for Housing and Shelter in the form of homeless shelters and other accommodations. Other basic needs included Utility Assistance, Transportation, Food, and Material Goods. Fourteen percent of referrals were for Income Support and Employment, mostly for Public Assistance, including general relief, 3SquaresVT applications, and Reach Up applications, as well as temporary financial assistance. Almost 25% of referrals were for Organizational and Community Services, such as specialized information and referral services, which include referrals to Help Me Grow Vermont and SW Vermont Council on Aging. The agencies given the most referrals were the Vermont Department of Children and Families—Economic Services Division, Vermont Department of Health, BROCC Community Action, Vermont Foodbank, Greater Bennington Interfaith Community Services, and Help Me Grow Vermont.

Vermont 2-1-1 Partners with Help Me Grow

Vermont 2-1-1 participates in the Vermont Department of Health's statewide Help Me Grow initiative. Help Me Grow provides a centralized telephone access point, via Vermont 2-1-1, for parents, caregivers, and providers to get information and referrals for local services for children birth through age eight. The Bennington County Solid Waste Alliance works to reduce the amount of waste disposed in landfills by promoting recycling and reuse as well as resource conservation. The Alliance offers education and outreach to businesses, schools, institutions, and event organizers in complying with the Universal Recycling Law and other solid waste management requirements primarily by increasing reuse and recycling. These programs help residents, businesses, schools, and institutions find solutions to recycling, food scrap diversion and the disposal of items such as electronic waste, fluorescent bulbs, paint, and others that are banned from landfills.

The Alliance launched an expanded website at www.bcswa.org and hosts a Facebook page (www.facebook.com/solidwastealliance) which provide information on:

- battery recycling through the Call2Recycle program
- disposal of used motor oil at retail establishments and transfer stations that accept motor oil
- recycling of paint through the PaintCare program, including retail stores that accept paint
- prescription drug disposal including drop-off locations
- recycling of textiles by the Apparel Impact, Goodwill, and others
- events for disposing household hazardous waste
- disposing of fluorescent bulbs, compact fluorescent lamps (CFLs) and other mercury items at transfer stations and retail establishments
- disposal of E-Waste at area transfer stations, Goodwill, and retail establishments
- diverting food scraps by composting and annual sales of compost bins and kitchen containers
- resources for businesses, schools, events, institutions and residents

During 2021 the Alliance assisted forty businesses, several major event organizers including Garlic Town, made a recycling presentation to summer campers at Lake Paran, and hosted tables at several farmers markets. On-site presentations were provided to Bennington Elementary and Sunderland Elementary schools to teach students about recyclable materials. Forty pieces of composting equipment were also sold through two distribution events.

The Alliance held three household hazardous waste events serving 666 households, a number that continues to increase each year. In 2022, three household hazardous waste events will be held for residents and small businesses of all thirteen towns within the Alliance. The spring event will be in Bennington and the fall in Dorset. A third event will be held for residents and businesses of Searsburg and Stamford to accommodate the greater distance they have to either of the other events. Visit bcswa.org for updates and details. The Alliance receives most of its funding from the thirteen towns along with grants from the Vermont Agency of Natural Resources and the Agency of Agriculture and Markets.

Vermont Spay Neuter Incentive Program

The VT Spay Neuter Incentive Program aka "VSNIP", under the oversight of the VT Economic Services Department, is administered by VT Volunteer Services for Animals Humane Society (VWSA). VSNIP helps financially challenged Vermont residents spay/neuter cats and dogs for \$27.00. The balance is paid by fellow Vermonters when dogs are licensed by an added \$4.00 fee, the major funding for this important program. Funds are determined by the number of dogs licensed, which is required by law when a dog is six months of age. A current rabies vaccination is required to register, and a rabies vaccination can be administered after 12 weeks of age for both cats and dogs.

Prostrate and mammary cancer is more likely to occur in unsterilized cats and dogs. It's not pretty and they're likely to die. Animals live longer and happier when they're spayed and neutered, are less likely to fight for territory, and mark what they claim to be "theirs"!

Licensing a dog: 1) helps identify your dog if lost, 2) provides proof your dog is protected from rabies in the event your dog is bitten by a rabid animal, but would still need immediate medical attention, 3) if your dog bites an animal or person – which could result in quarantine or possible euthanasia to test for infection, and 4) helps pay for VSNIP, addressing the population situation in Vermont.

Farms with cats should especially be aware that one rabid cat or dog can affect an entire population of animals on the premise. The answer is neutering through VSNIP which includes a rabies vaccination and the first of the two part distemper series.

Look for Rabies Clinics in March across the state. You can call your veterinarian and ask the cost of a rabies vaccination only, or call your nearest Tractor Supply Store for their Monthly Rabies Clinic schedule. Rabies IS in Vermont and it IS deadly.

Tales of South Woodford

Introduction written by Henry B. Walbridge ca 1943

Our Woodford Town Office houses a treasure-trove of history about our little town. Here is an excerpt from a document found in a box that contained local history researched by John Irons. This is a shortened version of the Tales of South Woodford introduction. The entire document can be found in the file drawer entitled "Historical Information".

Introduction

There are many old stories about the folks who lived on Woodford's old turnpike a hundred to a hundred and fifty years ago. (ca 1790 to 1840). There is little truth in some of these stories but they are still worth repeating if the truth about the people concerned can be discovered at the same time. It will take a lot of words to do that. Should readers prefer a mere summary of the facts, it is presented here. Should they care for more detail about some of the people or places mentioned in the summary below, the relevant chapter numbers are inserted for convenience.

Summary

(This summary is shortened due to length. Please note that the number correspond to the numbers in the original document. Hence, there are numbers missing here)

1. Woodford was early divided into two districts by the establishment of an arbitrary boundary called the Bingham Line. The Hamlin District stretched eastward over five miles to Readsboro and

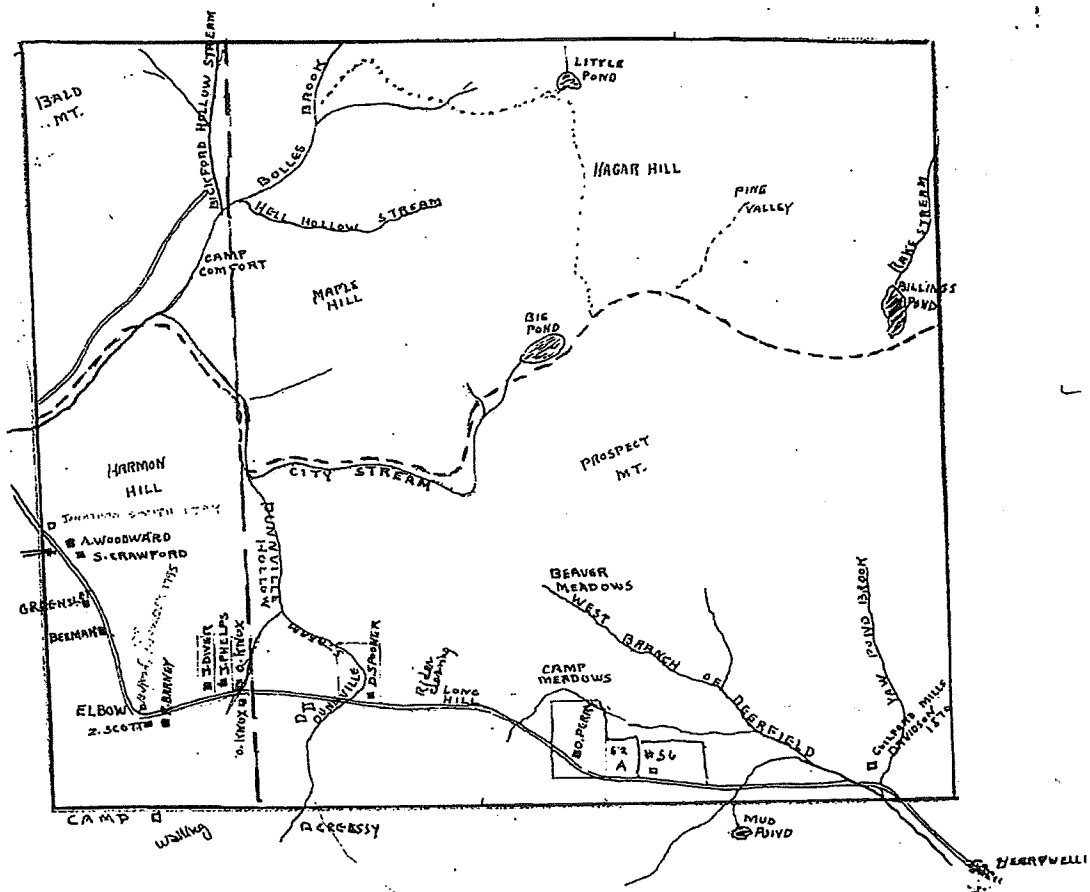
Searsburg. The Robinson District extended westward about one and two-thirds miles to Bennington's east line. Most of the people lived in the western quarter of the town.

2. Location of early roads and homesteads virtually separated the town into North Woodford and South Woodford. The story of South Woodford is essentially the story of the Old Turnpike. This road with its habitations can best be considered as consisting of three sections; the first (furthest east); in the Hamlin District (about 5 miles); the second from Bingham Line (west) to the "Elbow," nearly a mile; and the third from the Elbow to the Bennington line, about 1.6 miles. (See map drawn by Walbridge below)

3. The Bigelow Pitch was probably the first inhabited place on the east part of Woodford's old Turnpike. Lt. Johnathon Rich built a camp Bigelow sold to Caleb Moore in 1790. Moore sold to Martin Scott in 1794. Scott sold it in 1796. More about the Bigelows later.

26. Arnold Woodward was a later occupant of a part of Robert Hill's land. He built, about 1824, what is now the Harry Walker place, about opposite the end of the Gore Road. His father, Ichabod Woodward, did not live long in one place. (Note, this house is now owned by Dick Frantz and Nancy Coleman of Woodford)

30. Stage coaches traveled over the old Turnpike Road for well over 30 years, until a new turnpike was completed. There were stories about some of the old stage drivers.

TOWN OF WOODFORD- DELINQUENT TAX COLLECTION POLICY

Summary

Town and school budgets are set in anticipation of the collection of property taxes and taxes not paid by some property owners shift the cost burden onto those that do. It is the best interest of the Town of Woodford and its residents that property taxes be paid when they are due.

Woodford's collection policy recognizes that individuals may go through periods of financial difficulty, but in order to be fair to all town taxpayers, the policy asserts that, as a matter of principle, shifting the burden of one property owner's debt onto other property owners in the town is not appropriate. A taxpayer who becomes delinquent is encouraged to find alternative resources to pay in full as soon as possible.

Delinquent taxes represent a lien on the property that will remain in effect until the delinquent taxes, plus penalty and interest, have been paid in full.

Purpose

The purpose of this policy is to treat Woodford taxpayers fairly by establishing clear guidelines that relate to the collection of delinquent taxes.

Policies

Notices

- The Delinquent Tax Collector will send a notice to each delinquent taxpayer indicating the amount of delinquent taxes, penalty and interest owed within 15 days of receiving the warrant from the Town Treasurer and each quarter thereafter.
- The initial delinquency notice shall include a statement explaining tax abatement options for the delinquent taxpayer (see attached), as well as the steps needed to make adequate payment arrangements (see below).

Penalty and Interest

Delinquent taxes shall be assessed a penalty of 8% of the total tax due, plus monthly interest on the outstanding balance as follows: an interest rate of 1% per month (or partial month) for the first 3 months, increasing to 1.5% per month (or partial month) on months thereafter until the total balance is paid in full.

Payment Arrangements

Payments in full are preferred but payment plans can be an option using the following criteria:

- Only payment arrangements that will pay the bill in full before the due date of the next year's tax bill will be accepted.
- Delinquent taxpayers shall submit a written payment arrangement proposal to the Delinquent Tax Collector by midnight, December 31st of same year taxes were due. The proposal shall outline the intended monthly payments and should be accompanied by a good faith payment to the Town.
- Delinquent Tax Collector shall have an approved payment plan with the delinquent taxpayer by January 10th of the new tax year.
- Partial payments will be applied first to the interest portion of the amount due. Any remainder will be divided proportionally between the outstanding principal amount of the tax and the 8% penalty.
- Violation of the payment arrangement including, but not limited to, a check returned to the Town for insufficient funds shall make the payment arrangement null and void and payments not fulfilled before the next tax due date will initiate a tax sale immediately.
- Costs, including those associated with returned checks may be included in setting the tax sale amount.
- The Town reserves the right to deny any payment arrangement that does not meet the above criteria.

Regular Procedures

- Payments may be mailed or hand delivered to the Delinquent Tax Collector.
- The Collector will issue a receipt to the property owner for every payment.
- On a monthly basis, the Collector will deliver to the Town Offices a copy of each receipt issued during the previous month (and retain a copy for his/her records).
- A payment will be credited based on the postmark date or the Town official stamped date received.
- Postdated checks will not be accepted. Requests to hold checks for later deposit will not be honored.
- Cash payments will be accepted at the discretion of the Town official to whom the payment is tendered.

In accordance with "Government Auditing Standards", we have also issued our report dated November 21, 2021 on our consideration of the Town of Woodford, Vermont's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing and not to provide an opinion on internal over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with "Government Auditing Standards" in considering the Town's internal control over financial reporting and compliance.

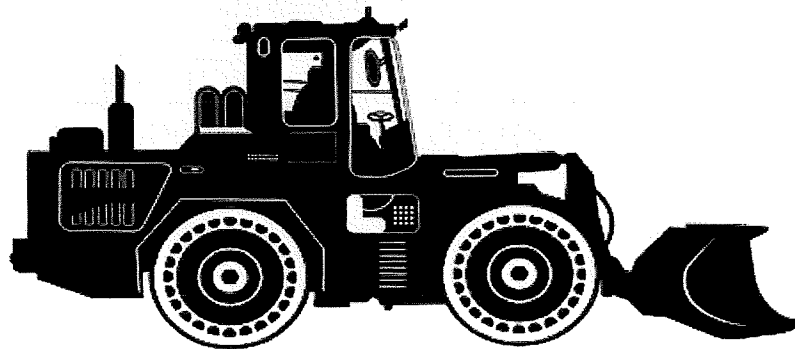





To our Member Towns and their Residents:

The Southern Vermont Communications Union District, a political subdivision of the State of Vermont, is a multi-municipal organization working to solve the longstanding rural broadband connectivity challenges in its fourteen member towns. Since forming in March of 2020, the CUD has grown to include Arlington, Bennington, Dorset, Landgrove, Londonderry, Manchester, Peru, Pownal, Rupert, Sandgate, Shaftsbury, Sunderland, Winhall, and Woodford.

In 2021, after issuing a Request for Qualifications and receiving multiple private sector responses, the CUD formed a public-private partnership with Consolidated Communications to ensure that currently unserved and underserved areas of the CUD are provided with world-class fiber broadband built out to the premises. In partnership with CCI, the Southern Vermont CUD submitted an application to the National Telecommunications and Information Administration's broadband infrastructure grant for a \$9.05 million fiber optic buildout program, and expects a determination in February 2022. A successful application, combined with separate fiber optic broadband incentives under the FCC's Rural Digital Opportunity Fund, will realize broadband buildout to 97 percent of the 2,500 unserved and underserved addresses in the district, with construction scheduled to begin in the second quarter of 2022. We are pleased to inform the public that, under the terms of the partnership with CCI, the CUD would retain ownership of all physical assets built with federal dollars.

While we are confident in our application, we also wish to assure the public that this is not the region's only pathway to connectivity. The Vermont Community Broadband Board recently announced the availability of funding under the Broadband Construction Grant Program, a provision of Act 71. Under this program, the CUD would be eligible for \$4.34 million of funding to build out a fiber optic broadband network. We are in the process of developing multiple application scenarios for this grant, and will submit the proposal most appropriate for the forthcoming NTIA funding decision.

By way of closing, we would like to thank the many people and organizations who continue to support our work: the Department of Public Service; the Vermont Community Broadband Board; the Vermont Community Foundation; our elected officials; and the Bennington County Regional Commission. Most importantly, however, we would like to recognize the delegates that you have appointed to the CUD's Governing Board. They have dedicated their time and energy to solving an immensely difficult problem, and we would not have made the progress that we have made to date without them.

This year marked PAVE's 40 year anniversary of providing compassionate, concrete support to survivors of domestic and sexual abuse. PAVE continues to be the only agency providing these services in Bennington County. Our goal is to promote a world where all peoples can be empowered to have fulfilling, safe relationships free from violence. We do this by providing services (that) (not only) provide services) in times of crisis but provide services that educate, heal and empower as well.

In the last 40 years PAVE has grown from a crisis hotline to an agency offering multiple, comprehensive services. The cycle of abuse is often multi-generational and because of this knowledge PAVE offers prevention services through education and community outreach as well as direct services to survivors.

This past year brought unique challenges due to COVID 19 and the precautions that we all needed to take to keep our communities safe. PAVE understood that to quarantine would create new barriers for survivors trying to flee domestic or sexual violence. In response, our hotline remained open and fielded 293 calls. In addition, we received 805 calls seeking services and support to our main agency line during the past year.

Our advocates worked hard to continue offering support to survivors, while working remotely providing 101 interactions through internet contact alone. Despite the challenges of the pandemic, PAVE remained available and vital to the community. PAVE served 2 residents from the town of Woodford, providing them with 7 supportive interactions in the past year. Our supervised visitation program also remained active providing remote visit options to parents and children, to keep them connected, despite not being able to physically see each other. This program offered 376 visits throughout the past year and has moved back to offering in person visits.

Domestic violence is the third leading cause of homelessness among families. For this reason our shelter remained open throughout the pandemic. Our shelter offers the only short term emergency housing for survivors of domestic violence in the county. Pave provided 1,057 nights of shelter last year, to survivors fleeing domestic or sexual violence.

PAVE is asking for level funding this year; \$100.00.

On behalf of our board of directors, staff, and the families we served, I thank the Town of Woodford for your ongoing support. It allows us to create greater opportunities for those that are impacted by domestic and/or sexual violence, and need our services each year.

BCRC Annual Report and FY 2023 Municipal Assessments

Dear Mr. Ryan Thurber:

The Bennington County Regional Commission (BCRC) provides planning and economic development support for seventeen towns and villages. Most of the BCRC's funding is derived from grants awarded by state and federal agencies, including the Vermont Agency of Commerce and Community Development, the Vermont Agency of Transportation, the Vermont Department of Environmental Conservation, the Vermont Department of Emergency Management, the US Environmental Protection Agency, and the US Department of Agriculture. A critical component of the organization's funding, however, is obtained from the annual appropriations received from its member municipalities. These funds are necessary to meet local matching requirements for many of the grant programs and to support our direct assistance to municipalities.


The BCRC maintains an office at 210 South Street in downtown Bennington. The Commission is overseen by municipally appointed commissioners from each of the member towns and villages as well as commissioners representing specific interests such as economic development, housing, transportation, and public health. The BCRC currently employs nine full-time and one part-time staff, with additional assistance provided by a VISTA through the SerVermont program. Principal areas of work with assigned staff responsibilities include: municipal and regional planning, community and economic development, transportation, environmental planning, emergency management planning, energy planning, public health, and solid waste planning and management. The BCRC provides contracted staff support to the Bennington County Solid Waste Alliance and the Bennington County Industrial Corporation (BCIC), while working cooperatively with numerous community and business organizations.

The BCRC has provided assistance to municipalities and businesses during the Covid-19 pandemic, while working through the logistics of maintaining our own operations. The office transitioned to remote work and meetings last year and, while staff do now spend some time each week in the office, it generally is easiest to contact us via email (see the contacts page at www.bcrcvt.org). Fortunately, technology has allowed us to continue work on all of our projects with little interruption in progress. Of course, significant staff resources have been dedicated to providing assistance to businesses and municipalities as they work to navigate the challenges associated with the pandemic, and also to take advantage of new programs designed to support economic recovery and long-term resilience.

The BCRC's budget for FY 2022 is \$1,344,257 of which \$102,686 is provided through town and village member dues. The organization's operating budget has increased significantly over the past decade as additional responsibilities have been assigned to regional planning commissions and with initiatives to improve efficiencies through the consolidation of regional programs (such as economic development, emergency management, and solid waste) under its umbrella. We have not changed formula used to calculate municipal dues for the past four years, although some adjustments were made this year following release of new US Census population figures. **For the coming year, based on Woodford's population of 355, the BCRC appropriation request is \$3,000.**

The Tutorial Center respectfully requests to be on the Woodford Town ballot again for March 2022, for the FY'23 year in the amount of \$300.

The Tutorial Center's mission is to assist individuals and organizations interested in meeting their educational and vocational needs for both youth and adults. The Center is committed to a philosophy which respects student goals, builds on students' strengths, and seeks educational approaches most appropriate for each student.

The past eighteen months have certainly presented some challenges for The Tutorial Center. While only closed to in-person learning for 4 months during the pandemic, in 2020, the Center had to offer virtual classrooms. We trained staff and purchased laptops to accommodate moving our learning model online. We have continued virtual classrooms as well as in person and blending learning, while many of the agencies we work with are still working remotely.

The Tutorial Center works closely with the social service agencies in the area, such as the Dept of Labor, Economic Services, PAVE, DCF, CRJ, and UCS to name a few. Though our main mission is education, we know there are many barriers to education for our students. We work closely with our students to help minimize these obstacles. We have a transition counselor to help students overcome these barriers, as well as direct them to the specific services they may need.

Our education services include tutoring for all ages; Adult Education and Literacy (which includes an alternate pathway to a high school diploma-the High School Completion program); English language classes for non-English speakers (ESL); GED preparation and testing; job readiness training; basic technology training for individuals and businesses; and our long-standing Youth Agricultural Program (YAP), as well as Integrated Educational.

Woodford's town appropriation funds support our tutoring work, enabling us to offer scholarships to students who need assistance. In addition, we work closely with the area schools to be a resource for them. We currently have 2 Woodford students in our Adult Ed classes

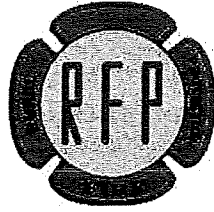

Re: **Request for Town Appropriation, Vermont Rural Fire Protection Program**

Dear Board of Selectpersons, Town Clerks and Auditors:

On behalf of the Vermont Rural Fire Protection Task Force, I am writing to request your support of the Vermont Rural Fire Protection (RFP) Program, formerly called the Dry Hydrant Grant Program. The RFP program helps Vermont communities protect lives, property, and natural resources by enhancing fire suppression resources. Program Manager and Engineering Technician Troy Dare helps local fire departments identify appropriate sites for dry hydrants and other rural water supply systems, design installations, and find financial support to support the costs of construction. During the **23+ years** of the program, almost **1200 grants** totaling over **\$2.6 million** have been provided to Vermont towns for installation of new rural fire protection systems, as well as for replacements and repairs.

The Rural Fire Protection Program is managed by the Vermont Association of Conservation Districts (VACD). VACD is the membership association of Vermont's fourteen Natural Resources Conservation Districts, whose mission is to work with landowners and communities to protect natural resources and support the working landscape throughout the state.

We have made several adjustments to the Rural Fire Protection Grant Program, including changing the name from Dry Hydrant Grant Program to Rural Fire Protection Program to better reflect the diverse range of projects we support. We have increased the maximum grant award amount from \$5,000 to \$10,000 per project. New rural fire protection systems, along with repair, replacement, relocation, upgrades of existing systems, and drafting site development, are eligible for grant funding on an ongoing basis. And we now consider applications from Vermont towns and fire departments on a revolving basis throughout the year rather than just once a year.

The annual expense of the Rural Fire Protection Program in FY 2021 was **\$193,930**, of which **\$92,909** was paid in grants to Vermont communities for construction costs. The remaining budget covered site assessments, project design and program oversight. Most of our funding comes from the Vermont Department of Public Safety through annual appropriations by the Vermont Legislature. In addition, the program receives support from the US Forest Service through the Vermont Department of Forests, Parks and Recreation. Unfortunately, these grants do not completely cover the costs of the program. Therefore,


we are respectfully requesting that you include a \$100 appropriation in your town budget to support the Rural Fire Protection Program. Last year, we received over **\$11,000** in town appropriations from over **100** towns, with contributions still coming in. We are deeply grateful for your ongoing support.

215 Vermont communities have benefitted from the Rural Fire Protection program. Our goal is to extend this support to all Vermont towns and continue to assist local fire departments in reducing the risk of injury, loss of life, and damage to property and natural resources, thereby improving the safety and welfare of Vermont communities.

Enclosed please find a summary report for the Rural Water Supply Grant Program, as well as an invoice and W-9 from VACD in case they are required. VACD's tax form 990 is also available upon request. Dear Woodford Select Board,

The VNA & Hospice of the Southwest Region (VNAHSR) respectfully requests town funds in the sum of \$650 to assist in providing much-needed home care and hospice services to all those in need. Attached is our summary of services provided this past year.

We believe in providing medically necessary healthcare wherever it is needed, regardless of the location of residence, or complexity of health issues. Our nurses, therapists, home health aides, and social workers provide medical care, assessments, assistance with activities of daily living, and education to assist people in maintaining their independence. Many of our patients are elderly, disabled, or individuals with a terminal illness who might otherwise not be able to manage their illnesses at home. We also serve mothers experiencing high-risk pregnancies as well as infants and children with special needs.

Eighty-two percent (82%) of the patients we serve have either Medicare or Medicaid that often does not cover the cost of providing their needed care. Town funds and charitable contributions help close the gap between reimbursement for services provided and costs of those services. With adequate town funding, an affordable option for home healthcare is available to all in need.

We also offer many services at no charge, such as bereavement support groups for adults and children, flu clinics, Tree of Hope Memorial service, and community education on end-of-life issues.

VNA & Hospice of the Southwest Region is an essential part of the community healthcare system. Without the services we provide, there would be a significant gap in addressing the what the community needs and the services provided. To continue meeting these needs, we urge you to consider the importance and cost-effectiveness of the work that VNAHSR does to ensure the health and well-being of the community.

We are very grateful to the Town of Woodford for many years of support to help the VNA & Hospice of the Southwest Region meet our mission to serve our community. Please do not hesitate to contact 802-775-0568 if you have any questions.

The Bennington Free Library requests a level funded appropriation in the amount of \$3,700 for the 2022-2023 fiscal year. Woodford's long history of support for the library confirms its commitment to sustain a community of engaged and well-informed citizens.

The library supports Woodford residents throughout their lifetime of learning: through story hours, by supporting students of all ages as they pursue their formal educational goals and later by providing resources for "lifelong learners" who remain intellectually curious throughout their lives. Most recently we have instituted a home delivery service for homebound seniors, possible through a cooperative effort with RSVP.

Despite the governor's mandated quarantine, the library has continued to provide critical resources to Woodford residents, including library takeout, online and phone reference assistance, summer reading activities, programs and handouts, book giveaways at the library and during food distribution events and themed activity bags. Free video and music streaming services and virtual programming has become a normal part of our operations as well as such unconventional offerings as snowshoes which are very popular among families.

Without adequate funding, many in our community would be forced to do without the books, videos, educational resources and computing facilities our library provides; more so during the current pandemic. Demand for services remains steady and Woodford's support is an important factor in our ability to meet the needs of a diverse community.

BENNINGTON FREE LIBRARY

Libraries are the public living rooms of our society. Offering a welcoming and supportive environment, libraries play a critical role in fostering education and literacy in their communities. **The library is not just about books!**

Families new to the area come to the library to meet other families through story time, public programming and to learn more about the community. Seniors use library resources and also come to connect and talk with a friendly staff member. Libraries help community members succeed in their lives and businesses through training and access to technology. Teens meet to study and attend programs geared toward their interests. Our Library is the go-to place for the under or unemployed looking to sharpen skills, research job opportunities, apply for employment and engage in home-based businesses.

The Bennington Free Library, after being open to the public since the summer of 2020, closed last winter after the Thanksgiving holiday in order to avoid becoming a vector for the COVID virus. We remained closed to the public based on area infection rates but implemented a phased reopening in May, increasing public hours over several weeks.

Throughout the pandemic, library staff have incorporated new strategies for serving the Woodford community, including library takeout, online and phone reference, virtual programs and “take-and-make” bags for children and adults while continuing deliveries to day care centers, book giveaways at the library and during food distribution events.

Library takeout allowed patrons to continue borrowing video, reading and unconventional materials such as snowshoes while the library was physically closed for public use. Online and phone reference continued 5 days a week and free 24/7 wi-fi service has been available without interruption. The library board recently voted to eliminate fines permanently in order to ensure that critical library sources continue to be available to those most in need.

We expanded our electronic services to include streaming movies, television shows, music and more through Hoopla to Woodford residents. Expanded outreach through virtual programming, social media and our website continues to provide links to a broad variety of online health, educational and recreational materials, and a new program offering home deliveries to homebound seniors sponsored cooperatively with RSVP began this fall.

It is clear that the Bennington Free Library is a unique institution, supporting the lifelong interests of a diverse community. Our success is due, in part, to the financial support received from the Town of Woodford. Woodford residents have been enthusiastic patrons of the library for many years, and with your support we will continue to provide the relevant and quality resources they deserve. For the last 42 years, The Vermont Center for Independent Living (VCIL) has been teaching people with disabilities and the Deaf how to gain more control over their lives and how to access tools and services to live more independently. VCIL employees (85% of whom have a disability) conduct public education, outreach, individual advocacy and systems change advocacy to help promote the full inclusion of people with disabilities into community life.

In FY'21 (10/2020-9/2021) VCIL responded to thousands of requests from individuals, agencies and community groups for information, referral and assistance and program services for individuals living with a disability. VCIL Peer Advocate Counselors (PACs) provided one-on-one peer counseling to **186** individuals to help increase their independent living skills and **4** peers were served by the AgrAbility program. VCIL's Home Access Program (HAP) assisted **141** households with information on technical assistance and/or alternative funding for modifications; **65** of these received financial assistance to make their bathrooms and/or entrances accessible. Our Sue Williams Freedom Fund (SWFF) provided **74** individuals with information on assistive technology; **42** of these individuals received funding to obtain adaptive equipment. **497** individuals had meals delivered through our Meals on Wheels (MOW) program for individuals with disabilities under the age of 60. We are also home to the Vermont Telecommunications Equipment Distribution Program (VTEDP) which served **35** people and provided **24** peers with adaptive telecommunications enabling low-income Deaf, Deaf-blind, Hard of Hearing and individuals with disabilities to communicate by telephone. Due to the pandemic VCIL was able to start a new (temporary) program, Resilience and Independence in a State of Emergency (RISE) which served 418 people in its first few months. The Rise Program can help provide an array of items or services if the needs are directly related to the Covid-19 epidemic (computers for tele-med appointments, cleaning supplies, etc.).

VCIL's central office is located in downtown Montpelier and we have five branch offices in Bennington, Chittenden, Lamoille, Rutland and Windham Counties. Our PACs and services are available to people with disabilities throughout Vermont.

Center for Restorative Justice

Restorative Justice is a form of community justice; it is a framework by which a community can respond to crime. It holds offenders accountable and places emphasis on repairing the harm done to the victim and community. This is the framework by which the Center for Restorative Justice (CRJ) bases its programs.

In Bennington County, CRJ works in partnership with the courts, State's Attorney's Office, defense attorneys, Department of Children and Families, Department of Corrections, schools and other community partners to deliver programs using restorative justice principles. The Restorative Justice philosophy involves the community in the process of holding offenders accountable for repairing the harm caused and helps him/her gain the skills necessary to become a productive member of our society. Restorative Justice also empowers victims and the community to have an active role in the process.

This past year, CRJ was challenged with delivering quality restorative justice programs and services while confronted with the COVID pandemic. CRJ is proud to have successfully served 1,531 Bennington County residents this past year. CRJ is a unique, one-stop restorative justice agency providing a full range of services from helping at-risk youth get on the right track to assisting individuals coming back to the community from incarceration. In addition to CRJ's traditional programs such as Court Diversion, Youth Substance Abuse Safety Program, Truancy Programs, Pre-Charge Programs, and Reparative Probation, CRJ helps hundreds of people each year get their driver's license reinstated, file petitions to get their records expunged and support victims to have a voice and be compensated with restitution. A unique program run by CRJ which started in 2020 (unique to anywhere else in the state) is Threads – a clothing boutique that provides free clothes and accessories to all Bennington County teens. The simple gift of clothing and contemporary accessories in many cases is all it takes to help a teen feel good about themselves and succeed in school. Some teens have even gained new confidence to go on job interviews with some new "threads"!

CRJ is a non-profit agency, funded by numerous state and private grants, donations and town funding. More information about CRJ programs can be found on CRJ's website- www.bcrj.org. With your town's support, CRJ is able to continue the important work of strengthening communities, empowering victims, supporting individuals in need, and holding people accountable who may have caused harm to others. It is the strength of our partnership that helps to make our community such a great place to live. Thank you very much for your continued partnership and support.

Report to the Citizens of Woodford

This report describes the services that the Southwestern Vermont Council on Aging (SVCOA) provided to elders in Woodford in 2021:

Nutrition Support

SVCOA helped provide 100 nutritious meals to 4 Woodford elders who came together at a community luncheon site in your area while enjoying the company of others.

The Council also remained available to provide home delivered meals, often referred to as "Meals on Wheels," to homebound elders residing in Woodford.

Additionally, SVCOA provided 2 hours of one-on-one nutrition support, including nutrition assessments and resource connections and referrals, to 2 residents of Woodford.

Case Management Assistance:

SVCOA case management and outreach staff helped 3 elders in your community for a total of 29.25 hours. Case managers meet with an elder privately in the elder's home or at another agreed upon location and assess the elder's situation. They will work with the elder to identify needs and talk about possible services available to address those needs. If the elder desires, the case manager will link the client to appropriate services, coordinate and monitor services as necessary, and provide information and assistance to caregivers. Case managers also help elders connect with in-home assistance programs, including a program called Choices for Care. This program is especially helpful to frail elders facing long term care placement who still wish to remain at home.

Other Services and Support:

1) "Senior Helpline" assistance at 1-800-642-5119. Our Senior HelpLine staff provide telephone support to elders and others who need information on available programs and community resources; 2) Medicare and health benefit counseling information and assistance through our State Health Insurance Program; 3) Legal service assistance through the Vermont Senior Citizens Law Project; 4) Information about elder issues and opportunities via various agency articles and publications 5) Nutrition education and counseling services provided by SVCOA's Registered Dietician; 6) Senior Companion support for frail, homebound elders; 7) Outreach services to elders dealing with mental health issues through our Elder Care Clinician. This service is provided in cooperation with Rutland Mental Health; 8) Transportation assistance; 9) Caregiver support, information and respite to family members and others who are providing much needed help to elders in need of assistance; 10) Money Management programs that offer either a volunteer bill payer or representative payee services to elders and younger disabled individuals.
