(a) A comprehensive major medical insurance policy issued by a health insurance company, nonprofit hospital or medical service corporation, or health maintenance organization that insures employees, members, or subscribers for hospital and medical insurance on an expense-incurred, service, or prepaid basis shall:

(1) provide notice to the policyholder or other responsible party of any premium payment due on a policy at least 21 days before the due date; and

(2) provide a grace period of at least one month for the payment of each premium falling due after the first premium, during which grace period the policy shall continue in force and the issuer of the policy shall be liable for valid claims for covered losses incurred prior to the end of the grace period.

(b) If the issuer of a policy described in subsection (a) of this section does not receive payment by the due date, the issuer shall send a termination notice to the policyholder at least 21 days prior to termination notifying the policyholder that the issuer may terminate the policy if payment is not received by the termination date.

(3) it maintains its principal place of business in this State; and

(4) it appoints a registered agent to accept service of process and to otherwise act on its behalf in this State; provided that whenever such registered agent cannot with reasonable diligence be found at the registered office of the captive insurance company, the ~~Secretary of State~~ Commissioner shall be an agent of such captive insurance company upon whom any process, notice, or demand may be served.

2 is available under a covered individual’s dental insurance plan or health
3 insurance plan or for which reimbursement would be available but for the
4 application of contractual limitations such as deductibles, co-payments,
5 coinsurance, waiting periods, annual or lifetime maximums, frequency
6 limitations, alternative benefit payments, or other limitations.

7 (3) “Dental insurance plan” means a stand-alone dental plan or policy
8 that provides coverage for dental services separately from a health insurance
9 plan.

10 (4) “Dental insurer” means any health or dental insurance company,
11 including a nonprofit dental service corporation, that offers a dental insurance

21 numbers associated with payment for health care services delivered by a health

1 care provider and chargeable for a predetermined dollar amount and in which
2 the health care provider is responsible for processing the payment using a
3 credit card terminal or Internet portal. The term includes virtual or online
4 credit card payments in which no physical credit card is presented to the health
5 care provider and the single-use credit card number expires upon payment
6 processing.

7 (2) “Health care provider” has the same meaning as in section 9402 of
8 this title.

9 (3) “Health insurer” means an insurance company that provides health
10 insurance as defined in 8 V.S.A. § 3301(a)(2), a nonprofit hospital or medical
11 service corporation, a managed care organization, a health maintenance
12 organization, and, to the extent permitted under federal law, any administrator
13 of an insured, self-insured, or publicly funded health care benefit plan offered
14 by a public or private entity, as well as any entity offering a policy for specific
15 disease, accident, injury, hospital indemnity, dental care, disability income,
16 long-term care, or other limited benefit coverage.

17 (b) A health insurer or its contracted vendor shall not require a health care
18 provider, including a dentist or ambulance service provider, to accept
19 reimbursement by credit card payment unless the health care provider has
20 affirmatively elected to receive payments in this manner. If a health care
21 provider, including a dentist or ambulance service provider, does not

1 affirmatively elect to receive reimbursement by credit card payment, the health

12 issued on and after January 1, 2022 on such date as a dental insurer offers,
13 issues, or renews the plan, but in no event later than January 1, 2023.
