Talking Points

- Vermont is a place to do business...not just ski, sail and savor our great food and beer
- You are here in Montreal to build on existing relationships
 - Strong relationship with Premier Couillard
 - Shared commitment to environmental excellence and economic development
 - Vermont has a longstanding cooperation agreement with Quebec – collaboration on economic development, energy, transportation, the environment
 - Strong energy partnership – Hydro Quebec and Gaz Metro (the Premier and Consul General Fite attended the Power from the North Conference last March in Vermont)
 - Transportation – improvements to A-35 have helped with commerce and tourism
 - Port of Montreal is a great asset to Vermont companies
 - The Premier's visit began discussions about economic development and the VQEI efforts
- We are working hard to growing new partnerships
 - VQEI – private sector participation will help make this a success
- VQEI work will enhance B2B opportunities, economic development relationships and create new promotion opportunities.
 - We have already hosted dozens of companies in Vermont thanks to the launch of this program and there are more events being planned to encourage new investment in our great state – one before the end of the year
 - New relationships with site consultants have been initiated

- The VQEI was a sponsor of Deringer's annual Port of Montreal Tour
- Quebec has been a great neighbor for commerce – we share some great companies that are located across Vermont: Revision, VELAN and Appalachian Flooring - and the door is open to host more.
 - Appalachian Flooring selected North Troy, Vermont as their US location. This Cowansville-based company makes engineered hardwood flooring products. They selected North Troy due to its proximity to the Canadian border and for the fantastic workforce.
 - You will hear more about Revision from Greg in a few minutes, but this company located in Vermont about eleven years ago and has expanded in Vermont several times. Revision now has two locations in our state.
 - Kaytec, with operations in Quebec and Richford, Vermont, is another great example of a cross-border company. They manufacture building products – including vinyl siding and window shutters. They have called Vermont home for decades.
- There are a host of incentives to encourage investment in our state; the panel will get into greater detail on that.
 - We don't play checkbook economic development; we have nationally recognized programs that are fiscally responsible.
 - Our commitment to workforce development includes our colleges and universities – all of whom understand the need to offer programs that help grow our already-strong workforce. They can customize training classes to fit employers' needs.

- We aren't striving to compete with Plattsburgh b/c what we have to offer is very different.
